**Charges:** Utter threats BH, Mischief under \$5000, FTC undertaking x 3,  
Fear of personal injury

**Released:**

Bail hearing on July 8<sup>th</sup>

Released on a Form 11

Promise to pay \$500 if FTC with the release order

Do not contact/communicate in any way direct/indirect with named party

Do not be within 50m of any place the named party lives or works

Next court date is July 23<sup>rd</sup>



**Charges:** FTC undertaking, Breach recognizance x 2

**Released:**

Bail hearing on July 8<sup>th</sup>

Released on a Form 11

Promise to pay \$500 if FTC with the release order

Reside with surety

No contact/communication in any way with named party

Do not be within 100m of any place the named party lives or works

Do not attend within 50m of named party

Do not possess any weapons

Next court date is July 30<sup>th</sup>



**Charges:** Identity theft x 2, Theft under \$5000 x 2, Forged document,  
Obstruct police, Possess property under \$5000 x 2

**Released:**

Bail hearing on July 7<sup>th</sup>

Released on a Form 11

Promise to pay \$200 if FTC with the release order

Next court date is July 16<sup>th</sup>

Released on a Form 11

Promise to pay \$500 if FTC with the release order

Reside at named address

Do not contact/communicate in any way direct/indirect with named parties

Do not be within 100m of any place the named parties live, work, go to school

Do not be within 25m of named party

Do not engage in any activity that involves persons under the age of 16 years

Next court date is July 16<sup>th</sup>



**Charges:** Break out of place after entering, FTC Probation

**Released:**

Bail hearing on July 12<sup>th</sup>

Released on previous Undertaking

Do not attend at named address

Next court date is August 13<sup>th</sup>

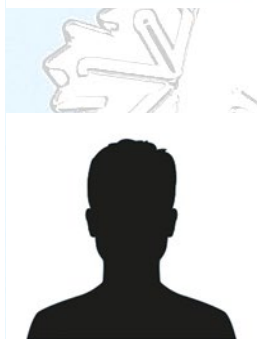

**Disposition:**

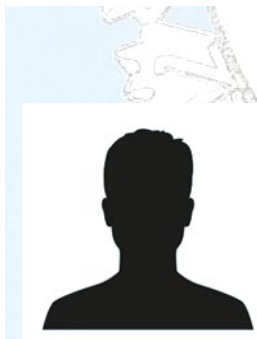
Court appearance on July 9<sup>th</sup>

No reasonable prospect of conviction – NRPC



**Charge:** Theft under \$5000

**Disposition:**

Court appearance on July 9<sup>th</sup>  
Guilty plea to theft under \$5000  
Suspended sentence  
20 hours of community service  
12 months probation



**Charges:** Possession of property obtained by crime under \$5000,  
Fraud under \$5000

**Disposition:**

Charges withdrawn on July 9<sup>th</sup>

**Charges:** Theft over \$5000 of a m/v, Theft under \$5000 x 2,  
Possession property obtained by crime under \$5000 x 2,  
Drive while under suspension

**Disposition:**

Court appearance on July 9<sup>th</sup>  
Guilty plea to lesser offence of take m/v without consent  
2 years' Probation, usual conditions  
No contact or communication with named party  
Perform 100 hours of community service  
Do not have care or control or occupy the driver's seat of any motor vehicle



**Charges:** B&E, Harassing communication

**Disposition:**

Court appearance on July 9<sup>th</sup>  
Entered into a 12 months' Common Law Peace Bond  
No contact/communication, direct/indirect with named party  
Do not attend any place the named party resides, works, attends school or frequents  
Do not possess any weapons  
Charges withdrawn as part of the resolution



**Charges:** Theft under \$5000 x 2, FTC release order x 3, Obstruct police  
Assault, Assault with a weapon

**Disposition:**

Court appearance on July 9<sup>th</sup>  
Guilty pleas to the following; Assault, Theft under, FTC  
Sentence to 60 days less PSC (40 days of PSC)  
8months' Probation  
Do not attend within 25m of the named party  
No contact or communication with named party  
No weapons  
Remaining charges were withdrawn as part of the resolution
