




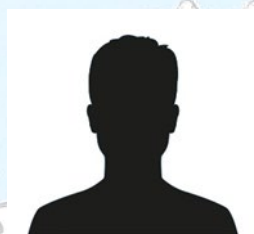

- \$1000 fine
- Criminal charge was withdrawn



Charges: Fraud under \$5000 x 4, Theft under \$5000,
Possess property obtained by crime under \$5000 x 3

Disposition:

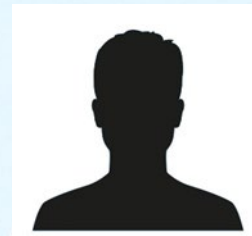
- Court appearance on June 25th
- Guilty plea to theft under \$5000
- Conditional Discharge
- 18 months' Probation
- Do not attend named address
- 80 hours community service
- Restitution payable to named party



Charge: Assault - Spousal

Disposition:

- Court appearance on June 25th
- Charge withdrawn



Charge: Assault

Disposition:

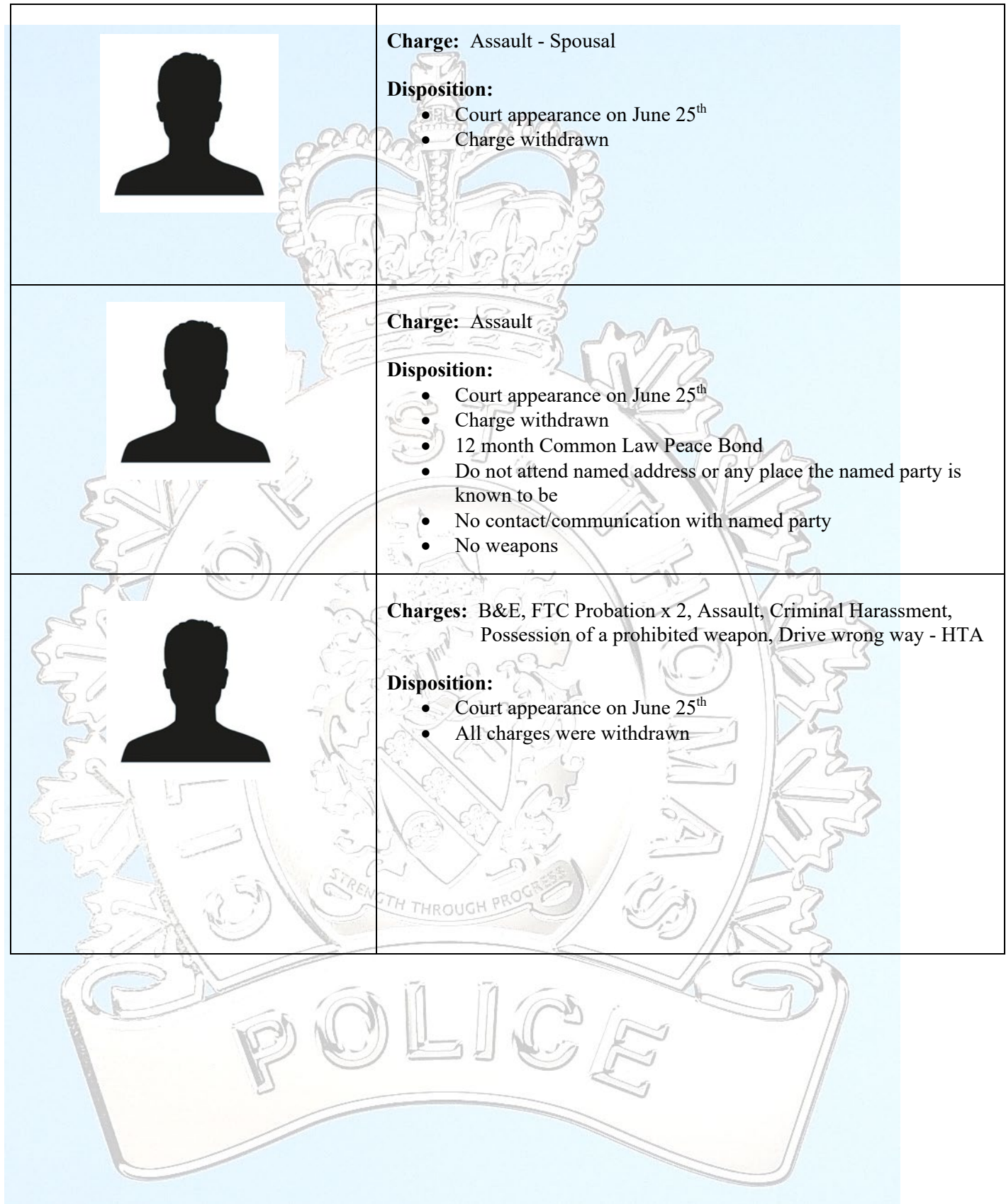
- Court appearance on June 25th
- Charge withdrawn
- 12 month Common Law Peace Bond
- Do not attend named address or any place the named party is known to be
- No contact/communication with named party
- No weapons



Charges: B&E, FTC Probation x 2, Assault, Criminal Harassment, Possession of a prohibited weapon, Drive wrong way - HTA

Disposition:

- Court appearance on June 25th
- All charges were withdrawn





Charges: Impaired operation, Over 80 BAC, Having care & control of a m/v with cannabis & alcohol readily available - LLCA

Disposition:

- Court appearance on June 25th
- Guilty plea to Over 80 BAC
- \$2000 fine
- 12 months' driving prohibition
- Remaining charges were withdrawn as part of the resolution



Charges: FTC Probation x 3, Assault with a weapon, Administer noxious thing, Possess firearm/ammo, Possess weapon for a dangerous purpose, Unauthorized possession of a weapon

Disposition:

- Court appearance on June 26th
- Charges withdrawn by the Crown
- NRPC



Charges: Possession of a controlled substance for trafficking - Cocaine

Disposition:

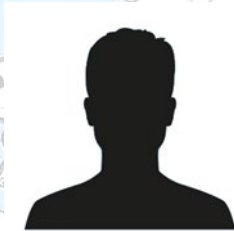
- Court appearance on June 26th
- Guilty plea
- 18 months' Condition sentence order
- \$5000 fine
- Reside at named address
- Do not possess any weapons
- DNA



Charges: Assault – Spousal, Mischief – Spousal x 2

Disposition:

- Court appearance on June 25th
- Guilty pleas to all charges
- Suspended sentence
- 18 months' Probation
- No communication/contact with named parties
- Non-attendance within 100m of any known place of residence, employment or education named parties
- Complete Changing Ways programming
- Do not possess any weapons
- 50 hours of community service
- 10 years s. 110 Order DNA ordered



Charges: Assault – Spousal, Mischief – Spousal, FTC Probation x 2

Disposition:

- Court appearance on June 26th
- Guilty pleas to the following; Assault, FTC Probation
- 25 days PSC enhanced to 37 days; 1 day deemed served
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not be within any place the named parties live, work or go to school
- Do not attend named address
- Do not possess any weapons
- Remaining charges were withdrawn as per the resolution



Charges: Possess property obtained by crime under \$5000, Obtain by false pretence, FTC with sentence x 3, Assault police, Possess property obtained by crime over \$5000, FTC

Disposition:

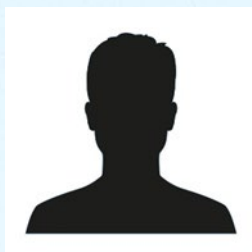
- Court appearance on June 27th
- Guilty pleas to the following; Obtain by false pretence, FTC with sentence, Assault police, FTC release order, Possess property obtained by crime over \$5000
- Sentenced to 60 days
- 6 months' Probation
- Reside with named party
- Curfew set by Probation
- No contact/communication as per Probation
- Do not purchase, possess or use intoxicants without a lawful prescription
- Do not possess any weapons



Charge: Impaired operation – Blood drug concentration

Disposition:

- Court appearance on June 27th
- Charge withdrawn by the Crown
- NRPC



Charges: **OPP** – Harassing phone calls, Utter threat BH, FTC x 2
STPS - Criminal harassment x 2, Utter death threats x 3,
Harassing phone calls x 2, Utter threat to property

Disposition:

- Court appearance on June 27th
- Guilty pleas to the following offences; Utter death threats x 2, Utter threat to property, FTC release
- Sentenced to 1 day deemed served – 31 days of PSC enhanced to 60 days
- 36 months' Probation Report – for the first 18 months of the order unless counselling has not been completed
- No contact with named parties
- Non-attendance within 100m of the named parties
- Not to be within 25m of the named parties
- No weapons
- DNA – Secondary on all charges s. 110 – 10 years
- Remaining charges were withdrawn as per resolution



Charges: Mischief – Domestic, Unlawfully in a dwelling

Disposition:

- Court appearance on June 27th
- Charges withdrawn buy the Crown



Charges: Assault – Spousal x 2

Disposition:

- Court appearance on June 28th
- Entered into a s. 810 Peace bond for 12 months
- Complete the Changing Ways program within 8 months
- No contact/communication, direct/indirect with named party
- Do not attend within 100m of any known place of residence, employment or education of named party
- Do not possess any weapons
