Form 11 Releases:



Charges: Assault – Spousal, Assault - Strangle

Disposition:

- Bail hearing on August 6th
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Reside at named address
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not attend within 100m of any place they live, work, attend school, frequent or they are known to be
- Do not attend within 100m of named address
- Do not attend within 25m of the named parties
- Do not possess any weapons
- Next court date is August 27th



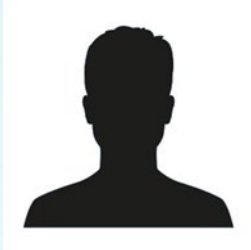
Charge: Theft under \$5000

Released:

- Bail hearing on August 7th
 - Released on a Form 11
 - Promise to pay \$500 if FTC with the release order
- Do not attend named address
Next court date is August 14th



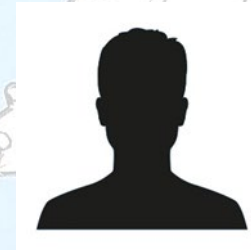

Charges: Sexual interference x 2, Sexual assault x 2

Released:

- Bail hearing on August 7th
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Reside at named address
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not attend any public park or public swimming pool, daycare centre, school ground or community centre with **exceptions**
- Do not engage in any activity that involves contact with persons under the age of 16 years
- Do not possess any weapons
- Next court date is September 3rd



Charges: Unauthorized possession of a weapon, Obstruct police, FTC undertaking, FTC release order

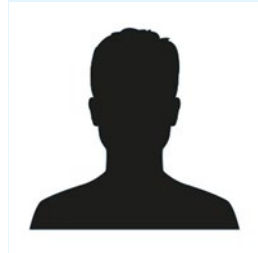
Released:

- Bail hearing on August 9th
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend the City of St. Thomas **except** for court
- Do not possess any weapons
- Next court date is August 27th

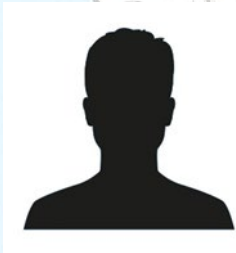
Dispositions:



Charges: Aggravated assault, Assault with a weapon, FTC release order

Disposition:

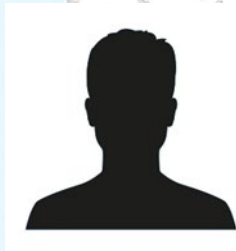
- Court appearance on August 6th
- Entered into a 24 months' Common Law Peace Bond
- No contact with named party
- Do not attend within 50m of named party
- Do not carry any knives while outside of residence
- Do not carry any weapons as defined by the Criminal Code
- Charges withdrawn as per the resolution



Charge: Theft under \$5000

Disposition:

- Court appearance on August 9th
- Direct Accountability Program – DAP completed
- Charge withdrawn



Charges: Theft under \$5000, Possession of fentanyl

Disposition:

- Court appearance on August 6th
- Guilty plea to theft under \$5000
- Suspended sentence
- 15 months' Probation
- No contact/communication with named party
- Do not attend at any known place of residence, education or employment of named party
- Restitution (\$200) to named party
- Fentanyl charge withdrawn as part of the resolution

Charges: Theft under \$5000, B&E, Possess crystal meth

Disposition:

- Court appearance on August 7th
- Entered into a 12 months' CLPB
- No contact/communication in any way with named party
Do not attend any known place of residence or employment,
Charges withdrawn as part of the resolution



Charges: Assault with a weapon, Assault, FTC

Disposition:

- Court appearance on August 7th
- Guilty plea with Assault with a weapon
- Elgin Therapeutic Court completed
- Conditional discharge
- 18 months' Probation
- No contact/communication with named parties
- Do not attend at any known place of residence, education or employment of the named parties
- Complete 50 hours of community service
- Do not possess any weapons
- DNA
- s. 110 weapons prohibition for 5 years
- Remaining charges were withdrawn as part of the resolution

Charge: Sexual assault

Disposition:

- Court appearance on August 7th
- Guilty plea
- Suspended sentence
- 2 years' Probation
- No contact/communication in any way with named party
- Do not attend any known place of residence, education or employment of named party
- Do not be within 25m of the person of named party
- Complete 100 hours of community service in the first 12 months
- DNA
