Do not contact/communicate in any way direct/indirect with named parties
Do not be within 50m of any place the named parties are known to be
Do not posses any weapons
Remain in custody until GPS monitoring device is available
Next court date is September 4th



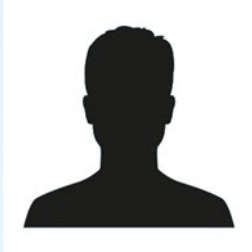
Charges: Breach 810 Recognizance

Promise to pay \$1000 if FTC with the release order
Reside at named address
Do not contact/communicate in any way direct/indirect by any means
with named party
Do not attend named location
Do not possess any weapons
Next court date is September 10th

\$1500 fine and 12 month driving prohibition



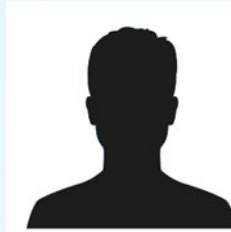

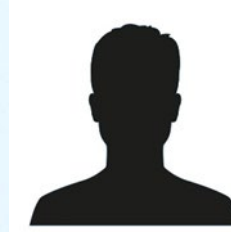

Disposition:

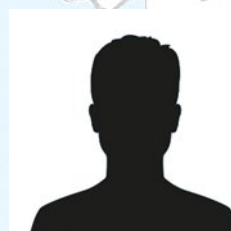
Court appearance Aug 21st

40 hours of Community Service



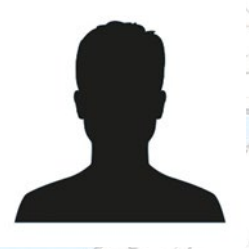

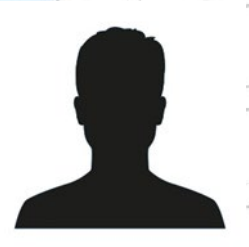

Disposition:

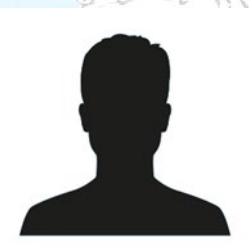
4-month conditional sentence

Final month curfew 9pm-7am.
Followed by 12 months Probation
Do not go to named locations
Non comm./association with named party



Charges: Breach Probation x3, Possess property over, possess property obtained by crime, Drive- licence wrong class

Disposition:

Court appearance Aug 20th
Guilty pleas to possess property obtained by crime and Br. Probation
4 days of pre custody enhanced to 7 days, one day deemed served



Charges: Impaired operation, careless driving & drive with open container

Court appearance Aug. 20th
Impaired charge withdrawn
POA matters transferred to POA court on Sept 11th
