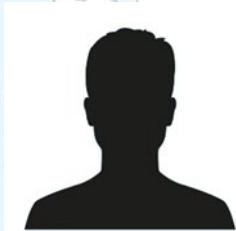
**Form 11 Releases:**



**Charges:** Assault x 3, Assault – choke, FTC undertaking x 3

**Released:**

- Bail hearing on September 16<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Reside with surety
- Do not contact/communicate by any means with named parties
- Do not be within 100m of any place the named parties live, work or attend school
- Do not attend the City of St. Thomas **except for court**
- Do not be within 25m of named party
- Do not possess any weapons
- Next court date is September 26<sup>th</sup>



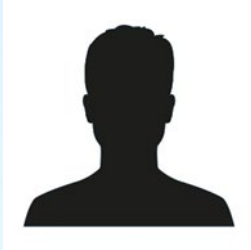
**Charge:** Operate conveyance while prohibited

**Released:**

- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Next court date is September 26<sup>th</sup>



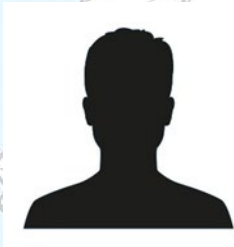

- Do not be within 100m of any place the named party lives, works or goes to school
- Do not possess any weapons
- Next court date is October 8<sup>th</sup>



**Charges:** Mischief under, Theft under, Breach Probation,  
Possession property obtained by crime under \$5000 x 2

**Released:**

- Bail hearing on September 17<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Report to the John Howard Society as directed
- Do not possess any ID, banking issued card/document unless it has been issued in their name
- Next court date is September 24<sup>th</sup>



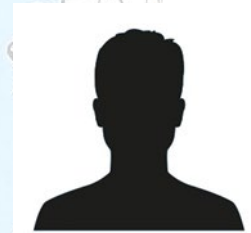

**Released:**

- Bail hearing on September 17<sup>th</sup>
- Released on a Form 11
- Promise to pay \$2000 if FTC with the release order
- Reside at named address
- Wear a GPS monitor and comply with the rules/protocols
- Do not contact/communicate in any way with named parties
- Do not possess any weapons
- Do not possess any controlled substances as per the CDSA
- Next court date is December 2<sup>nd</sup>



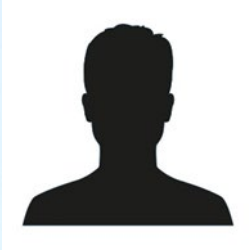
**Charges:** Breach Probation, Arson

- Next court date is September 27<sup>th</sup>



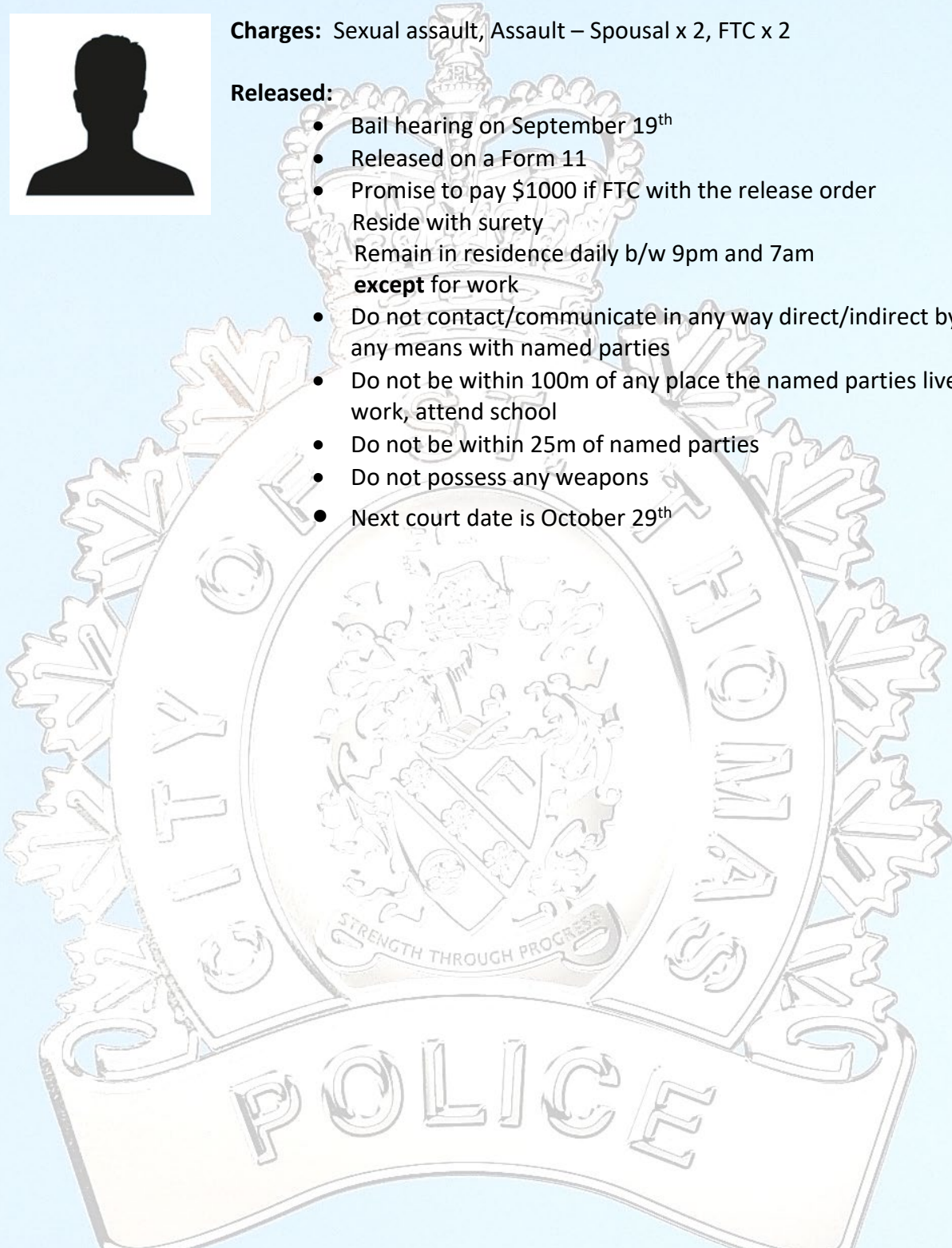

**Released:**

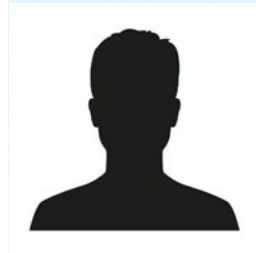
- Bail hearing on September 19<sup>th</sup>

- Promise to pay \$1000 if FTC with the release order  
Reside with surety  
Remain in residence daily b/w 9pm and 7am  
**except** for work
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not be within 100m of any place the named parties live, work, attend school
- Do not be within 25m of named parties
- Do not possess any weapons
- Next court date is October 29<sup>th</sup>

**OPP -** FTC Probation x 3, Drive disqualified x 6, Use of credit card obtained by crime x 2, Theft over x 6, Theft under, Theft of credit card, B&E x 2, Possess property obtained by crime over \$5000 x 5, Possess property obtained by crime under x 2, Mischief under \$5000, Impaired driving, Fail/refuse sample, Fail to stop after collision, Possess B&E tools, Flight from police, Robbery, Possess sched I

**Disposition:**

- Court appearance on September 16<sup>th</sup>
- Global resolution
- Has been in custody since July 7, 2023
- Guilty pleas; Use credit card obtained by crime, Drive disqualified x 3, Possess property obtained by crime over \$5000, Fail to stop after collision, Fail/refuse sample, B&E
- Time served on those pleas, 1 year sentence
- 2 years' Probation
- 3 years driving' Prohibition

**Charge:** Indecent act

**Disposition:**

- Court appearance on September 17<sup>th</sup>
- Guilty plea
- Conditional discharge
- Reside at named address
- 12 months' Probation
- No contact with named party
- Do not attend named address
- 30 hours of community service
- Do not be outside of house unless fully clothed
