Do not attend within 100m of named parties home, work, school

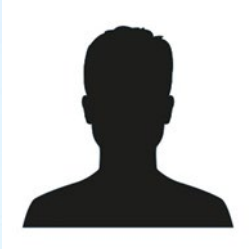
Don't be within 50m of named party

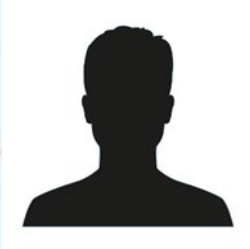


Charges: Utter threat – Cause death, Sexual Interference, Sexual Assault
Sexual assault

Disposition:

Bail hearing on September 6th
Released on a Form 11, Bail set, not met until GPS monitor is installed
Promise to pay \$2,500 if FTC with the release order
Reside at named address
Do not contact/communicate in any way direct/indirect by any means with named parties
Do not be within 100m of any place the named parties live, work or attend school
Do not attend named address
Do not be in the company of or communicate directly by any physical, electronic means with any person under the age of 16
Do not attend a public park or public swimming area where persons under 16 years are present; daycare, school ground, playground, community centre
Do not possess a cellphone, pager etc. **except** with surety
Do not possess/ use computers or any other device that has access to the internet
Next court date is October 1st

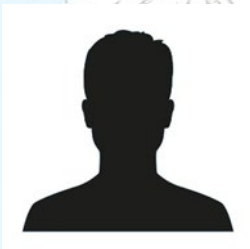

Disposition:

Court appearance on September 3rd
Guilty plea to Over 80 BAC
\$2000 fine
1 year driving prohibition
Remaining POA charge was withdrawn as per the resolution



Charges: FTC Youth sentence x 3

Disposition:

Court appearance on September 3rd
Guilty plea to FTC
Sentenced to 45 days PSC; time served
Remains on Probation with numerous conditions

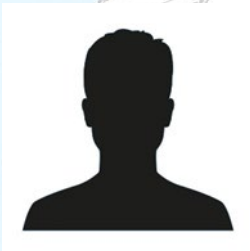

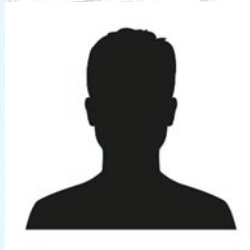

Has outstanding charges before the court



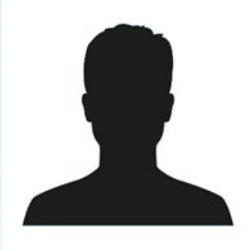

Disposition:

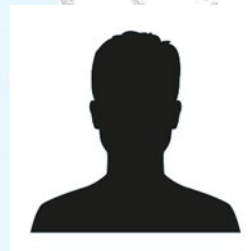

Charges: Sexual assault, Utter death threat, FTC

Disposition:

Court appearance on September 3rd
Guilty pleas to Utter death threat, FTC
60-day conditional sentence
House arrest with electronic monitoring **exceptions**
No contact with named parties
Non-attendance within 100m of any known place of residence, employment
or education of named parties
Non-attendance within 25m of named parties
No weapons, DNA, & s. 110 order
Has numerous outstanding charges before the court



Charge: Assault – Spousal

Disposition:

Court appearance on September 3rd
Guilty plea
Conditional discharge
24 months' Probation
No contact with named party
Non-attendance within 100m of any known place of residence,
employment or education of named party
No weapons; Section 110 - 5 years; DNA order
Has a remaining FTC charge before the court



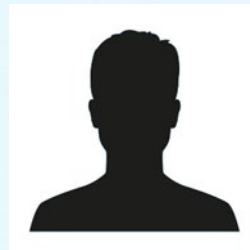

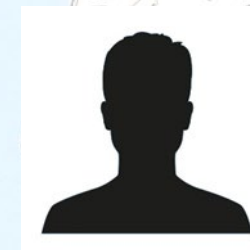

Charges: Assault, Mischief over \$5000, Possession

Disposition:

Guilty plea to Mischief over \$5000
YCJA - Conditional discharge
12 months Report to youth worker
Do not to attend named address
No contact with named party
No weapons
20 hours of community service
Remaining charges were withdrawn as per the resolution



Charge: Arson

Guilty plea to lesser offence of Mischief
Conditional discharge
24 months' Probation
Do not attend within 25m of named address
DNA, s. 110 order

Charges withdrawn as per the resolution



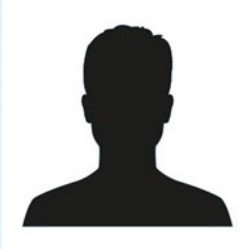
Charges: Arrange to commit a sexual offence against a person under 18 years and 16 years, Invitation to sexual touching under 16 years, Make for purpose of publication any child pornography Possess child pornography, Imports/sells/ or possess of the purpose of distribution of sale of child pornography, FTC x 3

Disposition:

Court appearance on September 5th
Guilty pleas to; Invitation to sexual touching, arrange to commit a sex offence against person under 16, Make child pornography
Sentenced to 3 years penitentiary
s. 110 weapons prohibition order
s. 161 order for 20 years; schools, parks, employment, communicating via computer
s. 743.21 Non-Communication Order with named parties
SOIRA s. 490.012 order (20 years)
Remaining charges were withdrawn as part of the resolution



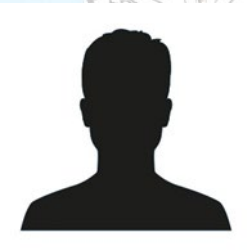

Disposition:

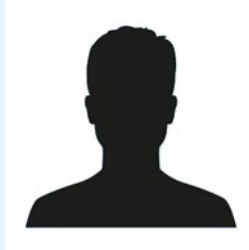
Court appearance on September 5th
Guilty pleas to the following; Assault x 2, & Mischief
Time served; 45 days enhanced to 68 days + restitution
2 years' Probation
S. 110 for 5 years
No contact with named parties
Do not attend within 50m of any place the named parties live
work or go to school
Do not attend named location
Do not attend within 100 meters of named address
No weapons & DNA
Has outstanding POA matters before the court



Charges: Impaired operation, Over 80 BAC

Disposition:

Court appearance on September 6th
Guilty plea to lesser offence of Careless driving
\$1,000 fine
12 months' Provincial Offences Act Probation
During the entire probation period will have a blood alcohol
concentration of zero while driving
Criminal code charges were withdrawn



Charge: Breach Probation

Court appearance on September 6th
Charge withdrawn by the Crown
