- Promise to pay \$1500 if FTC with the release order
- Do not contact/communicate in any way, by any means with named party
- Do not be within 50m of any place the named party lives, works, attends school
- Do not post any images of, or text in relation to all named parties on any social media site
- Do not possess any weapons
- Next court date is October 1st

Charges: Assault x 2, Mischief, Breach Probation 3, FTC x 2
Assault – Choke

Released:

- Bail hearing on September 9th
- Released on a Form 11

- Reside with sureties
- Report to the John Howard Society as directed
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not be within 100m of any place the named parties live, work, attend school
- Do not possess any weapons
- Next court date is October 1st



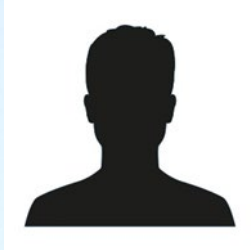
Charge: Breach Probation

- Report to the John Howard Society as directed
- Next court date is September 24th



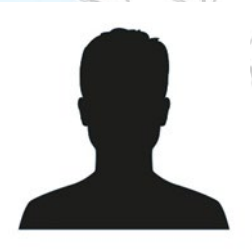

Released:

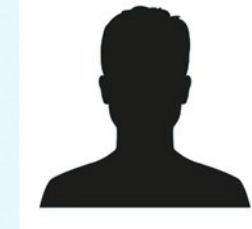
- Bail hearing on September 10th
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not be within 100m of any place the named party lives, works or attends school
- Do not be within 50m of the named party
- Do not possess any weapons
- Do not occupy the driver's seat of a m/v
- Next court date is October 1st



Charges: Operate conveyance while prohibited, Breach Probation, FTC undertaking

Released:

- Bail hearing on September 10th
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Do not occupy the driver's seat of a m/v
- Next court date is September 24th



Charge: Refusal/fail to comply demand

Charges: FTC undertaking x 2

Disposition:

- Court appearance on September 10th
- Charges withdrawn by the Crown
- Not in the Public's Interest – NPI



Charges: Obstruct police, Resist, Assault – Spousal, Assault

Disposition:

- Court appearance on September 10th
- Guilty plea to obstruct and assault - spousal
- 6 months custody (has 119 days of PSC)
- 36 months' Probation
- Non-attendance within 25m, no contact, non-attendance within 250m of any known place of residence, employment, or education of named party
- No weapons, s. 110 – 10 years, & DNA

Charges: Unauthorized possession of a weapon, Breach POA x 2

Disposition:

- Court appearance on September 10th
- Direct Accountability Program – DAP completed
- Charges withdrawn

- DAP completed
- Charge withdrawn



Charges: Failure/Refusal to provide sample

Disposition:

- Court appearance on September 10th
- Charge withdrawn by the Crown
- No reasonable prospect of conviction – NRPC



Charge: FTC release order

Disposition:

- Court appearance on September 10th
- Charge withdrawn by the Crown
- Has two outstanding breaches before the court

Charges: Careless storage of a firearm, Knowledge of unauthorized possession of a firearm x 2, Occupant of a m/v knowing there was a prohibited/restricted weapon, Possession of schedule I substance x 6, Unauthorized possession of a weapon, Possession of a firearm while prohibited, Operation while prohibited, **HTA** - Drive while under suspension, Drive wrong way, Fail to surrender permit for m/v
CAIA – Fail to surrender insurance card

Disposition:

- Court appearance on September 10th
- Plead guilty to Disqualified driving
- \$800 fine
- 12 months' Probation
- Do not associate with named parties
- Do not possess any weapons
- All remaining charges were withdrawn by the Crown



Charges: Theft under \$5000 x 2, Obstruct x 2, Unauthorized possession of a weapon, Possession property obtained by crime under \$5000 x 3

Disposition:

- Court appearance on September 10th
- Guilty pleas to; Theft under \$5000, Unauthorized possession of a weapon, Possess property obtained by crime under \$5000 x 2, Obstruct police
- Suspended Sentence
- 18 months' Probation
- Non-association with named party
- Do not attend named locations
- Perform 50 hours of community service
- Remaining charges were withdrawn as part of the resolution

Disposition:

- Court appearance on September 10th
- Guilty pleas to the following; Assault, & FTC
- Conditional Discharge
- 12 months' Probation
- No contact with named party
- Non-attendance within 100m of any known place of residence, employment or education of named party
- Not to possess any weapons
- DNA



Charges: Assault BH, Assault with a weapon

Disposition:

- Court appearance on September 10th for trial verdict
- Found guilty of assault with a weapon
- Conditional Discharge
- 24 months' Probation
- No contact/communication with named party
- Non-attendance within 100m of any known place of residence, employment or education of named party
- No weapons and DNA order

Charges: Obstruct police, Assault – Spousal, Mischief, FTC

Disposition:

- Court appearance on September 10th
- Guilty pleas to Mischief under \$5000 and FTC
- Conditional discharge
- 12 months' Probation
- No contact with named party
- Non-attendance at any known place of residence, employment or education of named party
- No weapons
- Remaining charges were withdrawn



Charges: Assault x 4, Forcible confinement, Harassing calls, FTC

Disposition:

- Court appearance on September 10th
- Guilty pleas to; Assault x 2, Forcible confinement, Harassing phone calls, FTC
- 120 Conditional sentence
- House arrest with GPS monitoring;
- No contact with named party; do not attend any place where named party lives, works or goes to school
- Do not possess any weapons
- Do not possess/consume any alcohol or drugs unless prescribed
- Followed by 24 months' Probation
- S. 110 order & DNA order

Charges: Theft under \$5000 x 2, FTC Probation

Disposition:

- Court appearance on September 10th
- Guilty pleas to all charges
- Suspended sentence
- 12 months' Probation
- Do not attend named locations
- Perform 50 hours of community service



Charges: Breach Probation x 9

Disposition:

- Court appearance on September 10th
- Breach Probation x 6 withdrawn by the Crown
- No reasonable Prospect of Conviction – NRPC
- Has Breach Probation x 3 charges before the court
