Do not attend within 25m of named address
Do not possess any weapons or B&E instruments
Next court date is September 16<sup>th</sup>

Promise to pay \$2,500 if FTC with the release order Reside at named address

Wear a GPS monitoring device

Do not communicate in any way direct/indirect by any means w/named parties Do not be within 100m of any place the names parties are known to be Do not attend named address

Do not be in the company of or communicate directly by any physical, electronic means w/ anyone under the age of 16 years

Do not attend a public park or public swimming area where persons under 16 years are present – daycare, school ground, playground, community centre Do not possess a cellphone, pager etc. **except** with surety

Do not possess/use any computer/any device that has access to the internet Next court date is September 17<sup>th</sup>

Sentenced to 3 years penitentiary;
