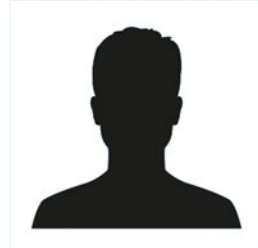

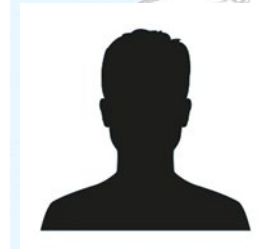
Form 11 Releases:



Charges: Theft under \$5000 x 2, Robbery, Possess property under \$5000

Released:

- Bail hearing on October 12th
- Released on a Form 11
- Promise to pay \$250 if FTC with the release order
- Do not contact/communicate - direct/indirect with named party
- Do not be within 25m of any place the named party lives, works or attends school
- No weapons
- Next court date is November 5th



Charges: Resist police, FTC, Possess property under \$5000

Released:

- Bail hearing on October 13th
- Released on a Form 11
- Promise to pay \$250 if FTC with the release order
- Report to the John Howard Society as directed
- Next court date is November 5th



Charges: Disobey court order, Assault

Released:

- Bail hearing on October 14th
- Released on a Form 11
- Promise to pay \$250 if FTC with the release order
- Do not contact/communicate - direct/indirect with named party
- Do not be within 25m of any place the named party lives, works or attends school
- Do not attend within 25m of named party
- Do not possess any weapons
- Next court date is November 5th

Charges: STPS – Assault with a weapon, Assault – Choking

- Promise to pay \$500 if FTC with the release order
- Report to the John Howard Society as directed
- Do not contact/communicate - direct/indirect with named party
- Do not with within 25m of where the named party lives, works or attends school
- Do not possess any weapons
- Next court date is November 12th

- Do not contact/communicate in any way with named party
- Do not attend any place the named party lives, works or goes to school
- Do not possess any ID, card with a data strip/security chip, cheque, bank document unless it has been lawfully issued
- Next court date is November 19th

Charges: FTC Probation x 6, Take m/v without consent
Drive disqualified x 2, FTC undertaking x 2
Suspend drive - HTA

Disposition:

- Court appearance on October 15th
- Guilty pleas to; Drive disqualified, Take m/v without consent, FTC Probation
- Suspended sentence
- 12 months' Probation
- No contact/association, directly/indirectly with named party
- Not attend within 10 m of any known place of residence, employment or education of named party

- 12 months' Probation
- Do not have any contact/communication directly or indirectly with named party
- Do not be within 50m of any place the named party is known to reside, go to school or work
- Do not be in a position of trust or authority with children under the age of 18
- s. 161 order for 20 years (schools, parks, employment, communicating via computer, etc.)

OPP - Assault, Harassing phone calls, Mischief under

Disposition:

- Court appearance on October 15th
- Guilty pleas to; Assault, Harassing phone calls, FTC x 2
- Suspended sentence + Probation on the OPP charges
- 3 days jail; 18 months' Probation on the STPS charges
- No contact/communication with named parties
- Do not attend within 100m of any place the named parties live work or go to school or are known to be
- No weapons & DNA



Charges: Assault, Unlawfully in a dwelling x 2, FTC undertaking x 5,
B&E, Mischief under, FTC release order, Possess fentanyl

Disposition:

- Court appearance on October 15th
- Guilty pleas to; Unlawfully in a dwelling x 2, B&E, FTC & Possession of Fentanyl
- Time served; 28 real days enhanced to 45 days
- 18 months' Probation
- No contact/communication with named parties
- Do not be within 10m of the named parties
- Do not attend within 50m of any known place of residence, employment or education of named parties
- Do not attend within 100m of named address
- No weapons



Charges: Assault, Mischief

Disposition:

- Court appearance on October 16th
 - Extra Judicial Sanctions
 - Common Law Peace Bond
- No contact/communication direct/indirect by any means with named party
Do not attend anywhere the named party lives, works or attends school
No weapons

- Found guilty of Fail/Refuse to provide sample
- \$2000 fine
- 12 months' driving prohibition



Charge: Assault – Spousal

Disposition:

- Court appearance on October 18th
- Entered into a s. 810 - 12 months' CLPB
- Do not contact/communicate with named party by any means
- Do not attend any place the named party lives, works, attends school
- Do not possess any weapons
- Charge withdrawn as per the CLPB



Charge: Mischief under \$5000

Disposition:

- Court appearance on October 18th
- DAP completed
- Entered into a s. 810 - 12 months' CLPB
- Do not contact/communicate with named party by any means
- Do not attend any place the named party lives, works or attends school
- Do not possess any weapons
- Charge withdrawn as per the CLPB
