**Form 11 Releases:**



**Charges:** Aggravated assault, Assault

**Released:**

- Bail hearing on October 23<sup>rd</sup>
- Released on a Form 11
- Promise to pay \$3000 if FTC with the release order
- Reside at named address
- Remain in residence daily b/w 10pm and 6am with exceptions
- Do not contact/communicate in any way direct/indirect with named parties
- Do not attend named addresses
- Do not attend establishments that's primary nature is the sale of alcohol
- Do not possess alcohol outside of residence
- Do not possess any weapons
- Do not be under the influence of alcohol while outside residence
- Next court date is November 12<sup>th</sup>



**Charges:** Mischief, Breach Probation, Obstruct police, FTC x 2,  
Possess sched I substance - Dilaudid

**Released:**

- Bail hearing on October 25<sup>th</sup>
- Released on a Form 11 once GPS installed
- Will be subject to wearing a GPS monitor, following the rules and protocols
- Promise to pay \$500 if FTC with the release order
- Do not attend named addresses
- Next court date is November 12<sup>th</sup>

**Released:**

- Bail hearing on October 25<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Do not contact/communicate direct/indirect with named party
- Do not attend named location
- Next court date is November 12<sup>th</sup>

**Charges:** Assault with a weapon x 2

**Disposition:**

- Court appearance on October 21<sup>st</sup>
- Entered into a 12 months' Common Law Peace Bond
- No contact with named party
- Non-attendance at any known place of residence, employment or education of named party
- No weapons
- Charges withdrawn as per the CLPB



**Charges:** Theft under \$5000 x 3

**Disposition:**

- Court appearance on October 22<sup>nd</sup>
- Direct Accountability Program – DAP completed
- Restitution
- Charges withdrawn

**Disposition:**

- Court appearance on October 22<sup>nd</sup>
- Entered into an 18 months' CLPB, charge withdrawn
- No contact or association, directly or indirectly, with named party
- Do not attend named address



**Charges:** STPS - FTC release order x 2

OPP - Flight from police x 3, Possess property over \$5000,  
Mischief under \$5000

Drive m/v no permit, Drive no insurance - POA

**Disposition:**

- Court appearance on October 22<sup>nd</sup>
- STPS charges withdrawn by the Crown
- Guilty pleas to; Flight from police, Possess property over \$5000,  
Careless driving
- 90 days PSC enhanced to 135 days
- 12 months' driving prohibition
- Remaining charges were withdrawn



**Charges:** Possess for the purpose of trafficking x 4, FTC x 2

**Disposition:**

- Court appearance on October 22<sup>nd</sup>
- CDSA charges were transferred to federal court
- FTC charges were withdrawn



**Charges:** Possess for the purpose of trafficking x 3, –Meth, Cocaine,  
Codeine, Possession of property over \$5000

**Disposition:**

- Court appearance on October 22<sup>nd</sup>
- All charges were withdrawn by the Crown

**Charges:** Impaired operation, Over 80 BAC  
Drive m/v liquor readily available, Novice B driver BAC above 0

**Disposition:**

- Court appearance on October 22<sup>nd</sup>
- Plead not guilty to impaired driving but guilty to the lesser offence of Dangerous operation
- Conditional discharge
- 12 months' Probation
- 100 hours of community service
- 12 months' driving prohibition



**Charges:** Robbery with violence x 2, FTC Probation x 4, B&E x 2

**Disposition:**

- Court appearance on October 22<sup>nd</sup>
- Plead guilty to the lesser offence of assault from the robbery charge, and unlawfully in a dwelling
- 98 days PSC enhanced to 147 days, 35 days remaining to serve
- 3 years Probation
- Do not contact/communicate with named parties
- Do not attend anywhere the named parties live, work, attend school
- Do not attend named address
- Do not possess any weapons
- All remaining charges were withdrawn

**Charge:** FTC Probation

**Disposition:**

- Court appearance on October 22<sup>nd</sup>
- Guilty plea
- Suspended sentence, 6 months' Probation
- Make a \$200 donation to a registered Canadian charity



**Charges:** Possession of property obtained by crime under \$5000, Fraud under \$5000, FTC Probation x 2, Possess sched I – Fentanyl for the purpose of trafficking

**Disposition:**

- Court appearance on October 22<sup>nd</sup>
- Guilty plea to Fraud under \$5000 and Possess for the purpose of trafficking - Benzimidazole
- Sentenced to 5 years Penitentiary
- 320 days PSC enhanced to 480 days
- Has 1,345 days remaining on sentence
- S. 110 order for 10 years weapons' Prohibition
- DNA



**Charges:** Assault, Theft under \$5000, FTC Probation x 2, B&E x 2, Robbery with violence

**Disposition:**

- Court appearance on October 22<sup>nd</sup>
- Guilty plea to Theft under \$5000, guilty plea to lesser offence of assault from the robbery charge and guilty plea to unlawfully in a dwelling from the B&E charge
- 14 days, time served
- 2 years' Probation
- Do not contact/communicate with named parties
- Do not attend anywhere the named parties live, work, attend school
- Do not attend named address
- Do not possess any weapons
- All remaining charges were withdrawn

**Charges:** Possess prohibited ammo, Unauthorized possession of a weapon, Assault – Spousal, Utter death threat

**Disposition:**

- Trial commenced on October 23<sup>rd</sup>
- Crown withdrew two charges prior to the trial;
- Possess prohibited weapon, Unauthorized possession of a weapon  
Was acquitted of remaining charges once trial commenced



**Charges:** Theft over \$5000 x 2

**Disposition:**

- Court appearance on October 23<sup>rd</sup>
- Guilty plea to theft over x 2
- Suspended sentence
- 12 months' Probation  
Do not attend named location



**Charges:** Assault, Mischief, FTC undertaking

**Disposition:**

- Court appearance on October 24<sup>th</sup>
- Guilty plea to assault
- Conditional discharge
- 12 months' Probation
- No contact/communication direct/indirect by any means with named parties
- Do not attend any residence, work, or employment of named parties
- Do not possess any weapons
- Remaining charges were withdrawn as per the resolution

**Disposition:**

- Court appearance on October 25<sup>th</sup>
- Charges withdrawn by the Crown
- Not in the public's interest – NPI
- Served 7 days
- Released from EMDC



**Charge:** Mischief – Domestic

**Disposition:**

- Court appearance on October 25<sup>th</sup>
- Charge withdrawn
- Entered into a 12 months' CLPB
- No contact/association, directly/indirectly with named party
- Do not attend at any known place of residence/employment/education of named party
- Not to possess any weapons



**Charge:** Impaired - Over 80 BAC

**Disposition:**

- Court appearance on October 25<sup>th</sup>
- Guilty plea to lesser offence of Careless driving
- \$1000 fine
- 12 months' POA Probation
- Have a BAC of zero at all times while operating a m/v on Probation
- Carry a copy of his Probation order with driver's licence at all times and surrender it to police when requested
