Form 11 Releases:



Charges: Sexual assault x 2, Sexual interference x 2, Utter death threats, Sexual Exploitation

Released:

- Bail hearing on October 8th
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Reside with surety
- Remain in the residence at all times except with surety
- Do not be within 100m of any place the named parties live, work, attend school
- Do not be in the presence of anyone under the age of 18
- Do not possess any weapons
- Next court date is November 1st



Charge: Assault BH

Released:

- Bail hearing on October 9th
- Released on a Form 11
- Do not contact/communicate in any way w/ named party
- Do not be within 100m of any place the named party lives, works or goes to school
- Do not possess any weapons
- Next court date is November 5th





Charges: Sexual assault, FTC Probation

Released:

- Bail hearing on October 10th
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Reside with surety
- No contact/communication with named party
- Do not be within 50m of any place the named party lives, works, attends school
- Do not attend within 25m of named location
- Do not possess any weapons
- Next court date is November 5th



Charges: Mischief under, Theft under, Assault x 2, Utter Resist arrest, Assault police

Released:

- Bail hearing on October 11th
- Released on a Form 11
- Promise to pay \$750 if FTC with the release order
- Report to the John Howard Society as directed
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not attend named locations
- Do not possess any weapons
- Next court date is October 29th





Charge: Theft under \$5000

Released:

- Bail hearing on October 11th
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Report to the John Howard Society as directed
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend named address
- Next court date is October 22nd

Dispositions:



Charges: Obstruct police, Possess schedule I substance for the purpose of trafficking x 2; Fentanyl & Crystal Meth

Disposition:

- Court appearance on October 7th
- Charges withdrawn by the Crown
- Not in the public's interest NPI Co-accused is still wanted



Charge: Arson-Disregard for human life

Disposition:

- Court appearance on October 8th
- Guilty plea to lesser charge of mischief
- Suspended sentence
- 12 months' Probation

Do not attend within 25m of named address

Was remanded into custody on outstanding charges





Charges: Theft under, Mischief under, unlawfully in a dwelling, FTC release order x 5

Disposition:

- Court appearance on October 8th
- Guilty pleas; Mischief, FTC x 2
- Condition discharge
- 12 months' Probation
- Do not attend within 50m of named address
- Communicate with named parties, only by phone
- Remaining charges were withdrawn as part of the resolution



Charges: FTC Probation x 14, Theft under x 3, Assault – Spousal, B&E x 2, FTC release order x 2

Disposition:

- Court appearance on October 8th
- Guilty pleas; Theft under, FTC, FTC Probation
- 10 days of pre-sentence custody
- 2 years' Probation
- No contact/communication with named parties
- Do not attend named addresses
- 80 hours of Community Service



Charges: Possession of schedule I substance x 2, Oxy & Crystal Meth, Resist police, Assault police, FTC release order

Disposition:

- Court appearance on October 8th
- Guilty plea to assault police
- 26 days enhanced to 39 days; time served
 Remaining charges were withdrawn as per the resolution





Charges: Impaired operation, Over 80 BAC, Drive m/v no licence - HTA

Disposition:

- Court appearance on October 8th
- Guilty plea to Impaired Operation
- \$1,000 fine
- 1 year driving prohibition
- 6 months' Probation
- 40 hours of CSO



Charges: Assault with a weapon, FTC release order

Possession of a weapon for a dangerous purpose

Disposition:

- Guilty plea on day of trial on October 10th
- Guilty plea to Possession weapon for dangerous purpose, FTC
- 1 day deemed served, 89 days PSC enhanced to 134 days
- 24 months' Probation
- No contact with named party
- Non-attendance at any known place of residence, employment, or education of named party
- No weapons, DNA, s. 110 10 years



Charges: Assault & Utter death threat - Spousa

Disposition:

- Court appearance on October 10th
- Elgin Therapeutic Court completed
- Charges stayed
