Mischievous under \$5000 x 2, Assault carry weapon

Disposition:

Bail hearing on September 26th
Released on a Form 11
Promise to pay \$500 if FTC with the release order
Reside at named address
Do not contact/communicate in any way by any means with named party
Do not be within 50m of any place the named party lives,
works, attends school
Do not be within 10m of named party
Do not possess any weapons
Next court date is October 22nd



Charges: possession schedule 1 substance for the purpose, possess
proceeds obtained by crime over, breach probation

Disposition:

Released on a Form 11
Promise to pay \$7,500 if FTC with order
Reside with surety at named address
Report to the STPS by phone every Friday

Disposition:
Court appearance on September 24th
Guilty plea to FTC Probation
Sentenced to 90 days, 48 days PSC enhanced to 72;
Has 18 days remaining to serve on sentence
Remaining charges to be withdrawn as part of the resolution
