**Charge:** Breach Probation

**Released:**

- Released on a Form 11
- Promise to pay \$200 if FTC with the release order
- Next court date is October 22<sup>nd</sup>



**Charge:** Assault

**Released:**

- Bail hearing on September 29<sup>th</sup>
- Released on a Form 11
- Promise to pay \$200 if FTC with the release order
- Next court date is October 15<sup>th</sup>



**Charges:** Breach recognizance, Disobey court order, FTC Probation

**Released:**

- Bail hearing on October 1<sup>st</sup>
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Wear a GPS monitor and follow the protocols of the program
- Do not contact/communicate in any way direct/indirect by any means with named parties
- Do not be within 100m of any place the named party lives, works, goes to school
- Do not be within 100m of named address
- Do not possess any weapons
- Next court date is October 15<sup>th</sup>

**Released:**

- Bail hearing on October 2<sup>nd</sup>
- Released on a Form 11
- Arrested by London PS on a Bench Warrant
- Promise to pay \$750 if FTC with the release order
- Report to Probation and the John Howard Society as directed
- Do not possess any ID, banking issued document or bank card unless it has been lawfully issued
- Next court date is October 15<sup>th</sup>



**Charges:** Assault x 2, Utter threats, Mischief, Prowl at night, B&E, Enter a dwelling, Harassment, FTC x 5

**Disposition:**

- Bail hearing on October 2<sup>nd</sup>
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Wear a GPS monitor and follow the protocols of the program
- Reside at named address
- Do not contact/communicate in any way direct/indirect by any means with the named parties
- Do not attend at any place the named parties live, work, attend school
- Do not attend named locations
- Do not possess any weapons
- Next court date is October 8<sup>th</sup>

**Charges:** Mischief to property endangering life, FTC Probation x 2

**Released:**

- Bail hearing on October 3<sup>rd</sup>
- Promise to pay \$1000 if FTC with the release order
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend at named address
- Do not possess any weapons
- Next court date is October 15<sup>th</sup>

**Charges:** Impaired driving, Over 80 BAC, Obstruct police  
**POA:** Drive while suspended, Use plate not authorized, Drive no insurance

**Disposition:**

- Court appearance on October 1<sup>st</sup>
- Guilty plea to Over 80 BAC
- \$2,700 fine
- 1 year driving Prohibition
- Remaining charges were withdrawn as part of the resolution



**Charges:** Assault, Assault with a weapon, Mischief under, FTC

**Disposition:**

- Court appearance on October 1<sup>st</sup>
- Guilty plea to FTC undertaking
- Suspended sentence
- 12 months' Probation
- No contact with named party
- Do not attend any place of employment, residence or education of named party
- Remaining charges were withdrawn as part of the resolution

**Charges:** Theft under \$5000 x 2

**Disposition:**

- Court appearance on October 1<sup>st</sup>
- Guilty plea to theft under \$5000
- 20 days of pre-plea custody enhanced to 30 days jail



**Charge:** Assault

**Disposition:**

- Court appearance on October 1<sup>st</sup>
- Guilty plea
- Suspended Sentence
- 24 months' Probation
- No contact/communication with named party
- Do not attend named address
- No weapons, DNA



**Charges:** Impaired operation, Over 80 BAC

**Disposition:**

- Court appearance on October 1<sup>st</sup>
- Guilty plea to Over 80 BAC
- 6 months' conditional sentence order
- Do not consume alcohol or controlled substances
- 12 months' driving prohibition which commences after the 6 months' CSO



**Charges:** Fraud under \$5000 x 2

**Disposition:**

- Court appearance on October 1<sup>st</sup>
- No public interest - NPI
- Charges withdrawn by the Crown

**Charge:** Arson

**Disposition:**

- Elgin Therapeutic Court appearance on October 2<sup>nd</sup>
- Guilty plea to lesser offence of mischief
- Conditional discharge
- 12 months' Probation
- Do not possess any incendiary devices



**Charge:** Possession of a weapon for a dangerous purpose

**Disposition:**

- Court appearance on October 2<sup>nd</sup>
- Charge withdrawn
- Entered into a 6 months' Common Law Peace Bond
- Do not possess any weapons



**Charges:** Fraud under \$5000

**Disposition:**

- Court appearance on October 3<sup>rd</sup>
- Direct Accountability Program completed
- Charge withdrawn



**Charges:** Over 80 BAC, Speeding - HTA

**Disposition:**

- Court appearance on October 3<sup>rd</sup>
- Guilty plea
- Suspended sentence
- 12 months' Probation
- Reside at named address
- DNA & 80 hours of community service
- Has other criminal matters before the court
- Next court date is October 15<sup>th</sup>



**Charges:** APS – Assault BH x 2, Assault – Spousal x 3, Mischief,  
FTC Probation x 2, Forcible confinement

**STPS** – Assault police, FTC Probation x 3

**Disposition:**

- Court appearance on October 3<sup>rd</sup>
- Guilty plea to assault police
- Found guilty of Assault, FTC Probation x 2 after trial
- 1 day deemed served, 120 days PSC enhanced to 180 days
- 3 years' Probation
- Do not contact/communication with named party
- Do not attend anywhere the named party lives, works, attends school
- Do not attend within the municipal boundaries of the Town of Aylmer
- 100 hours of community service
- Do not possess any weapons
- Remaining charges were withdrawn as part of the resolution

- Do not possess any weapons
- Complete the Changing Ways Program
- Charges withdrawn as per the Peace Bond
