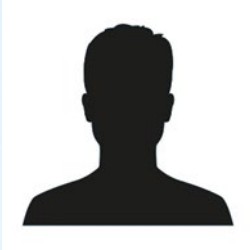

- Reside at named address
- Do not contact/communicate in any way direct/indirect with named parties
- Do not attend any place where the named parties live, work, attend school
- Do not possess any weapons
- Next court date is December 4th



Charges: Assault with a weapon, Utter death threat

Released:

- Bail hearing on November 14th
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Do not contact/communicate directly/indirectly by any means with named party
- Do not attend named address
- Do not possess any weapons
- Next court date is December 3rd



Charges: Identity fraud, Use forged document

Released:

- Bail hearing on November 15th
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Do not contact/communicate in any way direct/indirect with named party
- Do not attend at the City of St. Thomas with **exceptions**
- Do not possess any ID, card with data strip or security cheque, bank document unless she can prove it has been lawfully issued
- Next court date is November 26th

Released:

- Bail hearing on November 15th
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Report to the John Howard Society as directed
- Reside at named address
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend within 100m of named address
- Do not be in the City of St. Thomas with **exceptions**
- Do not possess any weapons
- Next court date is December 10th

- Remaining charges were withdrawn as part of the resolution



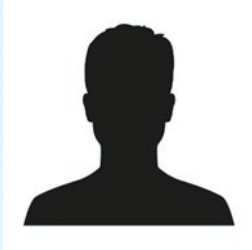
Charge: Theft under \$5000

- Charge withdrawn



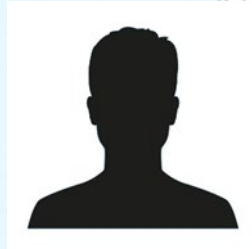

Charge: Identity theft

Disposition:

- Court appearance on November 12th
- Guilty plea to Identity theft
- Suspended sentence
- 12 months' Probation
- No contact/communication, directly/indirectly with named party
- Do not attend at any known place of residence, education or employment of named party
- Do not attend at any of the named locations
- Do not possess any identification, banking document, debit or credit card, etc. unless lawfully issued



Charges: Possess property obtained by crime under \$5000, Obstruct, FTC x 2

Disposition:

- Court appearance on November 12th
- Guilty pleas; Possess property under \$5000 & FTC
- Sentenced to 4 days of PSC, equivalent to 6 days jail
- Remaining charges were withdrawn as part of the resolution



Charge: Assault

Disposition:

- Court appearance on November 12th
- Entered into a 12 months' Common Law Peace Bond
- No communication/association with named party
- Do not attend any place of residence, work, school of the named party
- Do not have any weapons

Charges: Assault x 3, Utter death threats, Assault – Choke, FTC x 3

Disposition:

- Court appearance on November 12th
- Guilty pleas to utter death threat, FTC
- Suspended sentence, 18 months' Probation
- No contact/association, directly/indirectly with named party
- Do not attend any known place of residence, employment or education of the named party
- Remaining charges were withdrawn as part of the resolution



Charges: FTC youth sentence order x 9

Disposition:

- Court appearance on November 12th
- Guilty plea x 1
- Absolute discharge
- Remaining charges were all withdrawn



Charges: Assault police x 2, Theft under \$5000

Disposition:

- Court appearance on November 15th
- Guilty pleas; Assault police, Theft under \$5000
- Suspended sentence
- 10 days PSC enhanced to 15 days, 1 day deemed served
- 12 months' Probation
- Do not attend named location
- DNA
- Do not possess any weapons
- Remaining charges were withdrawn as per the resolution

Charges: Utter threat - BH, Mischief, Criminal harassment, FTC x 8

Disposition:

- Court appearance on November 15th
- Guilty pleas; Criminal harassment & FTC x 2
- Suspended sentence
- 10 days PSC enhanced to 15 days, 1 day deemed served
- 3 years' Probation
- No contact with named party
- Non-attendance within 100m of any known place of residence, employment, or education of the named party
- Non-attendance within 25m of the named party
- Remain in Ontario
- No weapons
- Remaining charges were withdrawn as per the resolution



Charges: Assault, S. 810 Peace bond

Disposition:

- Court appearance on November 15th
- Entered into a 12 months' Peace Bond
- Do not contact/communicate in any way direct/indirect with named party
- Do not possess any weapons
- Charges withdrawn
- Has a remaining charge currently before the court
