- Report to the John Howard Society as directed
- Next court date is December 3rd



Charge: Theft under \$5000

- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Report to the John Howard as directed
- Do not attend within 100m of named location Next court date is November 26th



Charges: Possession sched I substance – Meth, Possess property obtained by crime under \$5000

Released:

- Bail hearing on November 18th
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Report to STPS as directed
- Reside named address
- Do not contact/communicate direct/indirect by any means with named parties
- Do not attend named locations
- Do not possess any weapons
- Next court date is December 2nd





Charges: assault-spousal x3, sex assault, forcible confinement, FTC Undertaking

Released:

- Bail hearing November 22nd
- Released on a Form 11
- No contact with named parties
 Do not be within 100 m of where the live, work or go to school
 Do not attend within 100 m of named address
 Next court December 4th



Charges: Breach Probation Released:

- Bail hearing Nov. 22nd
- Released on Form 11
- Promise to pay \$250 if FTC with this release order
- Report to John Howard society within one business day of release Be under their direct supervision

 Next court Nov. 29th

Charges: Possession of schedule I substance x 2 – Meth & Fentanyl **Disposition:**

- Court appearance on November 18th
- Direct Accountability Program DAP completed
- Charges withdrawn by the Federal Crown
- Has numerous outstanding charges before the court



Charges: Impaired operation, Theft under \$5000 Disposition:

- Trial commenced on November 18th
- Impaired charge withdrawn, charge dismissed, not guilty
- Theft under \$5000 trial to begin on December 3rd



Charges: FTC Probation x 2 Disposition:

- Court appearance on November 19th
- Guilty plea to both charges
- 50 days sentence, minus 46 days of PSC 4 days remaining
- 12 months' Probation
- Reside at named address



Charges: Dangerous operation, Fail to remain - HTA **Disposition:**

- Court appearance on November 19th
- Guilty plea to Dangerous operation
- \$500 fine
- 6 months' driving prohibition
- Fail to remain charge withdrawn





Charge: FTC Probation

Disposition:

- Court appearance on November 20th
- Charge withdrawn
- No reasonable prospect of conviction NRPC

- Court appearance on November 19th
- Charge withdrawn NRPC



Charges: APS - B&E, Possess property over \$5000, FTC

STPS – Impaired operation, Possess schedule II – Fentanyl, Possess counterfeit money

Disposition:

- Court appearance on November 19th
- Guilty pleas to; Impaired operation, Possess property under \$5000
- \$1,300 fine
- 12 months' Probation
- 1 year driving prohibition
- Remaining charges were withdrawn



Charge: Mischief Disposition:

- Court appearance on November 19th
- DAP completed
- Charge withdrawn





Charges: Impaired operation, Over 80 BAC

- Disposition:
- Court appearance on November 19th
- Guilty plea to Impaired operation
- 30 days in jail to be served on weekends
- 2 years' Driving Prohibition
- 12 months' Probation

Over 80 charge was withdrawn



Charges: Assault – Spousal, Utter threats - BH, FTC Probation **Disposition:**

- Court appearance on November 19th
- Charges withdrawn by the Crown after speaking with the complainant
- No reasonable prospect of conviction NRPC



Charge: Theft under \$5000

Disposition:

- Court appearance on November 20th
- Charge withdrawn as part of a resolution with London charges





Charges: Possess property obtained by crime under \$5000 x 3, Theft under \$5000 x 3, FTC Probation x 2, FTC release order x 5, Theft over \$5000 of a m/v, Unlawfully in a dwelling, B&E, Mischief, Use credit card x 3, FTC undertaking x 2, Possess sched I substance Fentanyl

Disposition:

- Court appearance on November 19th
- Guilty pleas; Possess property obtained by crime under \$5000 x 2, FTC, Theft under \$5000, Unlawfully in a dwelling, Mischief, Use credit card
- 180 days jail; less 54 days of PSC
- 2 years' Probation
- Do not attend named addresses
- Do not possess any ID; do not possess a card with a data strip or security chip, credit/debit card, credit/debit card data, a blank card with a magnetic chip; cheque, negotiable, or banking document not issued in their name
- No contact/association with named party
- Do not attend any place the named party lives, works, attends school
- Do not possess any weapons
- Remaining charges were withdrawn as part of the resolution



Charges: Assault x 2, Utter threat BH, Mischief under \$5000

Disposition:

- Court appearance on November 20th
- Guilty pleas to all charges except mischief
- 12 months' Probation
- No contact with named parties
- Non-attendance at any known place of residence, employment or education for the named parties
- No weapons





Charges: OPP – Assault BH, Utter death threats, Assault x 2,
Assault with a weapon, Harassing phone calls
STPS – Assault with a weapon

Disposition:

- Court appearance on November 20th
- Guilty pleas to; Harassing phone calls, Utter death threats, Assault BH
- 2 years' Probation
- No contact with named parties
- Do not be within 250m of where the named parties live, work, attend school
- Do not to be within 25m of the named parties
- 50 hours of Community service
- DNA
- Weapons' Prohibition 2 years
- Remaining charges were withdrawn as part of the resolution
