### Form 11 Releases:



Charges: Obstruct police, Mischief under \$5000 Released:

- Bail hearing on November 5<sup>th</sup>
- Released on a Form 11
- Report to the John Howard Society as directed
- Do not attend named address
- Next court date is November 12<sup>th</sup>
  Held for CKPS on outstanding warrants



**Charges:** Operate conveyance in a dangerous manner, Assault, B&E, FTC **Released:** 

- Bail hearing on November 6<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Reside at named address
- No contact/communication in any way with named parties
- Do not attend named address
- Do not possess any weapons
- Do not possess any B&E tools
- Next court date is November 26<sup>th</sup>



Charges: Utter threats BH, Mischief under \$5000, FTC undertaking x 3, FTC release order x 2, s.810 Cause fear to person/damage property

#### Released:

- Bail hearing on November 6<sup>th</sup>
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Wear a GPS device and follow the protocols of the program
- Reside at named address
- Do not contact/communicate in any way with named parties
- Do not be within 50m of the named parties
- Do not possess any weapons
- Next court date is December 4<sup>th</sup>





**Charges:** Theft under \$5000 x 2, FTC undertaking x 2 **Disposition:** 

- Bail hearing on November 7<sup>th</sup>
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Wear a GPS monitor and comply with the protocols
- Reside at named address
- Do not attend named location
- Next court date is November 26<sup>th</sup>



Charges: STPS - Breach Probation

**APS** - Possess property obtained by crime under \$5000, Assault, Utter death threat

#### Released:

- Bail hearing on November 7<sup>th</sup>
- Released on a Form 11
- Promise to pay \$250 if FTC with the release order
- Report to the John Howard Society as directed
- Do not contact/communicate in any way with named party
- Do not possess any weapons
- Next court date is November 26<sup>th</sup>



Charges: OPP - Assault x 2, FTC undertaking

STPS - Theft under \$5000, FTC Possess schedule I x 3

#### Released:

- Bail hearing on November 8<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Report to the John Howard Society as directed
- Do not contact/communicate in any way with named party
- Do not attend named address
- Do not possess any weapons
- Next court date is November 25<sup>th</sup>





Charges: Assault, FTC x 2

#### Released:

- Bail hearing on November 8<sup>th</sup>
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Reside at named address
- Wear a GPS and follow the protocols
- Do not contact/communicate in any way with named parties
- Do not be within 100m of any place the named parties live, work, attend school
- Do not attend the County of Elgin
- Do not possess any weapons
- Next court date is November 26<sup>th</sup>

**Charges:** Unauthorized possession of a firearm, Knowledge of unauthorized possession of a firearm, Careless storage of a firearm & ammo

### **Disposition:**

- Court appearance on November 4<sup>th</sup> for sentencing
- Guilty plea to; Knowledge of unauthorized possession of a firearm
- 6 months jail sentence
- DNA, S. 109 weapons' Prohibition
- 3 years' Probation following jail sentence
- Do not contact/communicate in any way with named party
- Remaining charges were withdrawn as part of the resolution



Charge: Indecent assault on a male Disposition:

- Court appearance on November 5<sup>th</sup>
- Charge withdrawn by the Crown
- No reasonable prospect of conviction NRPC





**Charges:** Possession of an explosive substance x 2, Arson, Arson – Disregard for human life

#### **Disposition:**

- Court appearance on November 5<sup>th</sup>
- All charges withdrawn by the Crown
- No reasonable prospect of conviction NRPC



**Charges:** FTC Probation x 2

Charges: Assault, FTC undertaking, FTC Probation x 2

- Court appearance on November 5<sup>th</sup>
- Guilty plea to assault, FTC Probation
- 45 days sentence; 9 days remaining
- 12 months' Probation
- No contact/association, directly/indirectly with named party
- Do not attend any known place of named party
- Do not possess any weapons
- Remaining charges were withdrawn as per the resolution





Charges: FTC Probation x 5, Possess weapon for a dangerous purpose, Utter death threat, Assault with a weapon, Mischief over \$5000, Mischief under \$5000, Unlawfully in a dwelling

#### Disposition:

- Court appearance on November 5<sup>th</sup>
- Guilty pleas to; Possess weapon/dangerous purpose, Utter death threat, Mischief over \$5000, FTC Probation x 2, Unlawfully in a dwelling
- 6 months sentence, 22 days to serve
- 2 years' CLPB to remain away from all named parties and addresses
- Remaining charges were withdrawn as per the resolution



**Charges:** Mischief x 2, FTC Probation x 5 **Disposition:** 

- Court appearance on November 5<sup>th</sup>
- Guilty pleas to; Mischief under \$5000, FTC Probation x 4
- Time served; 26 days of PSC enhanced to 39 days
- Remaining charges were withdrawn as per the resolution



Charges: Mischief endangering life, FTC Probation x 2

#### Disposition:

- Court appearance on November 5<sup>th</sup>
- Guilty to all charges
- Suspended sentence
- 12 months' Probation

Charge: Assault - Spousal

#### Disposition:

- Court appearance on November 5<sup>th</sup>
- Guilty plea
- Conditional discharge
- 12 months' Probation
- No contact/communication with named parties
- Do not attend any place the named parties are known to be
- Do not possess weapons



**Charges:** FTC Probation x 2, FTC release order, B&E, Possess B&E tools, Mischief under, False pretences, Possess counterfeit money

- Court appearance on November 5<sup>th</sup>
- Guilty pleas to B&E, False pretences, FTC Probation
- Time served, global sentence of 86 days, released on a Form 11
- 12 months' Probation
- Do not attend named address
- Do not contact all named parties





**Charges:** Possession for the purpose of trafficking; Meth & Cocaine. Robbery x 2, B&E x 2, Arson

#### Disposition:

- Court appearance on November 6<sup>th</sup>
- Guilty pleas to; Possession of Cocaine and Unlawfully in a dwelling
- Sentenced to 170 days; time served (113 days PSC enhanced to 120)
- 3 years' Probation
- No contact/communication in any way with named parties
- Do not be within 25m of any place the named parties are
- Do not be within 25m of named address
- Do not possess any weapons
- Remaining charges were withdrawn as per the resolution



Charge: Arson – Damage to property Disposition:

- Court appearance on November 6<sup>th</sup>
- Guilty plea
- Time served; 10 days PSC enhanced to 15 days
- 18 months' Probation
- Do not attend within 100m of the named location



Charges: Assault & Theft under \$5000 Disposition:

- EN MICRO
  - Court appearance in London on November 6<sup>th</sup>
  - Conditional discharge
  - 18 months' Probation
  - Attend a non-residential Attendance Centre Program and complete up to 240 hours to a maximum period of six months
  - Non-association with all named parties
  - Not to be on the property of all named addresses
  - No weapons





Charge: Impaired - Over 80 BAC

#### **Disposition:**


- Court appearance on November 8<sup>th</sup>
- Guilty plea to lesser offence of Careless driving
- \$400 fine



Charge: Utter threat BH

#### Disposition:

- Court appearance on November 8<sup>th</sup>
- Guilty plea to S. 810 Peace bond for 12 months
- No contact/communication, direct/indirect with named party
- Do not attend any place the named party is known to be
- Do not be within 10m of the named party
- Do not possess any weapons
- Criminal charge was withdrawn



Charge: Assault

#### **Disposition:**

- Court appearance on November 8<sup>th</sup>
- Guilty plea to S. 810 Peace Bond for 12 months
- No contact/communication with named party
- Non-attend any known place of the named party
- No weapons
- Assault charge withdrawn, has an outstanding matter before the court



Charge: Assault – Spousal

- Court appearance on November 8<sup>th</sup>
- Guilty plea to S. 810 peace bond for 12 months
- No contact/association, directly/indirectly, with named party
- Do not attend at any known place of the named party
- Do not possess any weapons
- Assault charge was withdrawn





Charge: Assault - Spousal

- Disposition:
  - Court appearance on November 8<sup>th</sup>
  - Guilty plea to S. 810 peace bond for 12 months
  - No contact/association, directly/indirectly with named party
  - Do not attend at any known place of the named party
  - Do not possess any weapons
  - Assault charge was withdrawn as part of the plea
