- Promise to pay \$200 if FTC with the release order
- Next court date is November 12<sup>th</sup>



**Charge:** FTC undertaking

**Released:**

- Bail hearing on October 27<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Report to the John Howard Society as directed
- Do not contact/communicate in any way direct/indirect with named party
- Next court date is November 26<sup>th</sup>

**Charges:** Assault - choking, Assault, Forcible confinement, B&E

**Released:**

- Bail hearing on October 30<sup>th</sup>
- Released on a Form 11
- Wear a GPS monitoring device and follow protocols
- Promise to pay \$500 if FTC with the release order
- Reside with surety
- Remain in the residence daily b/w 12pm – 6am with exceptions
- Do not contact/communicate in any way direct/indirect with named parties
- Do not be within 100m of any place the named parties live, work, attend school, including named address
- Do not possess any weapons
- Next court date is November 19<sup>th</sup>



**Charges:** Theft under \$5000, Possess property under \$5000

**Released:**

- October 30<sup>th</sup> released from EMDC on a Form 11
- Do not attend named address
- Next court date is December 3<sup>rd</sup>

**Charges:** Sexual assault, Assault - Choking, Assault

**Released:**

- Bail hearing on October 31<sup>st</sup>
- Released on a Form 11
- Subject to a GPS monitor and its protocols
- Promise to pay \$1000 if FTC with the release order
- Assault charge withdrawn
- Reside with surety
- Do not contact/communicate in any way direct/indirect with named party
- Do not attend at any place the named party lives, work or goes to school
- Do not possess any weapons
- Deposit passports with STPS
- Remain within the City of St. Thomas at all times, **except** while with surety or while travelling to & from EMDC
- Next court date is November 19<sup>th</sup>



**Charges:** Assault, Assault - Choke

**Released:**

- Bail hearing on October 31<sup>st</sup>
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Wear a GPS monitor and follow protocols
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not be within 100m of any place the named party lives, works, attend schools or frequents
- Do not possess any weapons
- Do not attend the City of St. Thomas
- Next court date is November 26<sup>th</sup>

**Charges:** Sexual interference, Making child pornography for publication,  
Unauthorized possession of firearm, Possess child pornography

**Released:**

- Bail hearing on October 31<sup>st</sup>
- Promise to pay \$2000 if FTC with the release order
- Reside with surety
- Do not contact/communicate in any way direct/indirect by any means with named party
- Do not attend at any place the named party lives, works or attends school
- Do not attend the City of St. Thomas
- Do not attend a public park (public swimming area, daycare, playground, community centre) where persons under 16 years are present or can reasonably be excepted
- Do not seek, obtain or continue with any paid or unpaid activity that involves being in a position of trust or authority towards persons under the age of 16 years
- Do not have any contact – incl communicating by any means with a person who is under the age of 16 years unless the direct presence of of surety
- Do not possess any weapons
- Do not use the internet or other digital network unless under the direct supervision of surety
- Next court date is November 19<sup>th</sup>



**Charges:** Theft under \$5000 x 2

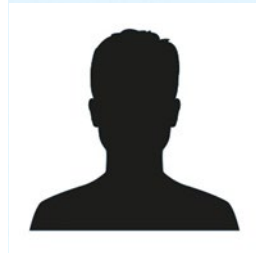
**Disposition:**

- Promise to pay \$500 if FTC with the release order
- Released on a Form 11, Report to the John Howard Society as directed
- Do not attend named locations
- Next court date is November 19<sup>th</sup>

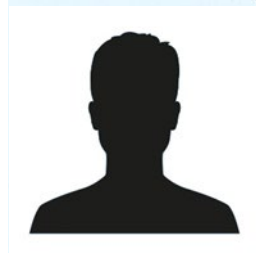
**Dispositions:**



**Charge:** Breach of Conditional Sentence Order (CSO)

**Disposition:**

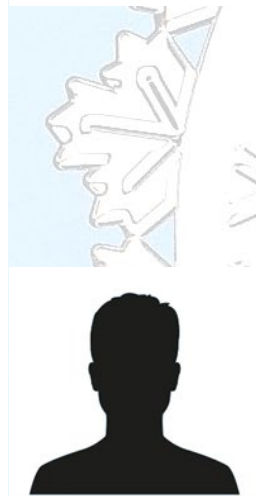
- Court appearance on October 28<sup>th</sup>
- Found guilty of the breach of CSO
- Varied sentence, 45 days in custody awaiting disposition hearing



**Charges:** Dangerous operation of a m/v, Mischief under \$5000

**Disposition:**

- Court appearance on October 29<sup>th</sup>
- Guilty plea to Dangerous operation
- \$1,000 fine
- 2 years' Probation
- No contact/communication with named party
- Do not attend at any known place of residence, education or employment of named party
- Do not possess any weapons



**Charge:** FTC undertaking

**Disposition:**

- Court appearance on October 29<sup>th</sup>
- Charge withdrawn by the Crown as part of resolution
- Has other criminal charges before the court

**Charge:** Fraud over \$5000

**Disposition:**

- Court appearance on October 29<sup>th</sup>
- Guilty plea
- Conditional discharge
- 12 months' Probation
- Do not possess any ID, card with data strip or security chip, credit/debit card or banking document unless it has been lawfully issued
- Make restitution of \$11,243.63 to named party



**Charges:** Possess sched I substance x 3 (Fentanyl, Meth, & Oxy)  
Obstruct police, FTC Probation

**Disposition:**

- Court appearance on October 29<sup>th</sup>
- CDSA informations x 3 were withdrawn by the Crown - NPI
- Remaining criminal charges are still before the court  
Next court date is December 3<sup>rd</sup>



**Charge:** Theft under \$5000

**Disposition:**

- Court appearance on October 29<sup>th</sup>
- Charge withdrawn - NPI

**Charges:** Robbery with violence, B&E

**Disposition:**

- Court appearance on October 29<sup>th</sup>
- Guilty plea to lesser offences of Assault and Unlawfully in a dwelling
- Sentenced to 90 days less PSC; 30 days remaining to serve
- 2 years' Probation
- No contact with named parties
- Do not attend within 25m of the named parties
- Do not attend within 25m of any place the named parties are
- Do not attend within 25m of named address
- Do not possess any weapons for 5 years
- DNA



**Charge:** FTC release order

**Disposition:**

- Court appearance on October 29<sup>th</sup>
- Direct Accountability Program – DAP completed
- Charge withdrawn



**Charges:** Possess sched I substance – Meth, Theft under \$5000,  
Possession of property obtained by crime under \$5000

**Disposition:**

- Court appearance on October 30<sup>th</sup> by video from EMDC
- CDSA charge withdrawn by the Federal Crown
- Criminal code charges are still before the court  
Released on a Form 11, next court date is December 3<sup>rd</sup>

**Charge:** Theft under \$5000

**Disposition:**

- Court appearance on October 31<sup>st</sup>
- Charge withdrawn by the Crown - NPI
- The property was returned to the victim



**Charges:** FTC Probation x 4, Assault x 2, Theft under \$5000, Robbery

**Disposition:**

- Court appearance on October 31<sup>st</sup>
- Guilty pleas to Assault x 2, Theft under \$5000
- Sentenced to 360 days minus PSC; 285 days remaining
- Do not contact/communicate in any way direct/indirect with named parties
- Do not attend anywhere the named parties live, work, attend school
- Do not possess any weapons
- DNA
- Remaining charges were withdrawn as part of the resolution



**Charge:** Assault - Spousal

**Disposition:**

- Court appearance on November 1<sup>st</sup>
- Entered into a 12 months' CLPB
- No contact/association, directly/indirectly with named party
- Do not attend at any known place of residence, employment or education of named party
- Do not possess any weapons
