**Form 11 Releases:**



**Charges:** Assault x 2, B&E, FTC Undertaking, Mischief under \$5000,  
Trespass at night, Unlawfully in a dwelling, Utter threats, FTC x 4,  
Possess schedule I substance - Fentanyl

**Released:**

- Bail hearing on December 1<sup>st</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Do not contact/communicate in any way with the named parties
- Do not attend the named locations
- Do not possess any weapons or B&E instruments
- Breached Form 11 on December 2<sup>nd</sup>, remanded into custody



**Charges:** Possess property obtained by crime over \$5000, FTC x 4,  
Obstruct, Mischief, Possess scheduled I substance

**Released:**

- Bail hearing on December 4, 2024
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Reside with surety
- Do not contact/communicate with the named parties
- Do not attend the named addresses
- Do not possess any weapons
- Next court date is January 14, 2025



**Charges:** Theft under \$5000

**Released:**

- Bail hearing on December 4<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Report to the John Howard Society as directed
- Do not attend named locations. Next court date is January 14<sup>th</sup>

**Charge:** Mischief under \$5000

**Released:**

- Bail hearing on December 4<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Notify STPS OIC of address within 24hrs
- Do not contact/communicate in any way direct/indirect with the named parties
- Do not attend where the named parties live, work, attend school
- Do not attend named address
- Do not possess any weapons
- Next court date is January 14<sup>th</sup> 2025



**Charges:** Assault with a weapon, Theft under \$5000, FTC Probation x 3, Possession prohibited weapon

**Released:**

- Bail hearing on December 5<sup>th</sup>
- Released on a Form 11
- Promise to pay \$250 if FTC with the release order
- Do not contact/communicate in any way with named party
- Do not attend where the named parties live, work, attend school
- Do not attend named location
- Do not possess any weapons
- Next court date is December 19<sup>th</sup>

- 18 months' Probation



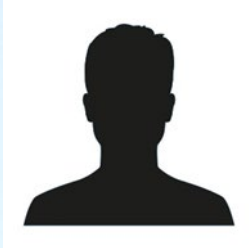
**Charges:** Breach Probation, FTC John Howard

- Court appearance on December 3<sup>rd</sup>
- Charges withdrawn by the Crown
- No public interest - NPI

**Charges:** FTC Probation x 4, Assault, Theft under \$5000

**Disposition:**

- Court appearance on December 3<sup>rd</sup>
- Guilty plea to assault
- Suspended sentence
- 12 months' Probation
- No contact with named party
- Do not attend any known place of residence, employment, education
- 20 hours of community service
- No weapons



**Charges:** Disobey court order, FTC Probation, FTC x 2

**Disposition:**

- Court appearance on December 3<sup>rd</sup>
- Guilty pleas to FTC recognizance, FTC release order
- 20 days of custody enhanced to 30 days
- 3 years' Probation
- No contact with named parties
- Do not attend within 100m of any known place of residence, employment, or education of named parties
- No weapons



**Charge:** Mischief under \$5000

**Disposition:**

- Court appearance on December 3<sup>rd</sup>
- Direct Accountability Program – DAP completed
- Charge withdrawn

**Charges:** APS – Obstruct police, Trespass at night, Possess credit card, Possess property obtained by crime under \$5000, Possess property under \$5000

**OPP** - Utter death threats, Mischief under \$5000

**STPS** – Theft under \$5000 x 2, Resist police, Obstruct police, Assault with a weapon, FTC, B&E, Utter death threat

**Disposition:**

- Court appearance on December 3<sup>rd</sup>
- Guilty pleas to Obstruct police, Possess property obtained by crime under \$5000, Mischief under, Utter death threat, Theft under x 2, Assault with a weapon, Resist police, FTC
- Sentenced to 133 days, (89 days PSC enhanced to 133; time served)
- 18 months' Probation
- Do not attend within 100m of named address
- Do not attend all named locations
- No contact /communication with named parties
- Do not possess any weapons
- Do not possess any identification, debit or credit card that is not in own name



**Charges:** Impaired operation, Possess schedule I substance – Fentanyl, Drive while under suspension – HTA, G1 licence holder – drive unlawful hour, unaccompanied by qualified driver - HTA

**Disposition:**

- Court appearance on December 3<sup>rd</sup>
- Guilty plea to Impaired driving
- \$1000 fine
- 1 year driving prohibition
- Remaining charges were withdrawn as per the resolution

**Charges:** Assault x 2

**Disposition:**

- Court appearance on December 3<sup>rd</sup>
- Assault charges withdrawn
- Entered into a 12 months' CLPB
- No contact/communication with named parties



**Charge:** STPS - FTC John Howard

**OPP** – Dangerous operation, Flight from police

**Disposition:**

- Court appearance on December 3<sup>rd</sup>
- Guilty pleas to all charges
- Sentenced to 3 months' jail (less 18 days of PSC)
- 24 months' Probation. Do not occupy the driver's seat of a m/v



**Charge:** Assault

**Disposition:**

- Court appearance on December 4<sup>th</sup>
- Extra Judicial Sanction – EJS completed
- Assault charge withdrawn
- Entered into a CLPB for 12 months
- No contact/communication with named party
- No weapons



**Charges:** Utter death threat, Assault BH – Choke, Assault – Spousal, Forcible confinement

**Disposition:**

- Court appearance on December 4<sup>th</sup>
- Guilty pleas to; Utter death threat, Assault BH - choke
- 1 day deemed served - 36 days PSC enhanced to 54 days
- 12 months' Probation
- No contact with named party
- Don't be within 25m of the named parties and do not attend within 100m of their residence, employment or education
- DNA, No weapons
