Form 11 Releases:



Charges: Assault – Choke, Utter death threat

Disposition:

- Bail hearing on December 8th
- Released on a Form 11
- Promise to pay \$250 if FTC with the release order
- Do not contact/communicate in any way with named party
- Do not be within 25m of named party including named address
- Do not possess any weapons
- Next court date is January 7th



Charges: Possess property obtained by crime under \$5000 x 3, FTC x 3, B&E

Released:

- Bail hearing on December 9th
- Released on a Form 11
- Promise to pay \$2000 if FTC with the release order
- Reside with surety & remain in the residence b/w 9pm and 7am
- Do not contact/communicate with named parties
- Do not attend named address
- Do not possess any weapons
- Next court date is January 28th



Charges: Assault with a weapon – Spousal, Mischief, FTC, S. 810 - fear

Released:

- Bail hearing on December 10th
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- No contact/communication with named party
- Do not attend within 10m of named party
- Non attendance where they live, work or go to school
- Do not attend named address
- Do not possess any weapons
- Next court date is January 7th

Charges: Possess sched I substance x 3 – Meth, Cocaine, Codeine
Possess property obtained by crime over \$5000

Released:

- Bail hearing on December 13th
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Report to the John Howard Society as directed
- Wear a GPS monitoring device and follow the program protocols
- Reside at named address
- Remain in residence daily b/w 11pm and 6am
- No weapons
- Next court date is January 13th

Charges: Criminal harassment, Harassing phone calls

Disposition:

- Court appearance on December 9th
- Guilty plea to Harassing phone calls
- Conditional discharge
- 24 months' Probation
- No contact/communication with named parties
- Do not attend anywhere they live, work, attend school
- No weapons



Charges: Theft under \$5000, FTC Probation

Disposition:

- Court appearance on December 10th
- Direct Accountability Program – DAP complete
- Charges withdrawn

Charge: Breach Probation

Disposition:

- Court appearance on December 10th
- No public interest – NPI
- Charge withdrawn



Charges: Assault – Spousal, Mischief - Domestic

Disposition:

- Court appearance on December 10th
- Guilty plea to Mischief under \$5000
- Conditional discharge, 12 months' Probation
- No contact/association, directly/indirectly with named party
- Do not attend any known place of residence, employment or education of the named party
- Do not possess any weapons
- \$305 restitution

Charges: Break out of place, FTC Probation

Disposition:

- Court appearance on December 10th
- Guilty plea to Break out of place
- Sentenced to 60 days jail (28 real days of PSC = 42 days of PSC)

Charges: FTC Probation x 6, Theft under, FTC undertaking

Disposition:

- Court appearance on December 10th
- Guilty pleas to Theft under, & FTC
- Sentenced to 15 days; time served
- Remaining charges were withdrawn a part of the resolution
