Charges: Assault with a weapon, Assault x 2

#### Released:

- Bail hearing on November 26<sup>th</sup>
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Do not contact/communicate in any way with named parties
- Do not attend any place they live, work, attend school
- Do not possess any weapons
- Next court date is January 14<sup>th</sup>



**Charges:** Assault x 2, B&E, FTC x 2, Mischief under, Trespass at night, Unlawfully in a dwelling, Utter threat

#### Released:

- Bail hearing on November 26<sup>th</sup>
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Do not contact/communicate in any way with named parties
- Do not attend anyplace they live, work, attend school
- Do not attend named addresses
- Do not possess any weapons or B&E instruments
- Next court date is December 4<sup>th</sup>

#### Released:

- Bail hearing on November 28<sup>th</sup>
- Released on a Form 11

- Wear a GPS monitor and follow the protocols
- Remain in residence daily b/w 10pm and 6am
- Do not be within 25m of or contact/communicate in any way with named parties
- Do not attend within 100m of any place the named parties live, work, attend school
- Do not attend St. Thomas
- Do not possess any weapons
- Do not apply for an authorization, licence or registration certificate for any weapons
- Do not occupy the driver's seat of a m/\u00ed
- Next court date is December 17<sup>th</sup>



Charge: FTC Probation

- Bail hearing on November 28<sup>th</sup>
- Released on a Form 11
- Promise to pay \$500 if FTC with the release order
- Report to the John Howard Society as directed
- Next court date is December 10<sup>th</sup>



Charges: Assault police x 2, Assault with a weapon, Mischief under \$5000, Breach Probation x 11

#### Released:

- Bail hearing on November 28<sup>th</sup>
- Promise to pay \$500 if FTC with the release order
- Report to the John Howard Society as directed
- Do not contact/communicate in any way with the named parties
- Do not attend anywhere the named parties live, work, attend school
- Do not attend 10 Princess Ave.
- No weapons. Next court date is December 3<sup>rd</sup>

- 18 months' Probation
- Several do not attend locations
- DNA, Weapons prohibition
- Currently in custody on outstanding charges



Charges: Criminal harassment, FTC release x 4

### Disposition:

- Court appearance on November 26<sup>th</sup>
- Charges withdrawn as part of a larger global resolution
  - Has numerous outstanding charges
- Being transferred to Elgin Therapeutic Court ETC
- Released on a Form 11, next court date is December 4<sup>th</sup>



Charges: Theft under, FTA court x 3 Disposition:

- Court appearance on November 26<sup>th</sup>
- Charges were withdrawn by the Crown
- No reasonable prosect of conviction NRPC
- Charges were 6 years old

Charges: Impaired Over 80 BAC, Use plate not authorized, Drive m/v fail to display both plates, Fail to surrender permit x 2, Improper tires, Improper brakes, Fail to display inspection sticker x 2, Fail to have insurance card

#### **Disposition:**

- Court appearance on November 26<sup>th</sup>
- Guilty plea to Over 80 BAC
- \$3900 fine
- 1 year driving prohibition
- Remaining charges were withdrawn



**Charges:** Theft under, Possession of Meth & Fentanyl **Disposition:** 

- Court appearance on November 26<sup>th</sup>
- Theft under and Possession of meth charges were withdrawn
- Possession of fentanyl was transferred to the Federal crown
- Has outstanding charges before the court
- Next court date is January 21<sup>st</sup>



Charge: Theft under \$5000 Disposition:

- Court appearance on November 26<sup>th</sup>
- Charge withdrawn by the Crown NRPC



**Charges:** Utter threat, FTC Probation x 5 **Disposition:** 

- Court appearance on November 26<sup>th</sup>
- Guilty pleas to; Utter threat & FTC Probation x 1
- Time served; 9 days PSC enhanced to 14 days
- Remaining charges were withdrawn

**Charges:** Possession for the purpose x 3 (Crystal meth, Cocaine, & Codeine), Possess proceeds of crime over \$5000

#### Disposition:

- Court appearance on November 27<sup>th</sup>
- Possess proceeds of crime over \$5000 withdrawn
- CDSA charges were transferred to the Federal Prosecutor



Charge: Assault Disposition:

- Court appearance on November 28<sup>th</sup>
- Entered into a 12 months' Common Law Peace Bond CLPB
- No contact/communication with named party
- Do not attend within 100m of any known place the named party is
- Assault charge was withdrawn as per the resolution



**Charges:** Impaired operation, Over 80 BAC **Disposition:** 

- Court appearance on November 29<sup>th</sup>
- Guilty plea to lesser offence of Careless driving
- \$1000 fine, 1 year POA Probation
- Do not operate a m/v with a BAC above zero
- Complete the Back on Track program, keep a copy of the probation order while operating a m/v



**Charges:** Assault – Spousal, S. 810 Peace Bond **Disposition:** 

- Court appearance on November 29<sup>th</sup>
- Entered into a 12 months' Peace Bond
- No contact/association, directly/indirectly with named party
- Do not attend at any known place of residence, employment or education of the named party
- Do not possess any weapons
- The Changing Ways program is to be successfully completed within the first 8 months
- Assault charge was withdrawn
