Charges: Assault with a weapon – Spousal, Mischief – Domestic,
Theft under \$5000, FTC Probation x 2

Disposition:

- Bail hearing on December 16th
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Report to the John Howard Society as directed
- Reside at named address
- Do not contact/communicate with named parties
- Do not attend named address
- Do not possess any weapons
- Next court date is January 21st



Charge: False fire alarm

Disposition:

- Bail hearing on December 18th
- Released on a Form 11
- Next court date is December 31st



Charges: Theft under \$5000 x 5

Released:

- Bail hearing on December 18th
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Do not contact/communicate with named parties
- Do not attend named locations
- Next court date is January 17th

Charges: Assault – spousal x3, Forcible confinement, FTC Undertaking x2 & FTC Release Order x3

Released:

- Bail hearing Dec 20th
- Released on Form 11
- Do not contact/communicate with named party
- Do not be within 100m of the named party
- Do not attend within 100m of named address
- Do not attend named location

Dispositions:



Charge: Sexual assault

Disposition:

- Found guilty of sexual assault after trial on July 18th
- 19.5 months (585 days) custody
- 24 months' Probation
- No contact with named party.
- DNA, Soira order, No weapons



Charges: Assault – Spousal x 3, Mischief under \$5000, Obstruct, FTC

Disposition:

- Court appearance on December 17th
- Guilty plea to assault
- Conditional discharge
- 18 months' Probation
- No contact/communication with named party
- DNA, No weapons

Charge: FTC recognizance

Disposition:

- Court appearance on December 17th
- Guilty plea
- Conditional discharge
- 12 months' Probation



Charges: FTC Probation x 2

Disposition:

- Charges withdrawn by the Crown
- No public interest – NPI



Charge: FTC release order

Disposition:

- Court appearance on December 17th
- Charge withdrawn – NPI



Charges: Assault BH, Mischief under \$5000 x 2, FTC Probation x 2, FTC

Disposition:

- Court appearance on December 17th
- Guilty pleas to FTC Probation x 2, Mischief under \$5000
- 90 days jail globally, deducting PSC leaving 25 days left to serve
- 12 months' Probation
- No contact/association, directly/indirectly, with named parties
- Do not attend any known place of the named parties
- Restitution \$305.95 payable to the City of St. Thomas
- \$500 payable to named party
- No weapons

Charges: Impaired operation, Obstruct police

Disposition:

- Court appearance on December 17th
- Guilty plea to Impaired operation
- \$1500 fine
- 1 year driving prohibition



Charges: Identity theft x 2, Theft under \$5000 x 5, Fraud under \$5000 x 2, Possess property obtained by crime under \$5000 x 4, FTC x 4, Assault BH, Assault, Obstruct police

Disposition:

- Court appearance on December 17th
- Guilty plea to; Identity theft x 2, Theft under \$5000 x 2, Obstruct
- 67 days of PSC - enhanced to 101 days – 1 day deemed served
- 18 months' Probation
- Do not associate with named parties
- Do not attend named locations
- Do not possess any identification, financial documents, etc. unless lawfully issued in name
- Remaining charges were withdrawn as part of the resolution
