**Charges:** FTC Release Order x2, Breach Probation x6, Theft under, Enter premises when entry prohibited, Assault with a weapon, Possession of a prohibited device

**Released:**

- Bail hearing on December 27<sup>th</sup>
- Released on a Form 11
- Promise to pay \$250 if fails to abide by conditions of this release
- Do not contact/ communicate with named party
- Do not attend where they live, work or go to school
- Do not attend named location
- Report to John Howard as directed
- Next court date is January 14<sup>th</sup>



**Charges:** Assault with a weapon, Breach Probation x 2

**Released:**

- Bail hearing on December 28<sup>th</sup>
- Released on a Form 11 – Promise to pay \$250 if FTC
- Do not contact/communicate with named party
- Do not attend within 25m of any place the named party lives, works, attends school
- Do not possess any weapons
- Next court date is January 21<sup>st</sup>

- Promise to pay \$500 if FTC with the release order

- Do not attend within 50m of named address
- Do not possess any weapons
- Next court date is January 14<sup>th</sup>

- Do not contact/communicate in any way with named parties
- Do not attend named addresses
- Do not possess any B&E instruments
- Next court date is January 28<sup>th</sup>



**Charges:** Possess property by crime under \$5000, FTC Probation x 3,  
Theft under \$5000 x 2, Assault
