Charges: Theft under \$5000, Breach Probation x 2

Released:

- Bail hearing on January 12th
- Released on a Form 11
- Promise to pay \$200 if FTC with the release order
- Next court date is January 21st

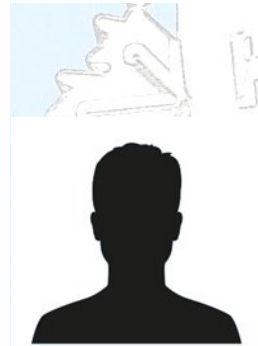
Dispositions:



Charges: Assault police x 2, Resist police, Assault

Disposition:

- Court appearance on January 13th
- Entered into a 24 months' Peace Bond on the assault charge
- No contact/communication in any way with named party
- Remaining charges moved into Elgin Therapeutic Court
- Next court date is February 26th



Charge: Over 80 BAC

Disposition:

- Court appearance on January 14th
- Guilty plea
- \$1500 fine
- 1 year driving prohibition

Charges: Theft under \$5000 x 2, Robbery, Possess property by crime

Disposition:

- Court appearance on January 14th
- Direct Accountability Program completed for theft charges x 2
- Guilty plea to lesser offence of Theft under from the initial Robbery
- Conditional discharge 12 months' Probation
- Complete 40 hours community service
- No contact/communication with the victim
- Do not attend any place the victim lives, works, attends school
- Do not to possess any weapons

Disposition:

- Court appearance on January 14th
- DAP completed
- Charges withdrawn



Charges: Theft under \$5000, Mischief under \$5000

Disposition:

- Court appearance on January 14th
- DAP completed
- Charges withdrawn
- Has outstanding charges before the court

Charges: STPS - FTC Probation
APS - FTC Probation

Disposition:

- Court appearance on January 14th
- Guilty plea x 2
- 10 days of PSC, time served
- Remains in custody on outstanding charges



Charges: STPS - Mischief, FTC release order
OPP- Possess property obtained by crime, Possess B&E tools

Disposition:

- Court appearance on January 14th
- Guilty plea to mischief
- 20 days of PSC
- Guilty plea to Possess property obtained by crime
- 40 days of PSC applied for a 60 days jail sentence
- 12 months' Probation; do not attend named location
- Was arrested on outstanding warrants from York and Peel and released on a Form 10 with a future court date



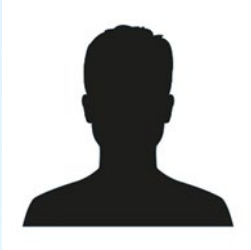
Charges: Theft under \$5000 x 3, FTC Probation

Disposition:

- Court appearance on January 14th
- Guilty plea to theft under \$5000 x 3
- Conditional discharge
- 12 months' Probation
- Do not attend named locations

Charges: Sexual interference, Sexual assault

Disposition:

- Sentenced on January 15th
- Convicted of the sexual interference
- 2 years' Probation
- No contact/communication in any way with named party
- Do not attend their home, work, or school
- Do not communicate with anyone under the age of 10 unless in the presence of an adult over the age of 21
- Complete 144 hours of community service
- No weapons & DNA order
- Assault charge stayed by the Crown



Charges: Fraud over \$5000, Theft over \$5000, + other Ontario charges

Disposition:

- Global resolution of charges involving multiple police agencies
- Sentenced to 8 years
- 4.5 years left to serve, 1296 days PSC
- DNA
