- Do not possess any firearms
- Next court date is February 5th

- Guilty plea to lesser offence of Careless driving
- \$1000 fine
- 12 months POA Probation
- During the entire probation period, BAC of zero at all times while driving
- Remedial driving program
- Carry a copy of the probation order with driver's license at all times and surrender it to any police officer who asks for it



Charge: Assault BH

Disposition:

- Court appearance on January 24th
- Charge withdrawn
- No reasonable prospect of conviction – NRPC
