Released:

- Bail hearing on January 7th
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Reside with sureties
- Wear a GPS monitor and follow the program protocols
- Remain in residence or within 200m - 24 hours a day
- Numerous non associations/communications/do not attend locations
- Do not possess any cellphone, pager **except** with sureties
- Do not possess or use any computer that has access to the internet
- Do not possess any type of bank document, card or ID unless its theirs
- Next court date is January 14th



Charge: Voyeurism

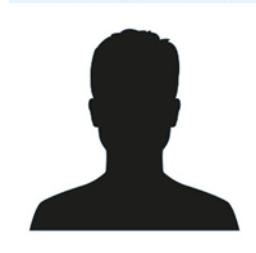
Released:

- Released on a Form 11 on January 9th
- Promise to pay \$1000 if FTC with the release order
- Reside with surety
- Do not contact/communicate by any means with named party
- Do not attend the named address
- Do not attend any store with a change room/fitting room **except** in the direct presence of surety
- Do not possess a cellphone, pager, etc.
- Next court date is January 28th

Dispositions:



Charges: Theft under \$5000, Resist police, FTC Probation x 4

Disposition:

- Court appearance on January 7th
- Guilty plea to theft under \$5000, Resist police
- Time served, 30 days (20 days PSC) - 6 months' Probation
- Curfew from 9:30pm – 7:00am
- Remaining charges were withdrawn
- Arrested on new charges Jan 8th & remanded, next court date Jan 13th



Charges: Theft under \$5000 x 2

Disposition:

Charges: Assault & Mischief – Domestic

Disposition:

- Court appearance on January 8th
- Guilty pleas to both charges
- YCJA Conditional discharge – No Probation
- Reside as directed, Remain in school/employment
- No contact with named party & Non-attendance at any known place of residence, employment or education of the named party
- \$268.00 restitution to the victim
- No weapons



Charges: STPS – Mischief under \$5000 x 3, Fraud under \$5000, FTC
Theft under \$5000, Possess property under \$5000

OPP - Theft under \$5000

Disposition:

- Court appearance on January 8th
- Guilty pleas; Theft under \$5000 x 2, Mischief under \$5000 x 2
- 24 months' Probation
- Do not attend at all named addresses
- No contact with named parties
- Non-attendance at any known place of residence, employment or education of the named parties
- 30 hours of community service
- No weapons

Charge: Use stolen credit card

Disposition:

- Court appearance on January 8th
- Elgin Therapeutic Court (ETC) completed
- No guilty plea for triable issues
- Charge stayed by the Crown



Charge: Disqualified driving

Disposition:

- Video court appearance on January 9th from EMDC
- Charge withdrawn by the Crown
- Charges 5 years old
- Has outstanding STPS POA charges before the court



Charges: Over 80 BAC, Careless driving

Disposition:

- Court appearance on January 10th
- Guilty plea to Careless driving
- 12 months' POA Probation, \$1000 fine
- Must have a zero BAC while operating a m/v during Probation period
- Carry a copy of Probation order while operating a m/v and surrender it to police if driver's licence is requested
- Over 80 BAC withdrawn

Charge: Assault BH – Choking

Disposition:

- Court appearance on January 10th
- Entered into a 12 months' Peace Bond
- No contact/association, directly/indirectly with named party
- Do not attend at any known place of residence, employment or education of the named party
- Not to possess any weapons
- Complete Changing Ways



Charge: Utter threat – BH

Disposition:

- Court appearance on January 10th
- Entered into a 12 months' Peace Bond
- No contact/communication in any way with named party
- Do not attend the named party's residence
- No weapons, Charge withdrawn



Charges: Assault – Spousal, Mischief - Domestic

Disposition:

- Court appearance on January 10th
- Entered into a 12 months' Peace Bond
- No contact/communication with named party
- Do not attend any known place of the named party
- Charges withdrawn as per the Peace Bond

Charges: Assault with a weapon – Spousal, Mischief under \$5000, FTC

Disposition:

- Court appearance on January 10th
- Entered into a 12 months' Peace Bond
- No contact/communication with named party
- Do not attend any known location of the named party
- No weapons
- Complete Changing Ways
- Charges withdrawn as per the Peace Bond
