**Form 11 Releases:**



**Charges:** Assault police, Assault, FTC

**Released:**

- Bail hearing on February 8<sup>th</sup> - arrested on a bench warrant
- Released on a Form 11, promise to pay \$250 if FTC
- Report to the John Howard Society as directed
- Next court date is February 18<sup>th</sup>



**Charge:** Impaired operation

**Released:**

- Bail hearing on February 9<sup>th</sup> arrested on a bench warrant
- Released on a Form 11
- Promise to pay \$200 if FTC with the release order
- Next court date is February 18<sup>th</sup>



**Charges:** Mischief, Breach Probation, FTC release x 3

**Released:**

- Bail hearing on February 11<sup>th</sup>
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Reside named address
- Do not contact/communicate in any way with named parties
- Do not attend named address
- Do not possess any weapons
- Next court date is February 25<sup>th</sup>

**Released:**

- Bail hearing on February 11<sup>th</sup>
- Released on a Form 11
- Report to the John Howard Society as directed
- Do not contact/communicate in any way with named parties
- Do not attend at named locations
- Next court date is February 19<sup>th</sup>



**Charges:** Dangerous operation, FTC Probation

**Released:**

- Bail hearing on February 12<sup>th</sup>
- Promise to pay \$500 if FTC with the release order
- Report to the John Howard Society as directed
- Do not occupy the driver's seat or have care & control of a m/v
- Next court date is March 4<sup>th</sup>



**Charges:** Assault – Spousal, Assault, Mischief, Utter death threat

**Released:**

- Bail hearing on February 12<sup>th</sup>
- Released on a Form 11, promise to pay \$1000 if FTC
- Reside at named address
- Do not contact/communicate in any way with named parties
- Do not attend their home, work, school
- Do not possess any weapons
- Next court date is March 4<sup>th</sup>



**Charge:** Assault

**Released:**

- Bail hearing on February 13<sup>th</sup>
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Do not contact/communicate in any way with named parties
- Do not attend any place they live, work, attend school
- Do not possess any weapons
- Next court date is March 11<sup>th</sup>

**Charges:** Assault with a weapon, Utter death threat, Pointing firearm,  
Possess weapon for dangerous purpose

**Released:**

- Bail hearing on February 14<sup>th</sup>
- Released on a Form 11, Promise to pay \$1000 if FTC
- Wear a GPS monitor and follow the program protocols
- Reside at named address
- Remain in the residence daily b/w 11pm & 7am
- Do not contact/communicate in any way with the named parties
- Do not be within 100m of where they live, work, attend school
- Do not possess any weapons
- Next court date is March 11<sup>th</sup>

**Dispositions:**



**Charges:** Theft under x 2, Assault, Robbery with violence, Obstruct police,  
FTC Probation x 5, FTC undertaking

**Disposition:**

- Court appearance on February 11<sup>th</sup>
- Guilty pleas to; lesser offence of Theft under from the robbery charge,  
Theft under, Assault, & FTC
- 56 days of pre-plea custody; = 84 days of jail
- 12 months' Probation
- Do not attend the named locations
- No contact/communication with the named parties
- Do not possess any weapons



**Charges:** Impaired operation, Over 80 BAC

**Disposition:**

- Court appearance on February 11<sup>th</sup>
- Guilty plea to Over 80 BAC
- \$2500 fine
- 1 year driving prohibition

**Charges:** Theft under x 2, FTC x 2

**Disposition:**

- Court appearance on February 11<sup>th</sup>
- Guilty pleas to Theft under, and FTC
- Suspended sentence, plus 12 months' Probation
- Do not attend within 100m the named location
- 60 hours of community service



**Charges:** FTC Probation x 2, FTC

**Disposition:**

- Court appearance on February 11<sup>th</sup>
- Guilty plea to FTC Probation
- Suspended sentence, plus 12 months' Probation
- Usual conditions plus 60 hours of community service
- All remaining charges were withdrawn



**Charges:** Utter threats BH, Possess weapon for dangerous purpose,  
Assault with a weapon

**Disposition:**

- Court appearance on February 11<sup>th</sup>
- All charges withdrawn by the Crown
- Not in the public interest – NPI



**Charge:** Breach Probation

**Disposition:**

- Court appearance on February 11<sup>th</sup>
- Charge withdrawn – No reasonable prospect of conviction

**Charges:** FTC Probation x 8, Theft under x 2, Assault with a weapon,  
Possess a prohibited device

**Disposition:**

- Court appearance on February 11<sup>th</sup>
- Guilty pleas; Assault with a weapon, Theft under x 2, FTC Probation x 3
- Time served; Sentenced to 30 days, 20 days PSC enhanced
- Probation, DNA & Weapons prohibition



**Charges:** Possession of schedule I substance – Dilaudid, Obstruct police,  
Enter premises when entry prohibited – TPA

**Disposition:**

- Court appearance on February 11<sup>th</sup>
- Charges relating to this occurrence were withdrawn
- Was released from custody on a Form 11
- Next court date is February 25<sup>th</sup>



**Charges:** Possess schedule I substance – Meth, Possess proceeds of  
Property obtained by crime under \$5000

**Disposition:**

- Court appearance on February 11<sup>th</sup>
- Guilty plea to Possession of meth
- 9 months Conditional sentence order – 22 conditions total
- Reside & remain inside named address
- Do not possess any weapons
- No contact/communication with named party
- Do not possess any drugs or drug trafficking paraphernalia
