Charges: Assault with a weapon, Possess weapon for dangerous purpose, Breach Probation x 2

Released:

- Bail hearing on February 19th
- Released on a Form 11, promise to pay \$500 if FTC
- Do not contact/communicate in any way with named parties
- Do not attend their home, work, or school
- Do not possess any weapons
- Next court date is March 4th



Charges: B&E, Theft under, FTC Probation x 3, Utter threats, Possess meth

Released:

Released:

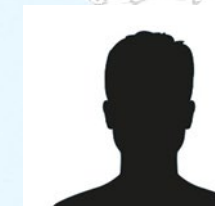
- Bail hearing on February 20th

- Released on a Form 11, promise to pay \$2000 if FTC
- Reside at named address
- Do not contact/communicate in any way with named parties
- Do not attend the City of St. Thomas
- Do not possess any weapons
- Next court date is March 25th

- 30 days of PSC applied - equivalent of 45 days jail
- 12 months' Probation
- Do not attend named address
- No contact/communication named parties
- Do not possess any weapons

- Guilty plea to lesser offence of assault
- Conditional discharge
- 18 months' Probation
- No contact with named party
- Do not attend at any place they lives, work or go to school
- Do not possess any weapons

Charges: OPP - Assault, FTC
STPS - Assault, Assault with a weapon

Disposition:

- Court appearance on February 18th
- Entered into a 12 months; Common Law Peace Bond
- Keep the peace and be of good behaviour especially towards named parties
- No contact with named party
- Non-attendance at any known place of residence, employment or education of the named party
- Do not possess any weapons



Charges: Assault, Mischief under, Theft under

Disposition:

- Court appearance on February 18th
- Charges withdrawn by the Crown
- Not in the public interest – NPI



Charges: Prohibited operation, Drive without proper headlights – m/v HTA

Disposition:

- Court appearance on February 18th
- Guilty plea to lesser offence, Suspend drive – HTA
- \$1000 fine
- Remaining charges were withdrawn



Charge: Theft under

Disposition:

- Court appearance on February 18th
- Direct Accountability Program – DAP completed
- Charge withdrawn

- Do not be within 20m of where they live, work, attend school
- Do not possess any weapons
- Remains in custody on outstanding charges

Charges: Assault BH, Assault

Disposition:

- Court appearance on February 19th
- Guilty plea to Assault
- 18 months' Probation
- No contact with named parties
- Do not attend within 100m of any known place of the named parties
- Do not attend within 25m of the named parties
- No weapons



Charges: Sexual interference, Sexual assault on a person under 16 years

Disposition:

- Court appearance on February 19th
- Guilty plea to lesser offence of Assault
- 2 years' Probation
- No contact/communication with the named parties
- No weapons
- Remaining charges were withdrawn as part of the resolution



Charge: Assault

Disposition:

- Court appearance on February 19th
- Entered into a 12 months' CLPB
- No association with named parties
- Do not be within 25m of the named parties
- No weapons
- Charge withdrawn



Charges: Theft of credit card x 5, Fraud under x 2, Theft under,
Possess property obtained by crime under

Disposition:

- Court appearance on February 20th
- Guilty plea to Theft under \$5000
- 1 day deemed served - 2 days PSC
- 12 months' Probation
- Do not attend named location
- Do not possess any ID/Cheques/Debit unless lawfully issued
- All remaining charges were withdrawn

Charges: Sexual assault, Mischief, Assault, Resist arrest

Disposition:

- Court appearance on February 20th
- Guilty pleas to Assault, and Resist arrest
- Suspended sentence, 12 months' Probation
- No contact with named parties
- Non-attendance within 100m of any known place of the named parties
- DNA sample, s.110 weapons' prohibition



Charges: Assault – Spousal, FTC x 2

Disposition:

- Court appearance on February 21st for scheduled trial
- Entered into a 12 months' CLPB
- No contact/communication in any way with named party
- Do not attend their home, work, or school
- Charges withdrawn as per the CLPB - No weapons



Charge: Impaired operation

Disposition:

- Court appearance on February 21st
- Guilty plea to lesser offence of Careless driving - HTA
- 12 months' Probation, \$1000 fine
- Have a zero BAC at all times while driving
- Has exceptions while operating a m/v during probation period
- Must provide police probation order with driver's licence when requested
- Impaired charge was withdrawn
