**Charges:** Possess dangerous weapon, Cause a disturbance  
**Released:**

- Bail hearing on February 2<sup>nd</sup>
- Released on a Form 11
- Do not attend the named location
- Do not possess any weapons
- Next court date is March 4<sup>th</sup>



**Charges:** Assault – Spousal, FTC Probation x 2, FTC x 2  
**Released:**

- Bail hearing on February 4<sup>th</sup>
- Released on a Form 11
- Promise to pay \$1000 if FTC with the release order
- Report to the John Howard Society as directed
- Do not contact/associate with named party
- Do not possess any weapons
- Next court date is February 25<sup>th</sup>

**Disposition:**

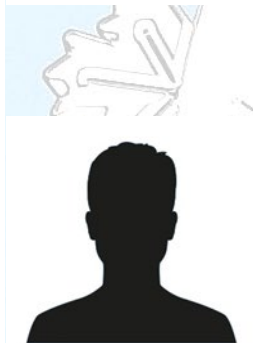
- Court appearance on February 3<sup>rd</sup>

**Disposition:**

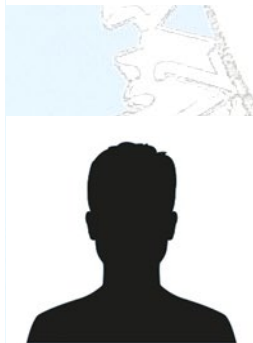
- Court appearance on February 3<sup>rd</sup>

- 12 months' Common Law Peace Bond - CLPB
- No contact/communication with named party
- Do not attend named address
- Charges withdrawn
