**Form 11 Releases:**



**Charges:** FTC x 3, Breach Probation

**Disposition:**

- Bail hearing on January 26<sup>th</sup>
- Released on a Form 11, promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- No contact/communication in any way with named party
- Do not attend within 25m of the named parties home, work or school
- Next court date is February 25<sup>th</sup>



**Charges:** Assault x 2

**Disposition:**

- Bail hearing on January 27<sup>th</sup>
- Released on a Form 11, promise to pay \$1000 if FTC
- Reside at named address
- Do not contact/communicate in any way with named party
- Do not be within 100m of anywhere they live, work or go to school
- Do not attend named address
- No contact with additional named parties
- No weapons
- Next court date is February 11<sup>th</sup>



**Charges:** FTC Probation x 2

**Released:**

- Bail hearing on January 29<sup>th</sup>
- Released on a Form 11
- Promise to pay \$200 if FTC with the release order
- Report to the John Howard Society as directed
- Next court date is February 4<sup>th</sup>

**Charges:** Assault - Choke

**Released:**

- Bail hearing on January 30<sup>th</sup>
- Released on a Form 11, promise to pay \$500 if FTC
- Reside at named address
- Do not contact/communicate in any way with named party
- Do not attend anywhere they live, work or attend school
- Do not possess any weapons
- Next court date is February 18<sup>th</sup>

**Dispositions:**



**Charge:** Assault

**Disposition:**

- Court appearance on January 28<sup>th</sup>
- Entered into a s. 810 Peace Bond for 12 months
- No contact/communication/attendance with named party
- Usual conditions
- No weapons



**Charge:** Utter threat - BH

**Disposition:**

- Court appearance on January 28<sup>th</sup>
- Entered into a 12 months' CLPB
- Do not attend within 25m of named party
- Do not contact or communicate with named party
- Do not attend at any place they live, work or attend school
- Do not attend within 100m of named address
- Do not possess any weapons

**Charges:** Impaired operation, Over 80 BAC

**Disposition:**

- Court appearance on January 28<sup>th</sup>
- Guilty plea to over 80 BAC
- 30 days jail
- 12 months' Probation
- 2 year driving prohibition



**Charge:** Mischief

**Disposition:**

- Court appearance on January 28<sup>th</sup>
- Guilty plea
- Conditional discharge - 12 months' Probation
- Do not attend within 10m of named business
- Restitution in the amount of \$517.40 to the named business



**Charges:** Possession for the purpose of trafficking x 6, Unauthorized possession of a firearm, Unauthorized possession of a firearm knowing it's unauthorized, Occupant of m/v knowing there is a prohibited weapon, Careless storage of a prohibited weapon

**Disposition:**

- Court appearance on January 28<sup>th</sup>
- All charges stayed by the Crown
- Co-accused charges are live before the court



**Charges:** Criminal harassment, FTC

**Disposition:**

- Court appearance on January 28<sup>th</sup>
- Entered into a 12 months' Peace Bond
- Charges withdrawn
- No contact/association named party
- Do not attend within 200m of their home, work, school
- Do not possess any weapons

**Charges:** Criminal harassment, Harassing phone calls, Utter threats BH, FTC

**Disposition:**

- Court appearance on January 28<sup>th</sup>
- Guilty pleas to criminal harassment, & FTC
- Four months conditional sentence
- No drugs or alcohol
- Wear a GPS monitor and follow the program protocols
- 24 months' Probation
- No contact with the named parties
- Do not attend any place where they reside, work or go to school
- No weapons, DNA sample



**Charge:** Theft under \$5000

**Disposition:**

- Court appearance on January 28<sup>th</sup>
- Direct Accountability Program – DAP completed
- Has outstanding matters before the court



**Charge:** FTC

**Disposition:**

- Court appearance on January 28<sup>th</sup>
- Charge withdrawn as part of global resolution w/LPS charges

- Do not attend any place they may be
- Attend and complete changing ways program
