Charges: Obstruct police, FTC release order

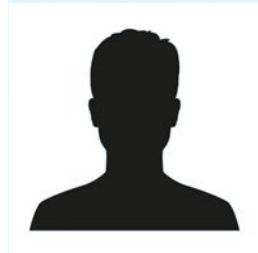

Disposition:

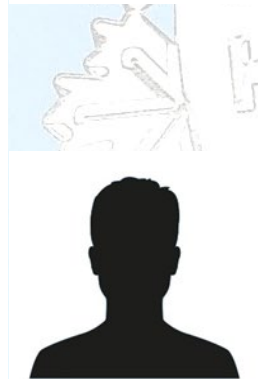
- Court appearance on February 25th

- Has outstanding charges before the court



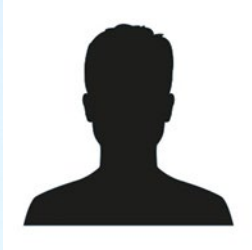
Charges: Theft under \$5000, Possess property obtained by crime under

- Charges withdrawn by the Crown



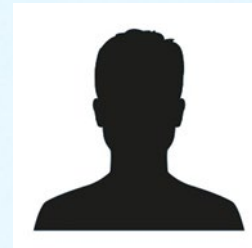

Disposition:

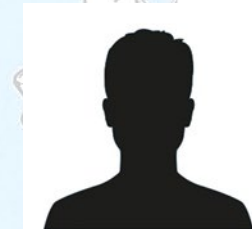
- Court appearance on February 25th

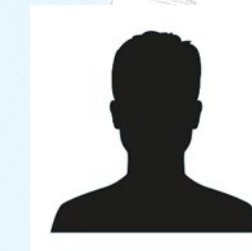
