**Released:**

- Bail hearing on March 2<sup>nd</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not operate or have care or control of any conveyance
- Next court date is March 31<sup>st</sup>



**Charges:** Drive while prohibited x 2, Obstruct police

**Released:**

- Bail hearing on March 3<sup>rd</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Next court date is March 25<sup>th</sup>



**Charges:** Utter threats, FTC Probation x 4, Theft under, Mischief under

- Released on previous STPS OIC Undertaking
- No contact/communication at all with named party
- Do not be within 20m the named party

**Released:**

- Released on a Form 11; Promise to pay \$5000 if FTC
- Do not contact/communicate in any way with named parties
- Don't attend their home, work, or school
- Do not attend at named location
- Remain in the province of Ontario
- Do not possess any ID or bank issued card/document
- Next court date is May 27<sup>th</sup>



**Charges:** Mischief under \$5000, Possess sched III substance, Assault,  
Forcible confinement, Unauthorized possession of a weapon

**Released:**

- Bail hearing on March 5<sup>th</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- Do not contact/communicate direct/indirect with named party
- Don't attend their home, work, school
- Do not be within 25m of the named party
- Do not possess any weapons
- Next court date is April 1<sup>st</sup>



**Charges:** Sexual assault, Assault x 3, FTC undertaking x 2, FTC release x 4,  
Criminal harassment

**Released:**

- Bail hearing on March 5<sup>th</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- No contact/communication with named party
- Do not be within 100m of their home, work, school
- Do not attend within 100m the named address
- Do not possess any weapons
- Do not have care and control of a m/v unless with surety
- Next court date is April 2<sup>nd</sup>

**Charge:** FTC Probation

**Released:**

- Released on a Form 11

**Charges:** Trafficking in stolen goods under \$5000, FTC

**Released:**

- Bail hearing on March 6<sup>th</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- Reside at named address
- Notify STPS OIC within 24 hours of any address change
- Next court date is April 1<sup>st</sup>



**Charges:** Utter death threat x 2, Obstruct police, Assault, FTC, Breach Probation

**Released:**

- Bail hearing on March 7<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Wear a GPS monitor and follow the protocols of the program
- Do not contact/communicate in any way with named parties
- Do not attend their home, work, or school
- Do not be within 50m of named location
- Do not possess any weapons
- Next court date is April 1<sup>st</sup>

**Charges:** Utter death threat x 2, Assault x 3, Public mischief, FTC

**Disposition:**

- Bail hearing on March 7<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Do not contact/communicate in any way with named party
- Do not attend within 100m of named address
- Do not possess any weapons
- Next court date is March 11<sup>th</sup>



**Charges:** Sexual assault, Possess sched I substance, FTC, Breach Probation

**Released:**

- Bail hearing on March 7<sup>th</sup>
- Bail set, not met pending GPS installation
- Released on a Form 11; Promise to pay \$1000 if FTC
- Reside at named address
- Remain inside at all time with **exceptions**
- Do not contact/communicate, direct/indirect with named parties
- Do not attend within 100m the named addresses
- Do not possess any weapons
- Do not possess any tools suitable for B&E
- Do not possess any banking ID (debit/credit cards, cheques)
- Follow the rules and protocols of the GPS program
- Next court date is March 20<sup>th</sup>

**Charges:** Possess property obtained by crime under \$5000, FTC,  
FTC Probation x 3, Theft under x 3, Assault

**Disposition:**

- Court appearance on March 4<sup>th</sup>
- Guilty pleas; Theft under x 2, Assault
- Jail - 48 days enhanced to 72 days, 12 months' Probation
- No contact/association, directly/indirectly with the named parties
- Don't attend their home, work, or school
- Do not attend named locations
- Remaining charges were withdrawn as per the global resolution



**Charges:** Assault, Assault with a weapon, Theft under, Breach Probation x 2

**Disposition:**

- Court appearance on March 4<sup>th</sup>
- Entered into a 12 month Common Law Peace Bond – CLPB
- No contact/association, directly or indirectly with named party
- Do not attend any known place they live, work or attend school
- Do not possess any weapons
- All charges were withdrawn as per the CLPB



**Charges:** Theft under \$5000, FTC Probation

**Disposition:**

- Court appearance on March 4<sup>th</sup>
- Charges withdrawn – No public interest
- Was released on a Form 11 regarding on outstanding charge

**Disposition:**

- Court appearance on March 4<sup>th</sup>
- Guilty plea to Over 80 BAC
- 30 days jail - intermittent sentence
- 2 years' driving prohibition



**Charges:** Assault x 2

**Disposition:**

- Court appearance on March 4<sup>th</sup>
- Guilty plea x 2
- Conditional discharge, 12 month Probation
- No contact/association, directly/indirectly with named parties
- Do not attend at any known home, work or school the named parties
- Do not possess any weapons



**Charges:** Impaired operation, FTC Probation

Drive m/v with cannabis readily available – CCAO

**Disposition:**

- Court appearance on March 4<sup>th</sup>
- Guilty plea to Impaired operation
- Jail sentence - 2 days enhanced to 3 days
- 12 months Probation, 1 year driving prohibition
- Remaining two charges were withdrawn as per the plea agreement
- Released from custody on a Form 11 from outstanding charges



**Charge:** Theft under \$5000

**Disposition:**

- Court appearance on March 3<sup>rd</sup>
- Guilty plea to theft under
- Suspended sentence, 12 months' Probation
- No contact/communication with named party
- Do not attend named address

**Charges:** Assault with a weapon, Administer noxious substance,  
Unauthorized possession of a weapon

**Disposition:**

- Court appearance on March 5<sup>th</sup>
- Guilty plea to Unauthorized possession of a weapon
- YCJA – Conditional discharge
- 12 months - No contact with named parties
- Do not attend within 100m of their home, work, school
- Do not possess any weapons
- Remaining charges were withdrawn as per the resolution



**Charge:** B&E

**Disposition:**

- Court appearance on March 5<sup>th</sup>
- Guilty plea to B&E
- 18 months' Probation - DNA sample
- Do not associate with named party
- Do not be within 25m named location



**Charges:** Assault police, Utter threat – BH, Utter death threats

**Disposition:**

- Court appearance on March 5<sup>th</sup>
- Guilty plea to utter threats - BH
- 18 months' Probation
- Do not contact/communicate, direct/indirect with named parties
- Do not attend anywhere they live, work, attend school
- Do not possess any weapons & DNA sample



**Charges:** Assault, Obstruct, Theft under, FTC release

**Disposition:**

- Court appearance on March 6<sup>th</sup>
- Guilty plea to assault, remaining charges were withdrawn
- Time served, 20 days' PPC enhanced to 30 days
- 12 months' Probation
- No contact/communication with name party
- Do not attend her home, work, or school
- No weapons & DNA sample
