Charges: Assault BH, Assault x 2, Utter death threat, FTC Probation x 3, FTC x 2
Released:

- Bail hearing on April 15th
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not contact/communicate in any way with named parties
- Do not attend their home, work, or school
- Do not possess any weapons
- Next court date is April 24th

Charge: Sexual assault

Disposition:

- Court appearance on April 14th
- Charge withdrawn as per the Common Law Peace Bond
- 3 years' CLPB
- No contact/communication with named parties
- Do not attend their home, work, school
- No weapons

Charges: Identity theft x 9, Possess property by crime under \$5000 x 13, Forgery x 5, Use, deals forged document x 3, False pretences x 3, Possess schedule I substance x 2, FTC x 4, FTC Probation x 2, Fraud under x 5, Fraud over x 2, Possess forged document x 2, Personation with intent

Disposition:

- Court appearance on April 14th
- Guilty pleas to Fraud over \$5000 & FTC release order
- Sentenced to 1 day deemed served; 173 days PSC enhanced to 260
- Guilty pleas to Identity theft, Forgery x 2, Fraud under x 2, Personation, Possess forged document
- 24 months' Community Service Order
- Reside and remain at named address
- Wear a GPS monitor and follow the program protocols
- Do not purchase, possess, or consume alcohol or cannabis
- Present at the door for compliance checks
- No contacts/communications, do not attend locations
- Do not possess any banking doc/cards unless lawfully issued
- Perform 100 hours of community service
- Do not possess any weapons



Charge: Possess schedule I substance - Meth

Disposition:

- Court appearance on April 14th
- Charge withdrawn by the Federal Crown – No public interest
- Has numerous live charges before the court
- Next court date is April 22nd



Charge: Possess schedule I substance - Psilocybin

Disposition:

- Court appearance on April 14th
- Charge withdrawn by the Federal Crown – NPI
- Has numerous live charges before the court
- Was remanded into custody for a bail hearing on April 22nd

Charges: Possess property under \$5000 x 2, Theft under, Mischief under, FTC Probation

Disposition:

- Court appearance on April 15th
- Guilty pleas to Mischief under & Theft under
- Jail sentence, 1 day deemed served – 20 days PSC enhanced to 30
- Remaining charges were withdrawn as per the resolution



Charges: Assault, Mischief

Disposition:

- Court appearance on April 15th
- Charges stayed by the Crown
- Mental Health Diversion completed



Charges: Assault with a weapon, Assault, Carry concealed weapon, Utter death threat, FTC Undertaking

Disposition:

- Court appearance on April 15th
- All charges were stayed by the Crown



Charges: FTC Probation x 4

Disposition:

- Guilty pleas to FTC Probation x 2
- 1 day deemed served; 10 days PSC enhanced to 15 days
- Remaining charges were withdrawn as per the resolution

Charges: Assault x 2, Mischief under, FTC

Disposition:

- Court appearance on April 15th
- Guilty pleas to Assault & FTC
- 1 day deemed served - 40 days of PSC enhanced to 60 days
- 12 months' Probation
- No contact with named party
- Non-attendance at any known place of residence, employment or education of the named party
- No weapons
- Remains in custody on outstanding charges



Charges: Mischief under \$5000

Disposition:

- Court appearance on April 15th
- Charge withdrawn by the Crown
- No reasonable prospect of conviction



Charges: FTC Probation x 2

Disposition:

- Court appearance on April 15th
- Guilty pleas x 2
- 1 day deemed served; 11 days PSC enhanced to 16 days



Charge: Unlawfully in a dwelling

Disposition:

- Court appearance on April 15th
- Guilty plea
- Conditional discharge
- 12 months' Probation
- Do not attend named addresses



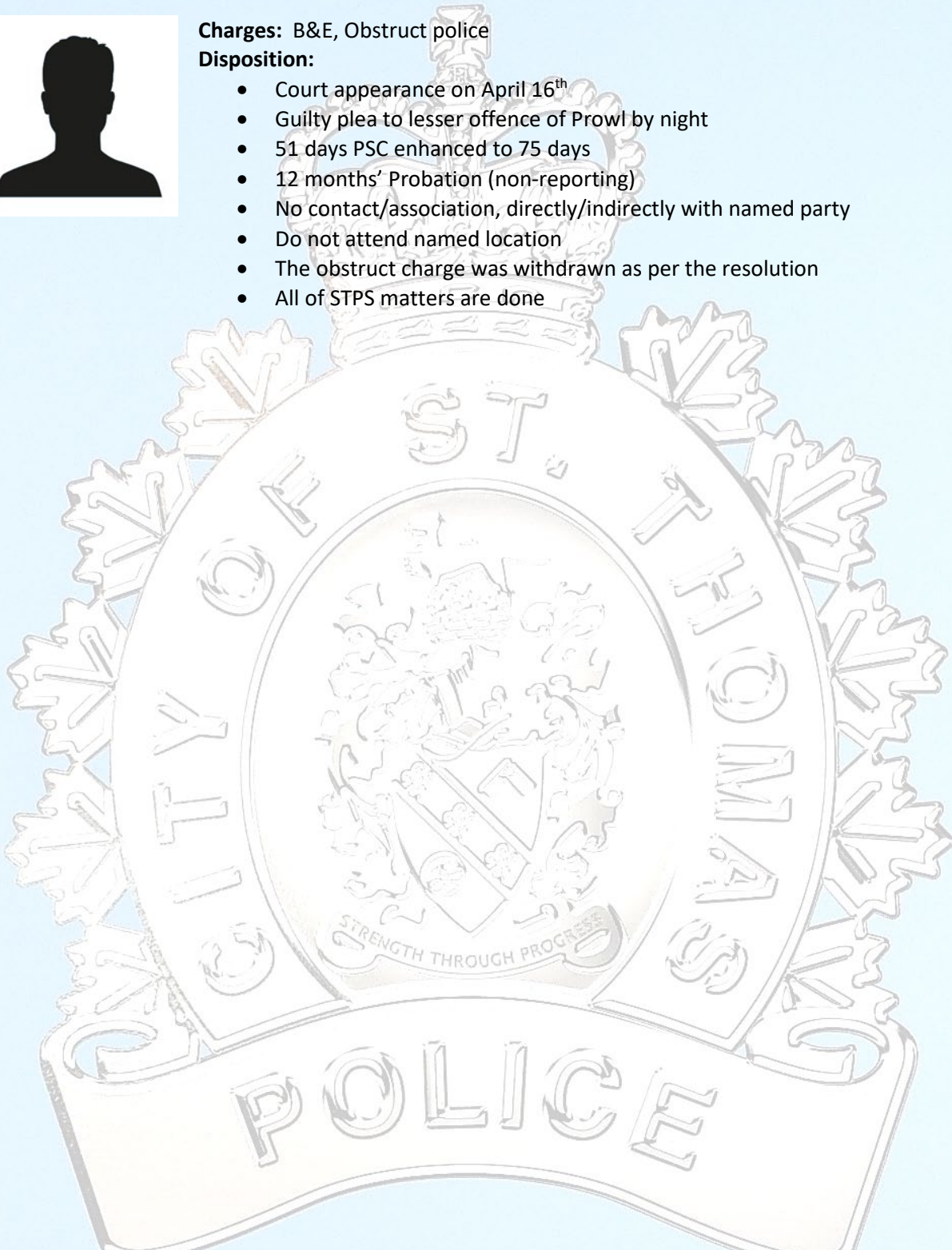

Charges: B&E, Obstruct police

Disposition:

- Court appearance on April 16th
- Guilty plea to lesser offence of Prowl by night
- 51 days PSC enhanced to 75 days
- 12 months' Probation (non-reporting)
- No contact/association, directly/indirectly with named party
- Do not attend named location
- The obstruct charge was withdrawn as per the resolution
- All of STPS matters are done
