

### St. Thomas Police Service – Court Dispositions

#### Form 11 Releases:

**Charges:** Resist arrest, FTC x 2, Breach Probation x 3 **Disposition:** 

- Bail hearing on April 18<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not contact/communicate with named party
- Don't attend their home, work, school
  - Next court date is May 20<sup>th</sup>

Charges: Use, deals, acts on forged documents x 6 Disposition:

- Bail hearing on April 22<sup>nd</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not possess any ID, bank card, document unless lawfully issued
- Do not attend the named locations
- Next court date is May 27<sup>th</sup>

#### Charges: APS - Assault, Utter threat - BH, Theft under \$5000, FTC STPS - FTC

#### Released:

- Bail hearing on April 22<sup>nd</sup>
- Released on a Form 11
- Report to the John Howard Society as directed
- Do no contact/communicate in any way with named party
- Don't attend the named locations
- Do not possess any weapons
- Next court date is May 6<sup>th</sup>



Charges: Assault – BH, Assault, Utter death threat Disposition:

- Bail hearing on April 22<sup>nd</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not contact/communicate with the named parties
- Do not be within 100m of their home, work, or school
- Do not possess any weapons
- Also has charges from an Undertaking

• Next court date for both matters is April 29th

#### Charges: APS - Mischief x 2, Utter threat – BH, FTC undertaking x 2 FTC release x 2

- Released:
- Bail hearing on April 22<sup>nd</sup>
  - Reside at named address
  - Remain in the home between 10pm & 7am
  - Do not possess any weapons. Next court date is April 30th

#### **Charges:** FTC Probation x 2

- Released:
  - Bail hearing on April 23<sup>rd</sup>
    - Released on a Form 11; Promise to pay \$500 if FTC
    - Report to the John Howard Society as directed
    - Do not attend the named address
    - Next court date is April 29<sup>th</sup>



## **Dispositions:**

Charges: Assault with a weapon – Spousal, Mischief under - Domestic Disposition:

- Court appearance on April 22<sup>nd</sup>
- Charges withdrawn by the Crown
- No reasonable prospect of conviction

Charge: Assault Disposition:

- Court appearance on April 22<sup>nd</sup>
- Charge withdrawn by the Crown
  - Not in the public's interest

**Charges:** Assault – Spousal, FTC Probation x 2 **Disposition:** 

- Court appearance on April 22<sup>nd</sup>
  - Charges withdrawn by the Crown

Charges: FTC Probation x 2 Disposition:

- Court appearance on April 22<sup>nd</sup>
  - Guilty plea to FTC x 1



Charge: Theft under \$5000 Disposition:

- Court appearance on April 22<sup>nd</sup>
  - Direct Accountability Program completed
- Charge withdrawn
- Has outstanding live charges before the court



#### Charge: FTC release order

Disposition:

- Court appearance on April 22<sup>nd</sup>
- Charge withdrawn by the Crown



**Charges:** Drive disqualified x 3 **Disposition:** 

- Court appearance on April 22<sup>nd</sup>
  - Guilty plea x 1
- \$1200 fine
  - 12 months' driving Prohibition

Charges: Impaired operation, Careless driving
Disposition:
Court appearance on April 22<sup>nd</sup>

- Court appearance on April 22<sup>th</sup>
- Charges withdrawn by the Crown



**Charges:** Possession for the purpose of trafficking - Cocaine, Meth, Fentanyl, Oxycodone, FTC Probation

Disposition:

- Court appearance on April 22<sup>nd</sup>
- Guilty pleas to; Possession for the purpose of trafficking cocaine, & FTC
- 8 months' pre-sentence custody enhanced to 12 months
- 18 months' Probation
- 1 day deemed served; 10 days PSC enhanced to 15 days for the FTC
- Lifetime weapons order
- DNA sample

#### Charge: FTC release order Disposition:

- Court appearance on April 22<sup>nd</sup>
- Plead guilty to London PS charges
- STPS charge withdrawn by the Crown



## Charge: FTC Probation

Disposition:

Court appearance on April 22<sup>nd</sup> Charge withdrawn by the Crown

**Charges:** Possess schedule I substance x 3 – Morphine, Codeine, Meth, FTC **Disposition:** 

- Court appearance on April 22<sup>nd</sup>
- Guilty pleas to possession of meth, FTC
- 1 day deemed served, 20 days PSC enhanced to 30 days
- Suspended sentence for the meth charge, 18 months' Probation
- Perform 40 hours of community service
- Remaining CDSA charges were withdrawn as per the resolution



Charge: Disqualified driving Disposition: Court appearance on April 22<sup>nd</sup> Guilty plea \$2000 fine 12 months' driving Prohibition **CONFIDENTIAL – LAW ENFORCEMENT AGENCIES ONLY**
