under x 2, Possess Imitation weapon dangerous to the public,
Possess prohibited weapon, Launder proceeds of crime, Assault,
FTC x 2, Distribute intimate image without consent

#### Released:

- Released on a Form 11; Promise to pay \$2000 if FTC
- Wear a GPS monitor and follow the program protocols
- Reside at named address
- Remain in residence daily b/w 10pm & 6am
- Do not contact/communicate in any way with named parties
- Do not possess any weapons
- Do not possess any drug related paraphernalia
- Next court date is April 28<sup>th</sup>

**Charges:** Possess for the purpose of trafficking x 3 – Meth, Cocaine, Codeine **Disposition:** 

- Court appearance on April 7<sup>th</sup>
- Charges withdrawn by the Federal Crown



**Charge:** Dangerous operation **Disposition:** 

- Court appearance on April 8<sup>th</sup>
- Guilty plea to Dangerous operation
- Suspended sentence; 12 months' Probation
- Do not operate, have care of or control of a m/v

- Court appearance on April 8<sup>th</sup>
- Direct Accountability Program DAP completed

Charge: STPS - Sexual assault

**OPP** - Impaired operation, Over 80 BAC

#### Disposition:

- Court appearance on April 8<sup>th</sup>
- Sexual assault charge withdrawn
- Guilty plea to Over 80 BAC
- \$1200 fine; 12 months' Probation
- Impaired charge and HTA charges were withdrawn as per the resolution



Charges: FTC undertaking, FTC Disposition:

- Court on April 11<sup>th</sup>
- Charges withdrawn by the Crown



Charges: Utter death threat, Assault Disposition:

- Court appearance on April 11<sup>th</sup>
- Entered into a 6 months' CLPB
- No contact/association with named party
- Do not attend their home, work, or school
- Charges withdrawn as per the CLPB
