
**Form 11 Releases:**



**Charges:** FTC undertaking x 3, Breach recognizance

**Released:**

- Bail hearing on June 16<sup>th</sup>
- Released on a Form 11
- Do not contact/communicate in any way with named party
- Don't attend their home, work or school
- Do not possess any weapons
- Next court date is June 24<sup>th</sup>



**Charges:** Theft under \$5000, Breach Probation x 5, Assault with a weapon, Possess property obtained by crime x 5, Utter threat BH, Assault, Possess sched I – Crystal meth

**Released:**

- Bail hearing on June 18<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to Probation as directed
- Do not contact/communicate in any way with named party
- Do not attend their home, work or school
- Do not possess any weapons
- Do not possess and ID, bank card or document unless lawfully issued
- Next court date is July 2<sup>nd</sup>

**Dispositions:**



**Charges:** Assault, FTC

**Disposition:**

- Court appearance on June 16<sup>th</sup>
- Charges withdrawn by the Crown – NPI
- Has outstanding live matters before the court



**Charges:** Fraud over \$5000, Use forged document

**Disposition:**

- Court appearance on June 17<sup>th</sup>
- Guilty plea to Utter forged document
- Conditional discharge, 12 months' Probation
- No contact with named parties
- 20 hours of community service
- Remaining charge was withdrawn



**Charges:** Mischief, FTC Probation, FTC x 3

**Disposition:**

- Court appearance on June 17<sup>th</sup>
- All charges were stayed by the Crown
- Has completed diversion



**Charges:** Assault with a weapon, Theft under, Mischief under, FTC Probation

**Disposition:**

- Court appearance on June 17<sup>th</sup>
- Guilty plea to Mischief under
- Suspended sentence, plus 3 years' Probation
- No contact with named parties
- Do not attend within 100m of their home, work, or school
- No weapons

**Charges:** Disqualified drive x 2, Obstruct police - CCC  
Suspend drive, Improper number plate, Improper rear light – m/v  
Fail to signal turn, Fail to surrender permit - HTA

**Disposition:**

- Court appearance on June 17<sup>th</sup>
- Guilty plea to Disqualified drive
- 60-day conditional sentence with house arrest for the duration with GPS monitoring
- 12 months' Probation
- 30 hours of community service
- All remaining charges were withdrawn
- Has an outstanding live charge before the court



**Charge:** Breach Probation

**Disposition:**

- Court appearance on June 17<sup>th</sup>
- Charge withdrawn - NPI



**Charges:** Assault with a weapon x 4, Assault x 2, Mischief under,  
Unlawfully in a dwelling

**Disposition:**

- Court appearance on June 17<sup>th</sup>
- Entered into a Common Law Peace Bond for 12 months
- No contact with the named parties
- Do not attend within 100m any known place of residence, employment, or education of the named parties
- Do not possess any weapons
- All charges were withdrawn

- Successfully complete Changing Ways program




