St. Thomas Police Service – Court Dispositions

Form 11 Releases:



Charges: Criminal harassment, Breach Probation

Released:

- Bail hearing on June 8th
- Released on a Form 11; Promise to pay \$250 if FTC
- Do not contact/communicate in any way with named party
- Do not be within 25m of their home, work, school
- Do not possess any weapons
- Next court date is July 8th



Charges: Arson: disregard for human life, Accessory after the fact,
Possess restricted firearm without licence

Released:

- Bail hearing on June 12th
- Released on a Form 11; Promise to pay \$100,250
- Wear a GPS monitor and follow the program protocols
- Reside only at the named addresses
- Carry a copy of release order at all times when outside of residence
- No contacts/communications with all named parties
- Do not attend all named locations
- Abstain from the purchase, possession or consumption of any non – medically prescribed narcotics defined by the CDSA
- Present at the door of residence when requested by police
- Do not possess any weapons
- Next court date is September 16th

Charges: Possess property obtained by crime under \$5000, Possess credit Card, Use of revoked credit card, Possess schedule I substance – Opioid

Released:

- Bail hearing on June 13th
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Do not contact/communicate with named party
- Do not attend named locations
- Do not possess any ID, debit/credit card, bank document unless it has been lawfully been issued
- Next court date is June 23rd

Dispositions:



Charges: Assault with a weapon, Utter death threat x 3

Disposition:

- Court appearance on June 10th
- Guilty plea to Utter threat to kill animal
- 1 day deemed served; (17 days PSC, enhanced to 22 days)
- 2 years' Probation
- Live at named address
- No contact/association, directly/indirectly with named parties
- Do not attend any known residence, work, or school of the named parties
- Has outstanding live charges before the court
- DNA order & weapons prohibition for 10 years

Charges: Theft under \$5000, FTC Probation

Disposition:

- Court appearance on June 10th
- Charges withdrawn by the Crown
- No public interest – NPI



Charge: Assault with a weapon

Disposition:

- Court appearance on June 10th
- Charge withdrawn by the Crown
- No reasonable prospect of conviction – NRPC & NPI



Charges: Theft over \$5000, Mischief x 2, FTC Probation

Disposition:

- Court appearance on June 10th
- All charges withdrawn by the Crown – NPI
- Has a live CDSA matter before the court
- Co-accused is still before the court – next court date is July 8th



Charges: Dangerous operation, Theft under \$5000, FTC

Disposition:

- Court appearance on June 10th
- Guilty plea to Dangerous operation, remaining charges withdrawn
- \$1,000 fine

Charges: Theft under \$5000, FTC

Disposition:

- Court appearance on June 10th
- Guilty plea to Theft under
- Suspended sentence, Probation
- \$10.00 fine



Charges: Assault x 2, Assault police, Resist arrest, Utter death threat

Disposition:

- Court appearance on June 10th
- Guilty plea to Utter death threat, & Assault
- Suspended sentence & 12 months' Probation
- No contact/association, directly/indirectly with named parties
- Do not attend their home, work, school or named addresses
- Do not possess any weapons
- Remaining charges were withdrawn



Charges: Assault – Spousal, Assault, Mischief – Domestic, Utter death threat

Disposition:

- Court appearance on June 10th
- Guilty plea to Mischief
- Conditional discharge; 12 months' Probation
- No contact with all named parties
- Do not attend within 100m of any known place of residence, employment, or education of the named parties
- No weapons; Remaining charges were withdrawn

Charges: Possess weapon for dangerous purpose, Cause disturbance
Carry concealed weapon, Assault police with a weapon

Disposition:

- Court appearance on June 10th
- Guilty plea to Possess weapon for a dangerous purpose
- 60 days of pre-sentence custody, enhanced to 90 days
- 18 months' Probation
- No contact/association, directly/indirectly with named parties
- Do not attend any know residence, work, school of the named party
- Remaining charges were withdrawn



Charges: Assault – Spousal, Utter threats - BH, Theft under, FTC

Disposition:

- Court appearance on June 12th
- Entered into a 12 months' Peace Bond
- Charges withdrawn
- No contact/association, directly/indirectly with named party
- Do not attend any known home, work, or education of the named party
- Do not post any images of, or text in relation to, all named parties on social media websites
- No weapons



Charges: Aggravated assault, Assault with a weapon, Assault x 3,
Assault Police x 2, Mischief, Cause a disturbance

Disposition:

- Sentencing on June 12th
- Guilty pleas to; Aggravated assault, Assault with a weapon, Assault x 3, Assault police
- Sentenced to 5 years (2 years PSC enhanced to 3 years), 2 years remaining to be served in the Penitentiary
- 3 years' Probation
- No contact/communication orders with victims & families; Non attendance orders
- No weapons; DNA order; Remaining charges were withdrawn

Charge: Assault

Disposition:

- Court appearance on June 13th
- Entered into a 12 months' Peace Bond
- No contact/communication with named party
- Don't attend their home, work, school
- Do not possess any weapons



Charges: Impaired operation, Fail or refuse to provide sample

Disposition:

- Court appearance for trial on June 13th
- Guilty plea to Impaired operation prior to trial commencing
- 30 days jail sentence
- Time served; 20 days PSC (from previous unrelated charges) enhanced to 30 days
- 2 years' driving Prohibition
- Remaining charge was withdrawn
