**St. Thomas Police Service – Court Dispositions**

**Form 11 Releases:**



**Charges:** Assault with weapon, Assault  
**Released:**

- Bail hearing on May 24<sup>th</sup>
- Released on a Form 11
- Do not contact/communicate in any way direct/indirect with named party
- Do not be within 25m of any place the named party lives, works or attend school
- Do not possess any weapons
- Next court date is June 17<sup>th</sup>



**Charges:** Forcible confinement, Utter threats - BH  
**Released:**

- Bail hearing on May 26<sup>th</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- Do not contact/communicate in any way with named parties
- Do not attend any place the named parties live, work or go to school
- Do not possess any weapons
- Next court date is June 17<sup>th</sup>



**Charges:** Theft under \$5000 x 3, Possess property under \$5000  
**Released:**

- Bail hearing on May 26<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not attend all named addresses and locations

**Charges:** Assault with a weapon – Spousal, Assault x 2, Assault police x 2, FTC  
**Released:**

- Bail hearing on May 26<sup>th</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- Do not contact/communicate in any way with the named parties
- Do not be within 25m of anywhere they live, work or go to school
- Do not contact/communicate by any means with the named person
- Do not possess any weapons
- Next court date is June 4<sup>th</sup>

#### Dispositions:



**Charges:** Possess for the purpose of trafficking - Fentanyl & Hydromorph,  
FTC Probation

**Disposition:**

- Court appearance on May 26<sup>th</sup>
- FTC Probation charge was withdrawn by the Crown
- CDSA charges were transferred to Federal (PPSC) court



**Charges:** FTC Probation x 10, FTC release order x 3, Transportation fraud x 2,  
B&E, Assault with a weapon

**Disposition:**

- Court appearance on May 27<sup>th</sup>
- Guilty pleas; Assault with a weapon, B&E, FTC x 2
- 6 months' Conditional sentence
- GPS monitoring; curfew- 10pm-6am for the first 6 months
- No contact with named parties
- Do not be within 100m of any place they live, work or go to school
- Do not be within 100m of the named locations
- No weapons
- Remaining charges were withdrawn as per the resolution

- Direct Accountability Program - complete

**Disposition:**

- Court appearance on May 27<sup>th</sup>
- Guilty plea to theft under
- Suspended sentence, 12 months' Probation
- Do not contact/communicate with named party
- Do not attend within 25m of named address



**Charges:** Assault x 2, Theft under \$5000, FTC Probation

**Disposition:**

- Court appearance on May 27<sup>th</sup>
- Guilty plea to theft under
- 12 months' Probation
- No contact with named party
- Do not attend their home, work or school
- Perform 10 hours of community service
- Remaining charges were withdrawn as per the resolution

**Charges:** Assault – Choke, Assault, Utter death threat, FTC x 4

**Disposition:**

- Court appearance on May 27<sup>th</sup>
- Guilty plea to lesser offence of Assault
- Suspended sentence plus 21 months' Probation
- No contact with the named party
- Do not attend their residence, employment or education
- No weapons, remaining charges were withdrawn



**Charges:** Prohibited operation x 3, Possess schedule I substance - Meth

**Disposition:**

- Court appearance on May 27<sup>th</sup>
- Guilty pleas;



**Charges:** Theft under \$5000 x 3, FTC

**Disposition:**

- Court appearance on May 27<sup>th</sup>
- Guilty pleas;



**Charges:** Assault, Assault with weapon, Dangerous operation

**Disposition:**

- Court appearance on May 27<sup>th</sup>
- Entered into a 12 months' Peace Bond
- Do not contact/communicate with name party
- Don't attend anywhere they live, work, attend school
- Do not possess any weapons
- All charges were withdrawn

**Charges:** Assault with a weapon – Spousal, Mischief

**Disposition:**

- Court appearance on May 27<sup>th</sup>
- Guilty plea to assault with a weapon
- Entered into a 3 years' Common Law Peace Bond
- No contact with all named parties
- Do not attend within 100m of any known place of residence, employment or education of the named parties
- No weapons
- Successfully complete the Changing Ways Program



**Charge:** Theft under \$5000

**Disposition:**

- Court appearance on May 27<sup>th</sup>
- Charge withdrawn by the Crown
