Form 11 Releases:



Charges: Theft under \$5000
Drive while under suspension x 2, Deface plate x 2 - HTA

Released:

- Bail hearing on June 2nd
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not attend named location
- Next court date is June 17th



Charges: Criminal harassment, Possess unmarked cigarettes

Released:

- Bail hearing on June 3rd
- Released on a Form 11; Promise to pay \$500
- Do not contact/communicate in any way with named party
- Do not be within 25m of anywhere they live, work, go to school
- Do not be within 25m of named address or person
- Do not possess any weapons
- Next court date is June 17th



Charges: Breach Probation x 11, Assault, Utter death threat

Released:

- Bail hearing on June 4th
- Released on a Form 11; Promise to pay \$1000 if FTC
- Reside at named address; notify STPS within 24 hrs of change
- Do not contact/communicate, direct/indirect with the named parties
- Don't attend their home, work, or school
- Do not attend within 10m of the named parties
- Do not attend the named locations
- Do not possess any weapons
- Next court date is July 2nd

Charges: Possess sched I substance x 2 – Cocaine, Meth, Mischief under, Carry concealed weapon, Possess a weapon, Careless storage of a weapon x 2, Possess property obtained by crime x 2, Knowledge of unauthorized prohibited weapon, Unauthorized Possession of a prohibited firearm

Released:

- Bail hearing on June 4th
- Released on a Form 11; Promise to pay \$2500 if FTC
- Wear a GPS monitor and follow the program protocols
- Reside with surety at named address
- Do not contact/communicate in any way with named party
- Do not attend at named location
- Do not possess any weapons
- Do not possess or consume any drugs as included in the CDSA
- Next court date is June 13th & Superior court on August 11th

Dispositions:



Charges: FTC Probation x 5, FTC undertaking x 2, FTC release order x 3, Obstruct police

Disposition:

- Court appearance on June 3rd
- Charges withdrawn by the Crown – NRPC & NPI



Charges: Theft under \$5000 x 3, Possess property under \$5000

Disposition:

- Court appearance on June 3rd
- Informal diversion
- All charges were withdrawn

Charge: Mischief - Domestic

Disposition:

- Charge withdrawn



Charges: Mischief x 4, FTC undertaking

Disposition:

- Court appearance on June 3rd
- Guilty plea to Mischief x 3, FTC
- Suspended sentence, plus 12 months' Probation
- Do not attend all named addresses
- Complete 40 hours of community service
- Do not possess any spray paint, permanent markers or any other marking devices capable for use in causing graffiti



Charge: Assault

Disposition:

- Court appearance on June 3rd
- Charge withdrawn by the Crown – NPI

Charges: STPS - Assault with a weapon, Assault BH - Choke

OPP - FTC

Disposition:

- Court appearance on June 3rd
- DAP completed
- All charges withdrawn



Charges: STPS - Over 80 BAC, Mischief under \$5000

Novice driver – BAC above zero - HTA

OPP – Impaired operation , Over 80 BAC

Disposition:

- Court appearance on June 3rd
- Guilty plea to OPP - Over 80 BAC
- \$2600 fine, 1 year driving Prohibition
- Remaining charges were withdrawn as per the resolution



Charges: Drive disqualified – CCC, Drive under suspension x 2 - HTA

Disposition:

- Court appearance on June 3rd
- Guilty plea to Drive under suspension – HTA
- \$1000 fine
- All remaining charges were withdrawn

Charges: Possess of a firearm or ammunition contrary to prohibition order,
Unauthorized possession of a firearm, Assault with a weapon

Disposition:

- Court appearance on June 5th
- Guilty plea to Possess firearm/ammo contrary to prohibition order
- \$1000 fine; 12 months' Probation
- No contact/ communication with named party
- Don't be within 100m of their home, work, school
- DNA sample, remaining charges were withdrawn



Charge: Theft under \$5000

Disposition:

- Court appearance on June 5th
- Guilty plea
- Conditional discharge, 18 months' Probation
- No contact/communication with named party
- Do not attend named location
- Complete 50 hours of community service



Charges: Identity theft, Fraud over \$5000, FTC
Possess property obtained by crime under \$5000

Disposition:

- Court appearance on June 5th
- Guilty pleas; Identity theft, Fraud over \$5000
- Suspended sentence; 24 months' Probation
- No contact/communication with named party
- Do not attend within 50m of any place they live, work, attend school or frequent
- Remaining charges were withdrawn as per the resolution

Charges: Theft under \$5000 x 2, FTC

Disposition:

- Court appearance on June 5th
- Guilty plea to theft under \$5000
- Conditional discharge, 6 months' Probation
- Do not attend the named locations
- DNA sample; Remaining charges were withdrawn as per the resolution



Charges: Utter threat – BH, Mischief under \$5000 x 3

Disposition:

- Court appearance on June 5th
- Guilty plea to Mischief under x 3
- Suspended sentence, 12 months' Probation
- No contact/communication with the named parties
- Don't attend their home, work, or school
- No weapons; Perform 50 hours of community service



Charges: Assault – Spousal, Mischief - Domestic

Disposition:

- Court appearance on June 6th
- Entered into a 12 months' CLPB
- No contact/communication with named party
- Don't attend their home, work, or place of employment
- Do not possess any weapons
- Charges withdrawn as per the Peace Bond
