Form 11 Releases:



Charges: Assault, Resist police, Breach Probation, Possess meth

Released:

- Bail hearing on June 21st
- Released on a Form 11; Promise to pay \$250 if FTC
- Do not contact/communicate in any way with named party;
- Don't be within 25m of their home, work or school
- Do not possess any weapons
- Next court date is July 28th



Charges: Mischief under, Utter threats, FTC release order

Released:

- Bail hearing on June 23rd
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not contact/communicate in any way with named party
- Don't be within 100m of the named location and address
- Do not possess any weapons
- Next court date is July 8th

Dispositions:



Charges: Sexual interference, Sexual assault, Invitation to sexual touching

Disposition:

- Court appearance on June 23rd for sentencing
- Guilty plea to sexual interference
- 275 days' custody; 116 days remaining to serve
- 3 years' Probation
- DNA Sample, s. 109 weapons prohibition order, s. 161 order (schools, parks, employment, communicating via computer, etc.)
- Non-communication order, SOIRA order
- Remaining charges were withdrawn



Charge: Theft under \$5000

Disposition:

- Court appearance on June 24th
- Direct Accountability Program – DAP complete
- Charge withdrawn



Charges: Sexual assault on person under 16 years, Sexual interference

Disposition:

- Court appearance on June 24th
- Charges withdrawn by the Crown
- No reasonable prospect of conviction

Charges: Utter death threat, FTC Probation x 10, Theft under x 6, Mischief under x 2, FTC release order

Disposition:

- Court appearance on June 24th
- Guilty pleas; Theft under x 3, Mischief, FTC Probation
- 30 days of PSC applied - equivalent of 45 days jail
- 12 months' Probation
- Do not attend the named locations and addresses
- No contact/communication with all named parties
- Do not possess any weapons; Remaining charges were withdrawn



Charges: Assault with a weapon x 2, Utter death threats x 2, FTC

Disposition:

- Court appearance on June 24th
- Entered into a 12 months' CLPB
- No contact/communication by any means with the named party
- Don't attend their home, work, school
- Do not possess any weapons
- Charges withdrawn



Charges: Theft under x 3, FTC

Disposition:

- Court appearance on June 24th
- DAP completed – Charges withdrawn by the Crown

Charges: Theft under, FTC Probation x 6, FTC release, Use of credit card

Disposition:

- Court appearance on June 24th
- Guilty pleas; Theft under, Breach Probation x 2, Use of credit card
- Time served; 10 days of PSC enhanced to 15 days
- 12 months' Probation
- Do not attend named locations
- No contact with named party
- Don't attend their home, employment or education
- Remaining charges were withdrawn
- Was remanded until July 2nd regarding outstanding charges



Charges: Assault, FTC Probation x 5, FTC release order x 4

Disposition:

- Court appearance on June 24th
- Guilty pleas to; Assault, FTC Probation
- Time served; 51 days PSC enhanced to 76 days
- 12 months' Probation
- No contact/communication with named party
- Do not attend their home, work, school



Charges: Theft under x 2, FTC Probation x 3, Sexual Assault

Disposition:

- Court appearance on June 24th
- Guilty plea to theft under
- Time served; 20 days PSC enhanced to 30 days
- 12 months' Probation
- Do not attend named address

Disposition:

- Court appearance on June 24th
- Judge confirmed the CSO breach
- Remanded into custody regarding outstanding live charges

- Guilty plea
- 20 days PSC enhanced to 30 days



Charges: Assault – Spousal x 2

Disposition:

- S. 810 court hearing court on June 27th
- Entered into a 12 months' Peace Bond
- No contact/association, directly/indirectly with named party
- Do not attend their home, work, or school
- Do not possess any weapons
- Complete the Changing Ways Program
- Charges withdrawn



Charge: Assault

Disposition:

- S. 810 court hearing court on June 27th
- Entered into a 12 months' Peace Bond
- No contact direct/indirect by any means with named party
- Do not attend within 5m of their home, work, school
- Do not possess any weapons
- Charge withdrawn



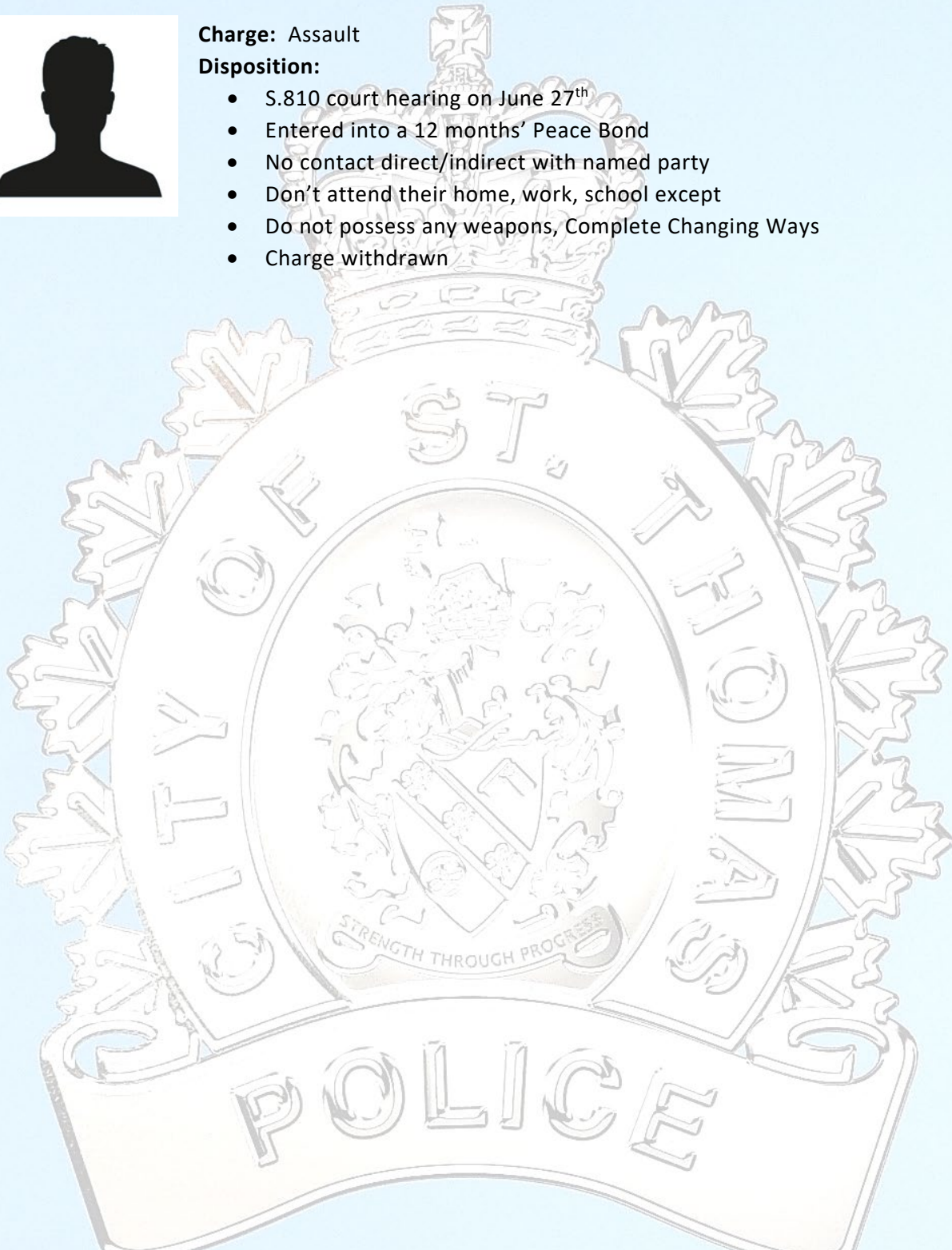
