**Charge:** Utter death threat

**Released:**

- Bail hearing on June 28<sup>th</sup>
- Released on a Form 11; Promise to pay \$200 if FTC
- Next court date is July 8<sup>th</sup>



**Charge:** B&E

**Released:**

- Bail hearing on June 28<sup>th</sup>
- Released on a Form 11; Promise to pay \$250 if FTC
- Report to the John Howard Society as directed
- Remain in residence daily b/w 10pm & 6am **except** emergencies
- Do not attend within 25m of named address
- Do not possess any B&E instruments
- Next court date is August 12<sup>th</sup>



**Charges:** Assault – Spousal, FTC

**Released:**

- Bail hearing on June 29<sup>th</sup>
- Released on a Form 11; Promise to pay \$250 if FTC
- Do not contact/communicate in any way with the named parties
- Do not be within 25m of them, their home, work, school and the named address
- Next court date is July 15<sup>th</sup>

**OPP** - Unauthorized possession of a firearm x 2, Possess a weapon for a dangerous purpose x 2, Careless use of firearm x 2

**Released:**

- Bail hearing on June 30<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Wear a GPS monitor & follow the program protocols
- Reside at named address
- Do not contact/communicate in any way with the named parties
- Do not attend the named addresses
- Do not possess any weapons
- Do not possess any drug trafficking paraphernalia, weigh scales or more than one cellular phone
- Next court date is July 14<sup>th</sup>



**Charges:** Possess schedule I substance, cocaine, fentanyl, Assault, Utter threat, Theft under \$5000, FTC release order

**Released:**

- Bail hearing on June 30<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Do not contact/communicate in any way with the named party
- Do not attend within 25 of their home, work or school, including the named address
- Do not possess any weapons
- Do not possess any weigh scales, debt lists, dime bags, and drug packaging materials
- Next court date is July 21<sup>st</sup>

**Charges:** **OPP** – Unlawful confinement, Impaired operation  
**STPS** – FTC release order x 2, FTC Probation order x 2

**Released:**

- Bail hearing on June 30<sup>th</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- Reside with sureties at named address
- Remain in residence daily between 10pm & 7am with **exceptions**
- Do not contact/communicate in any way with the named party
- Don't attend within 25m of the person or 100m of their home, work, or school
- Do not possess any weapons
- Next court date is July 29<sup>th</sup>



**Charges:** Prohibited operation x 2, FTC Probation x 2, Possess cocaine  
Theft under \$5000, Breach Probation  
Drive while suspended – HTA

**Released:**

- Bail hearing on June 30<sup>th</sup>
- Released on a Form 11; Promise to pay \$250 if FTC
- Report to Probation as directed
- Next court date is July 22<sup>nd</sup>



**Charges:** Unlawfully in a dwelling x 2, Theft under \$5000, B&E

**Released:**

- Bail hearing on July 1<sup>st</sup>
- Released on a Form 11; Promise to pay \$200 if FTC
- Next court date is July 8<sup>th</sup>

**Charges:** Assault with a weapon, Theft under, Identity theft, FTC

**Released:**

- Bail hearing on July 3<sup>rd</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- Wear a GPS monitor and follow the program protocols
- Reside at named address
- Do not contact/communicate in any way with the named party
- Don't attend their home, work, school
- Do not attend the named address
- Do not attend any of the named businesses in Ontario
- Do not possess any weapons
- Do not possess any ID, Bank cards or documents unless it has been lawfully issued
- Next court date is July 22<sup>nd</sup>



**Charge:** Utter threat - Property

**Released:**

- Bail hearing on July 4<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Notify STPS OIC of his address within 24 hours
- Do not contact/communicate in any way with the named party
- Don't attend their home, work, or school, incl. the named address
- Do not possess any weapons
- Next court date is July 7<sup>th</sup>

- YCJA - Conditional discharge for 18 months
- No association with anyone directed in writing by is probation officer
- Do not operate a m/v **unless for work, or counseling**
- For the first year only have family members in the car or one employee
- BAC zero while driving
- Community service - 80 hours
- DNA; Remaining charges were withdrawn



**Charge:** Theft under \$5000

**Disposition:**

- Judicial pretrial appearance on July 2<sup>nd</sup>
- Charge withdrawn by the Crown – NPI.



**Charges:** Disobey court order, Theft under \$5000

**Disposition:**

- Court appearance on July 4<sup>th</sup>
- Charges withdrawn by the Crown
- No reasonable prospect of conviction



**Charges:** Arson, FTC Probation x 10, FTC undertaking

**Disposition:**

- Court appearance from EMDC on July 4<sup>th</sup>
- Guilty pleas to; FTC Probation x 3, FTC undertaking
- Sentenced to time served, 8 days PSC enhanced to 12 days
- Arson charge withdrawn
- Remaining charges withdrawn by the Crown; STPS charges complete
