Released:

- Bail hearing on August 9th
- Released on a Form 11
- Do not contact/communicate in any way with named party
- Do not be within 25m of their home, work, or school
- Do not possess any weapons
- Next court date is September 9th



Charges: Resist arrest, FTC

Released:

- Bail hearing on August 9th
- Released on a Form 11
- Do not contact/communicate in any way with named party
- Do not be within 25m of their home, work, school
- Next court date is September 2nd



Charges: Theft under \$5000 x 7, Arson

Released:

- Bail hearing on August 9th
- Released on a Form 11; Promise to pay \$250 if FTC
- Do not attend within 25m of the named location
- Next court date is September 9th

Charges: Theft under, Mischief under x 2, Trespass at night

Released:

- Bail hearing on August 11th
- Released on a Form 11; Promise to pay \$500 if FTC
- Notify STPS of address within 24 hours of release
- Notify STPS of any change in address within 24 hours
- Remain in residence daily between 10pm & 7am
- No contact/communication in any way with named party
- Do not be within 25m of their home, work, school
- Do not attend within 100m of the named address
- Do not possess any weapons
- Next court date is August 26th



Charge: FTC Prohibition order

Released:

- Bail hearing on August 12th
- Released on a Form 11; Promise to pay \$1000 if FTC
- Wear a GPS monitor and follow the program protocols
- Report to the STPS on Fridays b/w 9 – 4pm commencing Aug 15th
- Reside at named address
- Do not be within 100m of the named location
- Don't attend any public park, public pool, where persons under 16 years are present or reasonably to be expected to be present, or a daycare, school ground, playground, community centre
- Next court date is September 2nd



Charges: Assault with a weapon, B&E

Released:

- Bail hearing on August 14th
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Do not contact/communicate with all named parties
- Don't attend their home, work, or school
- Do not possess any weapons
- Next court date is September 16th

Charges: Intimidation – Justice system, Utter threats - BH

Released:

- Bail hearing on August 14th
- Released on a Form 11; Promise to pay \$10,000 if FTC
- Must reside at named address
- Wear a GPS monitor and follow the program protocols
- Present at the door for police bail checks
- Remain in the residence at all times with exceptions
- Non association/communication orders
- Do not be within 100m of the named parties
- Do not possess any weapons
- Next court date is September 9th

Dispositions:



Charge: Impaired - Fail to provide breath sample

Disposition:

- Court appearance on August 12th
- Charge withdrawn by the Crown
- No reasonable prospect of conviction – NRPC



Charge: Impaired – Over 80 BAC

Disposition:

- Court appearance on August 12th
- Guilty plea
- \$2600 fine
- 12 months' driving Prohibition

Charge: Assault

Disposition:

- Court appearance on August 12th
- Charge withdrawn by the Crown
- Completed court order course



Charges: Criminal harassment, Assault with a weapon, Dangerous operation

Disposition:

- Court appearance for sentencing on August 12th
- Guilty plea to Criminal harassment
- Suspended sentence; 18 months' Probation
- No contact with the named parties
- Do not attend within 50m of any known place of residence, employment, or education of the named parties
- Do not possess any weapons for 10 years; DNA order
- Remaining charges were withdrawn



Charge: Assault

Disposition:

- Court appearance on August 12th
- Charge withdrawn by the Crown - NPI
- Has live charges before the court



Charges: Impaired operation, Impaired - Refusal

Disposition:

- Court appearance on August 12th
- Guilty plea to Impaired operation
- \$3000 fine, 2 years' driving Prohibition

Charges: Assault with a weapon, Carry concealed weapon x 2, FTC x 7,
Possess weapon for a dangerous purpose, FTC Probation x 9,
Unauthorized possession of a weapon

Disposition:

- Court appearance on August 2nd
- Guilty; Carry concealed weapon x 2, Possess weapon for a dangerous purpose, Unauthorized possess prohibited weapon, FTC x 2, FTC Probation x 2
- 60 days jail; 3 years' Probation
- Do not contact/communicate with named parties
- Don't attend their home, work, or school
- Do not possess any weapons
- Remaining charges were withdrawn as per the resolution



Charges: Prohibited operation, Theft under x 5, Fraud under, FTC x 2

Disposition:

- Court appearance on August 12th
- Guilty pleas; Prohibited operation, Theft under x 4, FTC
- 1 year sentence – concurrent on Elgin County charges
- 66 days PSC enhanced to 129 days; 236 days remaining to serve
- 12 months' Probation
- No association directly/indirectly with named party
- Do not attend all named locations
- Remaining charges were withdrawn as per the global resolution



Charges: Assault with a weapon, Assault

Disposition:

- Court appearance on August 15th
- Entered into a 12 months' Peace Bond
- No contact/communciation in any way with with named party
- Don't attend their home, work, school
- Successfully complete Changing Ways
- Do not possess any weapons
- Charges withdrawn
