Charges: Assault, ABH - Choking

Released:

- Bail hearing on August 4th
- Released on a Form 11
- No contact/communication in any way with named party
- Do not be within 25m of their home, work or school
- Do not possess any weapons
- Next court date is August 26th



Charges: Assault with a weapon, Utter threats - BH

Released:

- Bail hearing on August 5th
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Do not contact/communicate in any way with named party
- Do not be within 100m of their home, work or school
- Do not possess any weapons
- Next court date is September 2nd



Charges: Theft under \$5000 x 3, FTC Probation

Released:

- Bail hearing on August 5th
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not contact/communicate in any way with the named party
- Do not attend their home, work or school
- Do not attend the named locations. Next court date is August 12th

- Bail hearing on August 6th
- Released on a Form 11; Promise to pay \$250 if FTC
- Report to STPS any change in of address within 48 hours
- Do not attend the named location
- Next court date is August 26th



Charges: B&E x 2, Theft under x 2, Breach Probation x 6, Obstruct police

Released:

- Bail hearing on August 7th
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Notify STPS of address within 24 hours of release
- Notify STPS of any additional new address changes within 24 hours
- No contact/communicate in any way all the named parties
- Do not attend the named locations
- Do not possess any ID, card with data strip/chip or banking document unless it has been lawfully issued
- Do not possess any break in instruments
- Next court date is August 19th

Released:

- Bail hearing on August 7th
- Released on a Form 11; Promise to pay \$2500 if FTC
- Reside with surety
- No contact/communication with named parties
- Don't attend their home, work or school
- Do not be within 25m of the named parties
- Do not attend the City of St. Thomas
- Do not possess any weapons
- Next court date is September 9th



Charges: Assault, Unlawfully in a dwelling, Prowl at night, Theft under x 2, Mischief under, Disqualified drive, Breach Probation

Released:

- Bail hearing on August 7th
- Released on a Form 11; Promise to pay \$1000 if FTC
- Reside with surety
- Wear a GPS device and follow the program protocols
- Remain on the property of the residence daily between 8pm and 6am
- Do not contact/communicate in any way with the named parties
- Do not be within 25m of their home, work or school
- Do not possess any weapons
- Do not operate or have care and control of a m/v
- Next court date is September 9th



Charges: Assault with a weapon, Criminal Harassment & Dangerous Operation
Released:

- Released on Form 11
- Report to the John Howard Society
- No contact/communication in any way with named parties
- Do not be within 50m of anywhere they live, work or go to school
- Do not possess any weapons

Charge: Assault - Spousal

Disposition:

- Court appearance on August 5th
- Charge withdrawn by the Crown
- Nor reasonable prospect of conviction – NRPC



Charge: Utter death threat

Disposition:

- Court appearance on August 5
- Direct Accountability Program – DAP completed
- Charge withdrawn by the Crown



Charges: Utter death threat, Assault police, Resist arrest, FTC undertaking x 2

Disposition:

- Court appearance on August 5th
- Diversion completed
- Charges stayed



Charge: Arson

Disposition:

- Court appearance on August 5th
- Guilty plea to lesser offence of Mischief
- Suspended sentence - 12 months' Probation
- Do not attend named address
- Do not possess any incendiary devices **except** for one lighter for the purpose of smoking cigarettes
- 25 hours of community service

Charges: Dangerous operation, Prohibited driving,
Drive while suspended, Fail to stop – stop sign HTA

Disposition:

- Court appearance on August 5th
- Guilty plea to Dangerous operation
- 24 months' Driving prohibition
- \$2,600 fine
- Remaining charges were withdrawn as per the resolution



Charge: Assault

Disposition:

- Court appearance on August 5th
- Guilty plea to Assault
- Suspended sentence; 24 months' Probation
- No contact/communication with named party
- Don't attend their home, work, or school
- Do not be within 25m of the named party
- Complete 40 hours of community service
- DNA sample & No weapons



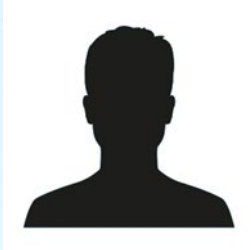
Charges: Impaired operation, Over 80 BAC

Disposition:

- Court appearance on August 5th
- Guilty plea to Impaired driving
- \$2,000 fine
- 12 months' driving Prohibition
- Remaining charge was withdrawn as per the resolution



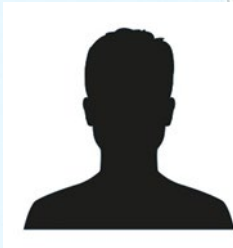

Charges: Resist arrest, Assault police, Public mischief

Disposition:

- Court appearance on August 6th
- Guilty plea to public mischief
- Conditional discharge
- 2 years' Probation, Usual conditions
- Perform 20 hours of community service



Charge: Impaired operation over 80

Disposition:

- Court appearance on August 7th for trial
- Found guilty after trial
- \$1,950 fine
- 12 months' driving prohibition
