Form 11 Releases:



Charges: Transportation fraud, False fire alarm, Breach Recog, FTC

Released:

- Bail hearing on July 29th
- Released on a Form 11; Promise to pay \$1000 if FTC
- Reside with surety at named address
- Do not contact/communicate in any way direct/indirect by any means with the named party
- Don't attend their home, work, school
- Do not attend named address
- Do not possess any weapons
- Next court date is August 12th



Charge: Sexual assault

Released:

- Bail hearing on July 30th
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not contact/communicate in any way with the named party
- Don't be within 50m of their home, work, or school
- Do not possess any weapons
- Next court date is August 19th

Charges: Disobey court order, FTC

Released:

- Bail hearing on July 30th
- Released on a Form 11
- Next court date is August 19th



Charges: Assault, Possess property obtained by crime x 2, FTC Probation x 2, Trafficking schedule I substance - Fentanyl

Released:

- Bail hearing on July 30th
- Released on a Form 11; Promise to pay \$1000 if FTC
- Wear a GPS monitor and follow the program protocols
- Reside with surety at named address
- Remain in residence 24 hours a day with exceptions
- Do not contact/communicate by any means with named parties
- Do not possess any weapons
- No substances under the CDSA unless issued in their name
- Next court date is August 25th



Charges: Theft under \$5000, Breach Probation x 2, FTC

Released:

- Bail hearing on July 31st
- Released on a Form 11
- Report to the John Howard Society as directed
- Do not attend the named address
- Next court date is August 19th

Dispositions:



Charges: Assault with a weapon, Carry concealed weapon, Mischief under,
Possess weapon for dangerous purpose, Unauthorized possession
of a weapon

Disposition:

- Court appearance on July 29th
- Guilty plea to Carry a concealed weapon
- Sentenced to 5 days PSC enhanced to 7 days and 1 day deemed served
- 12 months' Probation
- No contact/association, directly/indirectly with named party except with revokable consent filed with the STPS
- Do not attend their home, work, school except with written consent
- No weapons for 10 years, Forfeiture order on the weapon
- Remaining charges were withdrawn



Charges: Assault with a weapon, Assault - Spousal

Disposition:

- Court appearance on July 29th
- Guilty plea to assault
- Suspended sentence - 12 months' Probation, usual conditions
- No contact with the named party except with revokable consent
- Do not attend their home, work, or school
- Perform 20 hours of community service
- No weapons for 10 years, DNA sample

Charges: Theft over \$5000, Possess Cocaine, FTC Probation x 2, FTC x 2, Prohibited operation

Disposition:

- Court appearance on July 29th
- Guilty pleas to; Possess cocaine, FTC Probation, FTC release order, prohibited operation
 - Sentenced to time served; 20 days PSC enhanced to 30 days
 - 1 year driving Prohibition
 - Remaining charges were withdrawn as per the resolution



Charge: Assault - Spousal

Disposition:

- Guilty plea
- Conditional discharge, 12 months' Probation
- No contact with the named party
- Do not attend any known place of residence, employment, or education of the named party
- No weapons

Disposition:

- Charge withdrawn by the Crown
- No public interest – NPI

Charge: Theft under \$5000

Disposition:

- Guilty plea to theft under
- Suspended sentence - 3 years' Probation, usual conditions
- Complete 100 hours of community service
- Make restitution in the amount of \$2600 payable to named organization
- Do not handle any cash transactions at any place of employment



Charge: Breach Probation

- Charge withdrawn by the Crown - NPI
- Probation order is complete

Disposition:

- Court appearance on July 31st
- Guilty plea to Resist arrest
- Conditional sentence; Time served, 37 days PSC
- 12 months' Probation, usual conditions
- Do not possess any weapons
- Remaining charges were withdrawn



Charges: Assault – Spousal, Mischief - Domestic

Disposition:

- Court appearance on August 1st
- Entered into a 12 months' Peace Bond
- No contact/association, directly or indirectly with named party
- Do not attend at any known place of residence, employment, or education of the named party
- Do not possess any weapons
- Successfully complete the Changing Ways
- Remaining charges were withdrawn as per the resolution



Charge: Assault – Spousal

Disposition:

- Court appearance on August 1st
- Entered into a 12 months' Peace Bond
- No contact/association, directly/indirectly, with named party
- Do not attend at any known place of residence, employment, or education of the named party
- Do not possess any weapons

- Charge was withdrawn as per the resolution



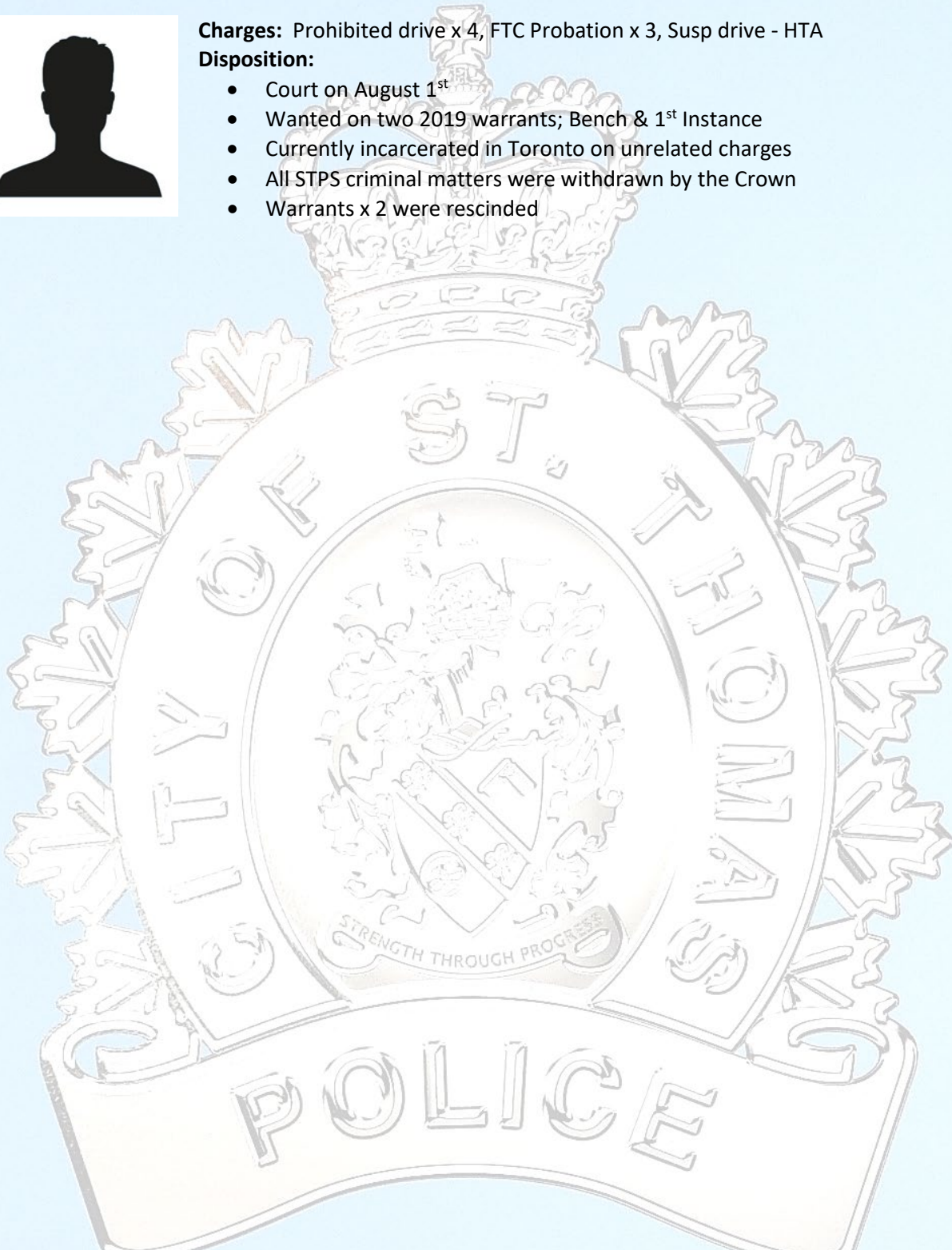
