Form 11 Releases:



Charges: Assault, Utter threat - BH

Released:

- Bail hearing on August 28th
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not contact/communicate in any way with the named parties
- Do not attend any place they live, work or go to school
- Do not possess any weapons
- Next court date is September 23rd



Charge: Impaired operation

Disposition:

- Video appearance from EMDC on August 29th
- In custody since July 10th after warrant executed
- Released on a Form 11
- Next court date is September 12th



Charges: Impaired operation, Theft under, Mischief under, B&E,
Possess property obtained by crime under \$5000

Released:

- Bail hearing on August 29th
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Do not contact/communicate in any way by any means with the named parties
- Do not attend within 100m of the named locations
- Do not possess any weapons
- Next court date is October 7th

Disposition:

- Court appearance on August 26th
- Guilty plea to Theft under
- Suspended sentence, 18 months' Probation
- Do not attend the named location
- Complete 20 hours of community service
- Remaining charges were withdrawn



Charge: FTC release order

Disposition:

- Court appearance on August 26th
- Guilty plea to FTC
- Time served; 10 days PSC enhanced to 15 days



Charges: Utter threats – BH, FTC Probation x 2, FTC

Disposition:

- Court appearance on August 26th
- Guilty pleas; Utter threats – BH, FTC Probation
- Time served; 10 days of PPC enhanced to 15 days
- 2 years' Probation
- No contact or association, directly/indirectly with the named parties
- Do not attend within 50m of the named address
- DNA order

Charges: Arson – Disregard for human life, FTC Probation x 2

Disposition:

- Court appearance on August 26th
- Guilty plea to lesser offence of Mischief
- Time served; 62 real days PSC, enhanced to 93 days jail
- Do not attend the named address
- Do not possess any weapons
- 2 years' Probation
- Remaining charges were withdrawn



Charges: Assault – BH, Assault

Disposition:

- Court appearance on August 26th
- Charges withdrawn by the Crown
- No Public Interest



Charge: Theft under \$5000

Disposition:

- Court appearance on August 26th
- Direct Accountability Program completed
- Charge withdrawn by the Crown

Charges: Disqualified drive, Suspend drive - HTA

Disposition:

- Guilty plea to Suspend drive
- \$1500 fine
- 6 months' driving Prohibition
- Remaining charges were withdrawn



Charges: STPS - Assault, FTC Probation

OPP - Mischief under \$5000, Breach Conditional sentence order

Disposition:

- Court appearance on August 26th
- Guilty plea to Breach conditional sentence order
- Remaining of Conditional sentence order, 2 years less a day, in custody



Charges: Forcible confinement, Utter threats - BH

Disposition:

- Court appearance on August 26th
- Guilty plea to Forcible confinement
- Conditional discharge, 12 months' Probation
- No contact, do not attend
- 60 hours community service
- No weapons, DNA sample

Charge: Breach of conditional sentence order

Disposition:

- Court appearance on August 28th
- Charge withdrawn by the Crown – NPI



Charge: Impaired operation

Disposition:

- Court appearance on August 29th
- Guilty plea to lesser charge of Careless driving – HTA
- \$1000 fine; 12 months' Probation
- Remedial driving program



Charge: Assault – Spousal

Disposition:

- Court appearance on August 29th
- Entered into a 12 months' Peace Bond
- No contact/communication with the named party
- Do not attend their home, work or school
- Complete the Changing Ways program
- Do not possess any weapons
- Assault charge withdrawn as per the Peace Bond



Charges: OPP - Assault, Mischief, FTC x 3
STPS - FTC

Disposition:

- Court appearance on August 29th
- All charges withdrawn by the Crown
