Charges: Dangerous operation, Breach Recognizance x 3

Released:

- Bail hearing on August 30th
- Released on a Form 11; Promise to pay \$500 if FTC
- Do not contact/communicate in any way with named party
- Do not be within 50m of any place they live, work, go to school, or any place they are known to be
- Next court date is October 21st

- Released on a Form 11; Promise to pay \$200 if FTC
- Next court date is September 23rd

- Do not possess any weapons - Next court date is September 23rd

Charges: Theft under, FTC Probation, FTC

Released:

- Bail court on September 3rd
- Consent release on a Form 11
- FTC charge was withdrawn, live charges still pending
- Do not attend named location
- Next court date is September 16th



Charges: Possess property under \$5000, Possess credit card, Use revoked Credit card, Possess schedule I substance – Opioid

Released:

- Bail hearing on September 2nd
- Released on previous Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Do not contact/communicate in any way with the named party
- Do not attend the named locations
- Do not possess any ID, bank document or debit/credit card unless lawfully issued
- Next court date is September 8th



Charges: Assault – BH, Assault

Released:

- Bail hearing on September 5th
- Released on a Form 11; Promise to pay \$500 if FTC
- Wear a GPS monitor and follow the program protocols
- Do not contact/communicate by any means with the named party
- Do not be within 50m of the person
- Do not possess any weapons
- Next court date is October 7th

- Not to possess any weapons

Disposition:

- Court appearance on September 2nd
- All charges were withdrawn by the Crown

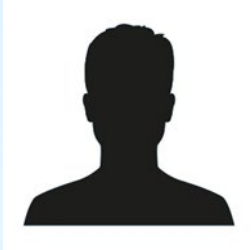

Charges: Assault – BH, Assault – Spousal x 2, FTC Probation, FTC x 6, Utter death threat

Disposition:

- Court appearance on September 2nd
- Guilty pleas; Utter death threat, FTC x 2, Lesser charge of Assault from Assault – BH
- Sentenced to time served; 64 days PSC enhanced to 96 days jail
- 2 years' Probation
- No contact with named party; non-attend within 100m of any known place of residence, employment or education of the named party
- Do not attend named address
- Do not contact named party
- Non-attend within 100m of any known place of residence, employment, or education of the named party
- Do not possess any weapons for 7 years, DNA



Charge: Utter counterfeit money

Disposition:

- Court appearance on September 2nd
- Direct Accountability Program – DAP completed
- Charge withdrawn



Charges: FTC – Undertaking, FTC Probation

Charges: Theft under \$5000 x 5, B&E, Obstruct police,
Possess property obtained by crime under \$5000

Disposition:

- Court appearance on September 3rd
- Guilty plea to B&E
- Suspended sentence, 2 years' Probation
- Do not contact/communicate in any way with named party; Do not attend their home, work or school
- Do not attend the named locations
- Do not possess any weapons
- Perform 75 hours of Community service



Charges: FTC Recognizance x 2, FTC Undertaking

Disposition:

- Court appearance on September 3rd
- Guilty plea to Breach Recognizance
- Suspended sentence; 2 years' Probation – usual conditions
- Do not contact/communicate in any way, by any means with the named party
- Do not attend within 25m of their home, work, school
- Next court date is October 7th for remaining live charges
