### Form 11 Releases:



**Charges:** Assault x 2, Theft under \$5000 **Released:** 

- Bail hearing on September 6<sup>th</sup>
- Released on a Form 11; Promise to pay \$250 if FTC
- Do not contact/communicate in any way with the named parties
- Don't be within 25m of their home, work, school, incl. named address
- Do not possess any weapons
- Next court date is October 7<sup>th</sup>



**Charges:** Utter threats – BH, FTC Probation x 9, FTC release order **Released:** 

- Bail hearing on September 7<sup>th</sup>
- Released on a Form 11
- Do not contact/communicate in any way with named party
- Don't be within 25m of them, their home, work or school, incl. named address
- Next court date is October 7<sup>th</sup>



**Charges:** Theft under x 3, FTC Probation x 5, FTC undertaking x 2 **Released:** 

- Bail hearing on September 8<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Wear a GPS monitor and follow the program protocols
- Notify STPS within 24 hours of any address change
- Don't attend within 100m of the entire shopping centre at 1063 Talbot
- Next court date is October 7<sup>th</sup>





**Charges:** Impaired driving (a) & (b), Prohibited operation, Obstruct police **Released:** 

- Bail hearing on September 9<sup>th</sup>
- Released on a Form 11; Promise to pay \$2000 if FTC
- Report to the John Howard Society
- Notify STPS of address within one business day within 24 hours of any change in address
- Do not operate or have care or control of a m/v
- Next court date is October 7<sup>th</sup>



Charges: B&E, Theft under \$5000 Released:

- Bail hearing on September 9<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Do not contact/communicate in any way with the named parties
- Do not attend the named locations
- Do not possess any B&E instruments
- Next court date is October 7<sup>th</sup>



Charges: Theft under \$5000 x 7, Arson Released:

- Bail hearing on September 10<sup>th</sup>
- Promise to pay \$500 if FTC
- Report to the John Howard Society
- Do not contact/communicate in any way with named party
- Do not attend the named locations
- Do not possess any incendiary device except for one lighter for the purpose of lighting cigarettes
- Next court date is September 23<sup>rd</sup>

- Do not possess any B&E instruments
- Next court date is September 22<sup>nd</sup>

- Released on a Form 11
- Do not contact/communicate in any way with the named parties
- Do not attend the named addresses or locations
- Next court date is October 7<sup>th</sup>

- Court appearance on September 8<sup>th</sup>
- Guilty pleas; Assault with a weapon, Assault, Theft under x 2
- Suspended Sentence, 18 months' Probation
- No contact/communication with the named parties
- Do not attend any place they live, work or attend school
- Do not attend within 10m of the named person or named locations
- No weapons, DNA



Charge: Possess schedule I substance – Crystal Meth Disposition:

- Court appearance on September 8<sup>th</sup>
- Direct Accountability Program DAP completed
- Charge withdrawn
- Has outstanding live STPS charges



**Charge:** Impaired operation - Drug **Disposition:** 

- Court appearance on September 8<sup>th</sup>
- Guilty plea
- \$1000 fine, 12 months' driving Prohibition





Charges: Possession of weapon for dangerous purpose,
Unauthorized possession of weapon, Careless use of a Firearm,
Unauthorized possession of firearm, Possession of imitation weapon,
Possess weapon firearm contrary to Prohibition order,
Possession for the purpose of trafficking x 4,

#### Disposition:

- Court appearance on September 8<sup>th</sup>
- Guilty pleas; Careless use of a firearm, Unauthorized possession of firearm,
   Possession for the purpose of trafficking
- Penitentiary Jail Sentence, Global sentence of 3.5 years less PSC imposed, concurrent on all charges (131 days PSC enhanced to 197 days; 1081 days left to serve)
- DNA, Weapons prohibition order
- Remaining charges were withdrawn as per the global resolution



Charges: Assault, Resist police, Possess schedule I substance - , FTC, FTC Probation x 2

### Disposition:

- Video court appearance from EMDC on September 9<sup>th</sup>
- All charges were withdrawn by the Crown
- No reasonable prospect of conviction NRPC

- \$1500 fine, 12 months' driving Prohibition
- Remaining charges were withdrawn

- Do not attend their home, work or school named address
- Remaining charges were withdrawn

- Charge withdrawn by the Crown, No public interest NPI



Charges: FTC Probation x 4 Disposition:

- Court appearance on September 9<sup>th</sup>
- Guilty plea to FTC x 1
- Time served; 40 days PSC enhanced to 60 days
- Remaining charges were withdrawn



**Charges: STPS** - Assault, Utter death threat, FTC Probation x 3

APS - Trespass/Prowl at night

#### Disposition:

- Court appearance on September 9<sup>th</sup>
- Guilty plea to FTC Probation x 1
- \$150 fine, Probation
- All remaining charges were withdrawn by the Crown NPI





Charge: Aggravated assault

#### Disposition:

- Court appearance on September 9<sup>th</sup>
- Guilty plea to lesser offence of Assault BH
- 8 months' conditional sentence order to be served in the community
- 12 months' Probation to follow conditional sentence
- Reside at named address
- Subject to house arrest rules and protocols
- No contact/communication with the named party
- Don't attend their home, work or school
- Do not attend any licenced establishments
- DNA, No weapons



**Charges:** Exposure to person under 16, Sexual exploitation of person with a disability, Utter death threats, FTC x 2

### Disposition:

- Court appearance on September 9<sup>th</sup>
- Entered into a 3 years' CLPB
- No contact/communication with the victims
- Non attendance at their home, work, school
- Do not attend a public park or public swimming area where persons under the age of 16 years are present or can reasonably be expected to be present, or a daycare centre, schoolground, playground or community centre except in the presence of a responsible adult aged 21 years or older who is aware of the circumstances of the offences
- Do not seek, obtain, or continue any employment, whether the employment is remunerated, or becoming or being a volunteer in a capacity, that involves being in a position of trust or authority towards persons under the age of 16 years
- No weapons



Charge: Firearms hearing

### Disposition:

- Court appearance on September 10<sup>th</sup>
- Prohibition order was not granted





**Charges:** Fail to stop at crash causing death, Prohibited operation x 2 **Disposition:** 

- Court appearance on September 11<sup>th</sup> for sentencing
- Guilty pleas; Fail to stop at crash causing death, Prohibited operation
- 3 years' jail, less 24.2 months PSC
- Plus 60 days credit for CNCC's failure to bring to court twice
- 359 days left to serve, Driving Prohibition, DNA



**Charge:** Assault with a weapon **Disposition:** 

- Court appearance on September 12<sup>th</sup>
- Entered into a 12 months' Peace Bond
- No contact/communication with named party
- Do not attend their home, work, school
- Do not possess any weapons
- Complete Changing Ways
- Charge withdrawn



Charge: Criminal harassment Disposition:

- Court appearance on September 12<sup>th</sup>
- Entered into a 12 months' Peace Bond
- No contact/communication, directly/indirectly with the named parties
- Do not attend their home, work, or school or the named addresses
- Do not possess any weapons
- Charge withdrawn as per the Peace Bond
