Form 11 Releases:



Charges: Assault – Spousal x 2, FTC x 3

Released:

- Bail hearing on October 11th
- Released on a Form 11; Promise to pay \$250 if FTC
- Do not contact/communicate in any way with named party;
- Do not be within 25m of the named party; home, work, school
- Next court date is November 18th



Charges: Assault with a weapon, FTC x 2

Released:

- Bail hearing on October 11th
- Released on a Form 11; Promise to pay \$250 if FTC
- Report to the John Howard Society
- Do not contact/communicate in any way with the named party
- Do not be within 25m of the named party; home, work, school
- Next court date is October 28th



Charges: Assault - BH, Assault, FTC

Released:

- Bail hearing on October 15th
- Released on a Form 11
- Wear a GPS monitor and follow the program protocols
- Report to the John Howard Society
- Do not contact/communicate in any way with the named party
- Don't be within 50m of the named party; home, work, school
- Do not attend within 100m of the named address
- Next court date is October 21st

Charges: Impaired operation, Possess schedule I substance x 3
(Meth, Fentanyl, Hydromorphone)

Released:

- Bail hearing on October 16th
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Notify STPS OIC of address within 24 hours of release
- Notify STPS OIC of address within 24 hours of any changes
- Next court date is November 4th

Dispositions:



Charge: Impaired – Over 80 BAC

Disposition:

- Court appearance on October 14th
- Guilty plea to Over 80 BAC
- \$1950 fine
- 1 year driving Prohibition



Charge: FTC Probation

Disposition:

- Court appearance on October 14th
- Charge withdrawn
- No public interest – NPI



Charge: Drive disqualified

Disposition:

- Court appearance on October 14th
- Charge withdrawn
- No reasonable prospect of conviction - NRPC

Charges: Sexual assault, Utter death threat x 2, Assault with a weapon, Assault – Spousal x 3, Mischief – Domestic x 2

Disposition:

- Court appearance on October 14th
- Guilty plea to Assault & Mischief under \$5000
- Conditional discharge, 2 years' Probation
- Changing ways was completed before sentencing
- No contact with named party
- Do not attend with 100m of any place of residence, employment or education of the named party
- Make restitution of \$4,500
- Remaining charges were withdrawn as part of the resolution



Charges: Utter death threat, Mischief x 2, Theft under

Disposition:

- Court appearance on October 14th
- Mischief charges withdrawn – Diversion completed
- Remaining charges were withdrawn – NPI



Charges: Assault, Assault police, Resist arrest

Disposition:

- Court appearance on October 14th
- Guilty plea to Resist arrest
- Suspended sentence, 18 months' Probation
- No contact with named party
- Do not attend the named party's residence, employment, or education
- No weapons
- Remaining charges were withdrawn



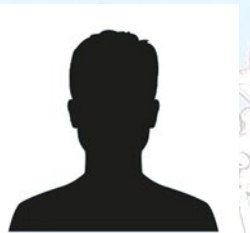

Charges: Impaired operation, Over 80 BAC, Fail to remain - HTA

Disposition:

- Court appearance on October 14th
- Charges withdrawn by the Crown – NRPC



Charges: Use credit card x 4, Theft under x 2, FTC
Possess property obtained by crime under \$5000 x 4

Disposition:

- Court appearance on October 14th
- Guilty plea to Use credit card
- Suspended sentence, 12 months' Probation
- No contact/association with directly/indirectly with the named party
- Don't attend the named party's home, work, school
- Do not attend the named address
- Do not be in possession of any ID/banking instruments, etc. unless lawfully issued
- Remaining charges were withdrawn



Charge: Mischief under \$5000

Disposition:

- Court appearance on October 15th
- Extra Judicial Sanction - diversion complete
- Charge withdrawn

Charges: Assault x 2, Mischief x 4, Utter death threat

Disposition:

- Court appearance on October 14th
- Guilty pleas to Assault, Utter death threat
- Suspended sentence; 12 months' Probation
- No contact/communication with named party
- Do not attend any place the named party lives, works or goes to school
- Do not attend within 25m of the named party
- Do not attend the named locations
- Perform 10 hours of community service
- No weapons
- All remaining charges were withdrawn



Charges: Take m/v without consent, Drive m/v – no licence HTA

Disposition:

- Court appearance on October 15th
- Guilty plea to Take m/v without consent
- Conditional discharge for 12 months
- Not to be in a m/v without the consent of the owner



Charges: Obstruct police, Theft under \$5000

Disposition:

- Court appearance on October 15th
- Guilty pleas to both charges
- Conditional discharge for 12 months
- Report to Probation
- Do not attend named location
- 30 hours community service
- Has live matters processing through Diversion

Charges: STPS - Assault with a weapon, Utter threats - BH
OPP - FTC undertaking

Disposition:

- Court appearance on October 15th
- Guilty plea to FTC undertaking
- Conditional discharge, 12 months' Probation
- No contact/communication with named party
- Do not attend any place the named party lives, works, attends school
- No weapons
- Remaining charges were withdrawn as per the resolution



Charge: Assault - BH

Disposition:

- Trial commenced on October 16th
- Was acquitted of the charge
- Entered into an 18 months' Peace Bond
- No contact/communication with the named party
- Don't attend the named party's home, work, school
- Do not possess any weapons



Charges: Theft under \$5000, Mischief under \$5000

Disposition:

- Court appearance on October 16th
- Direct Accountability Program
- Charges withdrawn

- Guilty plea to Careless drive – HTA
- \$1500 fine
