Form 11 Releases:



Charges: Theft under \$5000 x 2

Disposition:

- Court appearance on October 21st
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society as directed
- Do not attend the named locations
- Next court date is November 4th



Charges: Possess schedule I substance – trafficking x 8, FTC x 16,
Possess proceeds of crime over \$5000, Prohibited operation

Released:

- Bail hearing on October 22nd
- Released on a Form 11; Promise to pay \$250 if FTC
- Do not attend the named location
- Next court date is November 18th



Charges: **OPP** - Criminal harassment, FTC x 2
STPS - FTC

Released:

- Bail hearing on October 22nd
- Released on a Form 11; Promise to pay \$1000 if FTC
- Wear a GPS monitor and follow the program protocols
- Reside at named address
- Do not contact/communicate in any way with the named party
- Do not be within 100m of any place the named party lives, works or attends school
- Do not be within 25m of the named party
- Do not possess any weapons
- Next court date is November 4th

Charges: Theft under \$5000 x 2, Utter threats – BH x 2, FTC x 3, B&E, Food & lodging fraud

Released:

- Bail hearing on October 24th
- Released on a Form 11; Promise to pay \$1000 if FTC
- Report to the John Howard Society as directed
- Do not contact/communicate in any way with the named parties
- Don't attend the named parties home, work or school
- Don't attend the named addresses and locations
- Do not possess any weapons
- Next court date is November 10th

Charge: Theft under \$5000

Disposition:

- Court appearance on October 21st
- Direct accountability program – DAP complete
- Charge withdrawn



Charge: Mischief under \$5000

Disposition:

- Court appearance on October 21st
- Charge withdrawn by the Crown
- No public interest – NPI

Charge: FTC Probation

Disposition:

- Court appearance on October 21st
- Charge withdrawn by the Crown – NPI
- Has outstanding live matters before the court
- Next court date is October 28th for guilty pleas



Charges: Assault – Spousal, Assault with a weapon, FTC Probation

Disposition:

- Court appearance on October 21st
- Guilty plea to assault
- 30 days of PSC enhanced to 45 days jail
- 3 years' Probation: Report/Reside - until counselling complete
- No contact with the named parties
- Non-attend within 100m of any known place of residence, employment, or education of the named parties
- No weapons, DNA sample
- Remaining charges were withdrawn as per the resolution



Charges: Assault – Spousal, FTC Probation, FTC x 5

Disposition:

- Court appearance on October 21st
- Guilty pleas; Assault, FTC Probation, FTC x 3
- Suspended sentence
- 50 days jail, (33 days of PSC)
- 12 months' Probation
- No contact with the named party
- Non-attend within 100m of any known place of residence, employment, or education of the named party
- No weapons, remaining charges were withdrawn

Charges: Disqualified drive x 2, Possess cocaine, FTC Probation x 2

Disposition:

- Court appearance on October 21st
- All charges were withdrawn by the Crown – NPI
- Has outstanding OPP charges before the court



Charges: Impaired operation, Obstruct police

Disposition:

- Court appearance on October 21st
- Guilty plea to lesser charge of Careless driving
- \$1000 fine
- Criminal charges were withdrawn



Charges: FTC Probation x 10, Theft under x 2, Mischief under x 3, FTC x 5, Possess property under \$5000, Possess B&E tools, Smoke tobacco in prohibited place x 2, Improper bicycle brake, lighting, No horn - bicycle

Disposition:

- Court appearance on October 21st
- Guilty pleas; Mischief under, Theft under, FTC, & FTC Probation
- 60 days of PSC enhanced to 90 days
- 12 months' Probation
- Not to be within 5m of named address
- All remaining charges were withdrawn

Charges: Mischief under \$5000 x 4, FTC x 2

Disposition:

- Court appearance on October 21st
- Guilty pleas to Mischief under \$5000 x 2
- Suspended sentence
- 18 months' Probation
- Remain 50m away from the named addresses
- Remaining charges were withdrawn



Charges: Assault with a weapon, B&E, FTC

Disposition:

- Court appearance on October 22nd
- All charges were withdrawn by the Crown



Charges: Criminal harassment, Utter threat – BH, FTC x 5, FTC Probation

Disposition:

- Court appearance on October 22nd
- Guilty pleas; FTC Probation x 2, FTC
- 98 days jail PSC enhanced to 146 days
- 3 years' Probation
- Do not contact/communicate in any way with the named parties
- Don't be within 25m of the named parties
- Do not be within 100m of their home, work, or school
- Do not possess any weapons
- Remained in custody on outstanding charges
