### Form 11 Releases:



**Charges:** B&E x 2, Theft under, FTC, Breach Probation, Possess Opioid **Released:** 

- Bail hearing on October 4<sup>th</sup>
- Released on a Form 11
- Do not contact/communicate in any way with named party
- Don't attend their home, work, or school
- Next court date is November 4<sup>th</sup>



**Charges:** Assault – Spousal, Assault – Choke, Assault - BH **Released:** 

- Bail hearing on October 7<sup>th</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- Reside at named address
- Do not contact/communicate in any way with named parties
- Don't be within 25m of them
- Do not attend within 100m of their home, work, school
- Do not possess any weapons
- Do not possess or consume any intoxicating substances



**Charges:** Assault police, Resist police, Obstruct police **Released:** 

- Uncontested bail hearing on October 7<sup>th</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- Notify STPS OIC within 24 hours of any address change
- Present themselves and/or the named party to police when they attend
- Do not possess any weapons except for eating and employment
- Next court date is October 28<sup>th</sup>





Charges: Sexual assault, Sexual assault on a person under 18,

Sexual interference

#### Released:

- Bail hearing on October 7<sup>th</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- Reside at named address
- Remain in residence daily b/w 9pm 6:30am
- Do not contact/communicate in any way with the named parties
- Do not be within 25m of them
- Do not attend any place they live, work, attend school
- Next court date is November 4<sup>th</sup>



**Charges:** Assault, Cause a disturbance, Carry a weapon dangerous to public **Released:** 

- Bail hearing on October 8<sup>th</sup>
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society
- Do not contact/communicate in any way with named party
- Do not attend within 100m of any place they live, work, attend school
- Do not attend the named location
- Do not possess any weapons
- Next court date is October 28<sup>th</sup>



Charges: Theft under \$5000, FTC Probation x 2, Assault with a weapon, Carry a weapon, FTC Recognizance, Possess CDSA x 3

#### Released:

- Bail hearing on October 9th
- Released on a Form 11; Promise to pay \$500 if FTC
- Report to the John Howard Society
- Do not contact/communicate in any way with the named party
- Don't attend their home, work, or school
- Don't be within 25m of them
- Do not attend the named location
- Do not possess any weapons
- Next court date is October 20<sup>th</sup>





Charges: FTC release order x 2

#### Released:

- Bail hearing on October 9<sup>th</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- Form 11 release order from Woodstock and subject to GPS monitoring
- Do not contact/communicate in any way with the named parties
- Don't be within 50m of them; Don't attend their home, work, school
- Do not possess any weapons
- Do not use or access social media
- Next court date is November 4<sup>th</sup>



**Charges:** Agreement to commit a sexual offence against a person under 16, Sexual assault, Sexual interference, Luring a person under 16

#### Released:

- Bail hearing on October 10<sup>th</sup>
- Released on a Form 11; Promise to pay \$1000 if FTC
- Reside at named address
- No contact/communication in any way with the named party
- Do not be within 100m of their home, work, school
- Curfew between 10pm & 7am
- Do not attend Elgin County except for court
- Do not have contact with anyone under the age of 16
- Do not possess any weapons
- Do not attend any public park, swimming area, daycare, school ground, playground, community centre, public transit, arena where persons under 16 are present or reasonably be expected
- Next court date is November 4<sup>th</sup>



### **Dispositions:**



Charge: Assault with a weapon Disposition:

- Trial commenced on October 6<sup>th</sup>
- During the trial, entered into a 12 months' CLPB
- Do not contact/communicate in any way with named party
- Do not attend within 50m of the named address
- Do not attend where they live, work, attend school
- Do not possess any weapons
- Charge withdrawn



Charge: Sexual assault Disposition:

- Court appearance on October 6<sup>th</sup>
- Entered into a 3 years' CLPB
- No contact with named party
- Do not attend within 75m of any known place of residence, employment, or education of the named party
- Do not be within 25m of the person
- Do not possess any weapons, except as needed in the course of lawful employment
- Charge withdrawn as per the CLPB



Charge: Assault with a weapon Disposition:

- Court appearance on October 7<sup>th</sup>
- Charge withdrawn by the Crown No Public Interest (NPI)





Charges: OPP - Theft under \$5000

STPS - Obstruct police, Resist arrest, FTC, FTC Probation

#### Disposition:

- Court appearance on October 7<sup>th</sup>
- Is reporting to Probation
- All charges were withdrawn



**Charges:** FTC release order x 2 **Disposition:** 

- Court appearance on October 7<sup>th</sup>
- Charges withdrawn as part of global resolution with London matters



**Charges:** Theft under \$5000 x 6, FTC Probation x 4, FTC release x 2 **Disposition:** 

- Court appearance on October 7<sup>th</sup>
- Guilty pleas; Theft under \$5000 x 2, FTC Probation
- 41 days of PSC enhanced to 62 days; 1 day deemed served
- 15 months' Probation
- Do not attend the named locations
- All remaining charges were withdrawn



Charges: Theft under \$5000 x 8

Disposition:

- Court appearance on October 7<sup>th</sup>
- Guilty plea to Theft under \$5000 x 1
- 80 days PSC enhanced to 120 days; 1 day deemed served
- 12 months' Probation usual conditions
- Non-attend within 100m of the named locations



All remaining charges were withdrawn



**Charges:** Possess property over \$5000, Impaired operation & Over 80 BAC, Unauthorized possession of a weapon

### Disposition:

- Court appearance on October 7<sup>th</sup>
- Guilty plea to Over 80 BAC
- \$2000 fine, 12 months' driving Prohibition
- All remaining charges were withdrawn



Charge: Theft over \$5000

### **Disposition:**

- Court appearance on October 7<sup>th</sup>
- Charge withdrawn by the Crown



Charge: Unlawfully in a dwelling Disposition:

- Court appearance on October 7<sup>th</sup>
- Charge withdrawn by the Crown NPI



**Charges:** FTC Recognizance x 2, FTC release order **Disposition:** 

- Court appearance on October 7<sup>th</sup>
- Charges withdrawn by the Crown
- Has outstanding charges before the court
- Next court date is October 21<sup>st</sup>





**Charges:** Impaired operation & Over 80 BAC, Prohibited drive x 3, Suspend drive - HTA

#### Disposition:

- Court appearance on October 7<sup>th</sup>
- Guilty plea to Over 80 BAC
- Intermittent jail sentence 90 days
- Served intermittently from Saturday to early Monday
- Probation while serving the jail sentence
- · All remaining charges were withdrawn



**Charges:** Sexual assault on a person under 16, Sexual interference, Invitation to sexual touching – person under 16

#### **Disposition:**

- Court appearance on October 8<sup>th</sup> for Judgment
- Acquitted of all charges



Charge: Theft under \$5000

### **Disposition:**

- Bail hearing on October 8<sup>th</sup>
- Theft under charge withdrawn by the Crown NPI
- Remanded on numerous outstanding charges
- Next court date is October 15<sup>th</sup>



**Charge:** Sexual assault on a person under 16 **Disposition:** 

- Trial commenced October 8<sup>th</sup>
- Entered into a 24 months' CLPB
- No contact/communication in any way with named party
- Don't attend their home, work or school
