- Next court date is October 21st

STPS - Assault, Possess sched I substance – Fentanyl, FTC Probation

Released:

- Bail hearing on September 29th
- Released on a Form 11; Promise to pay \$1000 if FTC
- Wear a GPS monitor and follow the program protocols
- Reside at named address
- Do not contact/communicate in any way with the named parties
- Do not be within 25m of them and don't attend their home, work, school
- Next court date is October 20th



Charges: APS - Possess property by crime under \$5000

OPP - Possess property by crime under \$5000

STPS - Theft under \$5000, Breach Probation x 3

Released:

- Bail hearing on September 29th
- Released on a Form 11
- Do not contact/communicate direct/indirect with the named party
- Do not attend the named addresses
- Next court date is October 28th

Charges: Sexual assault, Utter threats - BH, FTC

Released:

- Bail hearing on October 2nd
- Released on a Form 11; Promise to pay \$1000 if FTC
- Wear a GPS monitor and follow the program protocols
- Reside at named address, remain in residence 24/7
- Do not contact/communicate in any way with the named party
- Do not be within 25m of them & don't attend their home, work, school
- Do not possess any weapons
- Next court date is October 17th



Charges: Unlawfully in a dwelling, FTC Probation x 8

Released:

- Bail hearing on October 2nd
- Released on a Form 11; Promise to pay \$500 if FTC
- Wear a GPS monitor and follow the program protocols
- Notify STPS within 24 hours of any address change
- Do not contact/communicate in any way with the named party
- Don't attend their home, work, school
- Don't be within 25m of them
- Do not attend within 50m the named address
- Do not possess any weapons
- Next court date is October 21st

Charges: Sexual assault, Sexual interference

Disposition:

- Court appearance on October 1st
- Guilty plea to lesser offence of Assault from the Sexual assault charge
- YCJA - Conditional discharge - 12 months' conditions
- No contact with the named party
- Don't attend their home, work, school
- No weapons
- Remaining charge was withdrawn as per plea arrangement



Charges: Assault, Sexual assault, Forcible confinement

Disposition:

- Court appearance on October 1st
- Guilty plea to Assault
- YCJA - Conditional discharge - 12 months' conditions
- No contact with the named party
- Non-attendance within 25m of any known place of residence, employment or education of the named party
- Non-attendance within 5m of the named location
- No weapons
- Remaining charges were withdrawn as per plea arrangement
- Has outstanding charges, next court date October 15th

Charges: Sexual assault x 2

Disposition:

- Court appearance on October 1st
- Guilty plea to lesser offence of Assault
- YCJA - Conditional discharge – 12 months' conditions
- No contact with the named parties
- Non-attendance at any known place of residence, employment or education of the named parties
- No weapons
- Remaining charge was withdrawn as per the plea



Charges: Assault with a weapon, Assault x 2, Forcible confinement

Disposition:

- Elgin Therapeutic Court – appearance on October 1st
- Guilty plea to lesser offence of assault from assault with a weapon
- Conditional discharge with 12 months' Probation
- No contact with the named parties
- Non-attendance at any known place of residence, employment or education of the named parties
- All remaining charges were withdrawn as per ETC
- DNA & No weapons
